Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Benefits Plus Trust Fund Welfare Benefit Plan (Plan 501), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the benefit obligations and net assets available for benefits of Benefits Plus Trust Fund Welfare Benefit Plan (Plan 501) as of March 31, 2025 and 2024, and the changes in benefit obligations and net assets available for benefits for the year ended March 31, 2025, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Benefits Plus Trust Fund Welfare Benefit Plan (Plan 501) and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Benefits Plus Trust Fund Welfare Benefit Plan (Plan 501)'s ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Benefits Plus Trust Fund Welfare Benefit Plan (Plan 501)'s internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Benefits Plus Trust Fund Welfare Benefit Plan (Plan 501)'s ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of Schedule of Assets (Held at End of Year) as of March 31, 2025, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1 – Description of the Plan 501

The following brief description of the Benefits Plus Trust Fund Welfare Benefit Plan (Plan 501 or the Plan) is provided for general information purposes only. Reference should be made to the Summary Plan Description for a more complete description of Plan 501's provisions.

General – The Plan provides group medical, dental, vision, chiropractic, and life insurance benefits through a multiple-employer trust fund. All benefits are fully insured. The Plan is maintained in compliance with the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions – Participating employers pay contributions for the participating employees covered under the Plan. Contribution rates are determined based upon amounts needed to pay insurance premiums and Plan expenses. Contributions are recorded when the service is rendered.

Plan termination – Although they have not expressed any intent to do so, the Trustees have the right to terminate the Plan or to modify the Plan at any time. The Plan and participating employers do not promise the continuation of any benefits, nor do they promise any benefits at or during retirement. In the event the Plan terminates, the Trustees shall wind up the remaining affairs of the Plan, and any and all monies remaining in the Plan, after the payment of administrative and other expenses, shall be allocated so as to continue the payment of benefits to participating employees and their beneficiaries under the employee welfare benefit plan in accordance with the Trust Agreement. No portion of the remaining assets shall be paid to or be recoverable by any participating employer.

Eligibility – Field construction trade employees receive month-to-month coverage and are eligible for benefits the first day of the second month following a month in which they worked at least 130 hours. Coverage continues on a month-to-month basis as long as the participating employee is credited with at least 130 hours each month. If an employee works more than 130 hours in a month, the excess contribution is held in a dollar bank reserve, up to a maximum dollar amount equivalent to a total of 390 hours. This dollar bank reserve will be available for months in which the employee works less than 130 hours. In addition, employers may, on a nondiscriminatory and nonselective basis, pay additional premiums to achieve eligibility for employees. Coverage ends at the end of a month in which the hours worked by a participant, plus reserve account hours and additional employer contributions, are insufficient to cover the participant for eligibility the following month.

Administrative, supervisory, and office employees for whom contributions are paid on a monthly flat-rate basis, and their dependents for whom coverage is elected and paid, become eligible on the first day of the month following the employee's first full month of full-time employment, and remain eligible until the last day of the month in which their employment is terminated, for any reason, provided they work at least 130 hours per month.

Salaried management employees as defined by the participating employer of Plan 501 are eligible for benefits on the date of hire.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Cash and cash equivalents – For the purposes of financial statement presentation, the Plan considers all short-term investments with an original maturity of three months or less to be cash equivalents.

Receivables from employers – Receivables represent amounts due from participating employers for hours worked in March and are presented in the statements of benefit obligations and net assets available for benefits, net of the allowance for doubtful accounts. There is no collateral related to these receivables. An allowance for credit losses is estimated based on the Plan's historical losses, the existing economic conditions, and the financial stability of its employers. Receivables are written off in the year deemed uncollectible. The Plan's administrator has determined that an allowance for credit losses was not necessary as of March 31, 2025 and 2024.

Due to Benefits Plan Trust Fund (other plans) – The balance represents amounts due from Plan 501 to other plans referred to as the Benefits Plus Trust Fund Welfare Benefit Plan (Plan 502, Plan 503, Plan 505, Plan 508, and Plan 509). All these plans hold their cash and cash equivalents in the same bank account, and the balance represents the cash held and reported by Plan 501 that is related to and due to these other plans. The assets and liabilities of the plans are recorded separately.

Accumulated eligibility credits – As described in Note 1, certain hourly employees meeting eligibility requirements are entitled to coverage for a maximum of three months. Estimated liability for accumulated eligibility credits is calculated as accumulated contributions made by employers on behalf of employees, less accumulated premiums for benefits coverage. As of March 31, 2025 and 2024, the estimated liability for accumulated eligibility credits was \$48,541 and \$51,587, respectively.

Concentrations – For the year ended March 31, 2025, approximately 73% of employer contributions were concentrated with two employers. In December 2024, the Plan's largest participating employer withdrew from the plan and is no longer making contributions. As of March 31, 2025, there were no concentrations in receivables. As of March 31, 2024, 85% of receivables from employers were concentrated with one employer, respectively.

Cash and cash equivalents at times may exceed federally insured limits. Management considers the risk of loss to be minimal due to the creditworthiness of the financial institutions.

Note 3 – Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology that include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. All investments in the plan are registered investment companies.

Note 4 – Income Taxes

The Plan is a taxable plan. Income taxes are provided for the tax effects of transactions reported in the financial statements and consist of taxes currently due, plus deferred taxes. The Plan's tax returns are prepared on an accrual basis. Accordingly, income and deductions are recognized in the same period for tax reporting purposes and for financial statement purposes.

The Plan follows Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 740-10 relating to accounting for uncertain tax positions. ASC 740-10 prescribes a recognition threshold and measurement process for accounting for uncertain tax positions and also provides guidance on various related matters such as derecognition, interest, penalties, and disclosures required. The Plan does not have any entity-level uncertain tax positions. The Plan files income tax returns in the United States federal jurisdiction and various state jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan did not have a liability on March 31, 2024.

The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of benefit obligations and net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of benefit obligations and net assets available for benefits but arose after the statements of benefit obligations and net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through December 15, 2025, which is the date the financial statements were available for issuance.
