RE: Reasonable Cause Request – Form 5500-SF Filing Requirement

To Whom It May Concern,

I am writing in response to the IRS notice regarding the filing of Form 5500-SF for my retirement plan. I respectfully request penalty relief based on reasonable cause.

From 2017 through November 2022, my 401(k) plan was administered and managed by Paychex. During that period, Paychex handled payroll, plan administration, and associated compliance matters. In November 2022, I changed my business structure and transitioned from having employees to operating solely as an independent contractor. As a result, I terminated my payroll and plan administration services with Paychex.

At the time of this transition, I relied in good faith on Paychex to advise me regarding all required compliance steps related to the closure or continuation of the plan. During the termination discussions and in the closing documentation provided, I was not informed that Form 5500-SF filings would still be required for any years in which the plan remained active, nor was I advised that a final Form 5500-SF would be required to formally close the plan.

I exercised ordinary business care and prudence by engaging a professional third-party administrator and reasonably relied on their guidance regarding compliance obligations. The failure to file the required Form 5500-SF was unintentional and resulted from my reasonable reliance on that third party, not from neglect or willful disregard of filing requirements.

Upon becoming aware of the filing requirement, I took steps to understand and address the issue promptly. I am committed to bringing the plan into compliance and filing any required forms as directed.

Given these circumstances, I respectfully request that any penalties associated with the Form 5500-SF filing requirement be abated due to reasonable cause.
