Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of CEEN 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution, Principal Life Insurance Company, as of and for the years ended April 30, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - Description of Plan:

The following description of CEEN 401(k) Plan (the Plan) provides only general information. For a more complete description of the Plan's provisions, participants should refer to the Plan document and *Summary Plan Description*, which are available from the Plan Administrator.

General:

The Plan is a defined contribution plan sponsored by Colorado Early Education Network (the Organization) covering all employees who are age twenty-one or older, regardless of how many hours are worked each year. Employees must be employed on the last day of the Plan year and have worked 1,000 or more hours during the year to be eligible for discretionary employer profit sharing contributions. Employees become eligible immediately on the date they satisfy the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Principal Life Insurance Company serves as the Plan's recordkeeper and as the Plan custodian. Kayla Farmer serves as Plan trustee.

The Plan began April 15, 2013, and was restated effective February 17, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions:

Each year, participants may contribute up to the maximum annual amount established by the IRS of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (which are not subject to employer matching contributions). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

The Plan's provisions state that Colorado Early Education Network will make a matching contribution determined by the Organization, 3% in FY24 and FY25. In addition, Colorado Early Education Network may annually determine whether to make a discretionary contribution, allocated based on annual pay to all eligible participants.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - Description of Plan - Continued:

Participant Accounts:

Each participant's account is credited with the participant's contribution, the Organization's contribution and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Account Options:

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily. The Plan accounts of participants not electing to direct the investment of their Plan accounts will be invested with the default investment alternatives established under the Plan.

Vesting:

Participants are immediately vested in their voluntary contributions and rollover contributions, plus actual earnings thereon.

Vesting in Colorado Early Education Network's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service and is determined as follows:

Years of Service	Vested Percentage
1	20%
2	40%
3	60%
4	80%
5 or more	100%

Under the Plan, a year of service is earned by working at least 1,000 hours during a plan year. A participant is fully vested after five years of continuous service. Participants are 100% vested if they are employed on or after their normal retirement age or if they die or become disabled.

The nonvested balance is forfeited upon termination of service. Forfeitures are used to pay plan expenses, reduce Organization contributions, or can be allocated among all participants.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - Description of Plan - Continued:

Forfeited Accounts:

At April 30, 2025 and 2024, forfeited nonvested accounts totaled \$2,985 and \$2,958, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. In the plan years ended April 30, 2025 and 2024, plan expenses or employer contributions of \$22,182 and \$17,416, respectively, were paid from forfeited nonvested accounts.

Payment of Benefits:

Upon severance from employment with the employer, disability, or death an employee or their beneficiary may elect to receive either a lump-sum amount equal to the vested value of his or her account, or a joint and survivor annuity. In-service distributions are also available to participants who have reached age 59½. Hardship distributions of vested amounts may be made in the event of hardship, defined as an immediate and heavy financial need where the participant lacks other available resources.

NOTE 2 - Summary of Significant Accounting Policies:

Basis of Accounting:

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States.

Valuation of Investments and Income Recognition:

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

NOTE 2 - Summary of Significant Accounting Policies - Continued:

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Transfers Between Fair Value Hierarchy Levels:

Transfers in and out of Level 1 (quoted market prices), Level 2 (other significant observable inputs) and Level 3 (significant unobservable inputs) are recognized on the period beginning date.

Subsequent Events:

Subsequent events have been evaluated through the date the financial statements were available to be issued, which is the date of the Independent Auditors' Report.

NOTE 3 – Certification of the Trustee's Agent:

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at April 30, 2025 and 2024, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the years ended April 30, 2025 and 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Principal (the recordkeeper and custodian of the plan).

NOTE 4 – Disclosures About Fair Value of Plan Assets and Liabilities:

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs.

There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level 1: Quoted market prices in active markets for identical assets or liabilities.

Level 2: Observable market-based inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for plan benefits, as well as the general classification of such asset pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended April 30, 2025. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Pooled Separate Accounts:

The Pooled Separate Accounts are reported in the financial statements at fair value. The plan administrator believes the best estimate of fair value for the Pooled Separate Accounts is contract value. Participants may withdraw Pooled Separate Accounts assets at contract value without restriction, and Pooled Separate Accounts assets are marked-to-market on a daily basis primarily using the net asset value per share based on quoted market prices of underlying investments.

Stable Value Collective Trust Fund:

A Stable value fund that is composed primary of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the report net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTES TO FINANCIAL STATEMENTS

NOTE 5– Investment Contract with Principal Life Insurance Company:

The Plan is funded with a Group Annuity Contract. Contributions are made to the contract on behalf of plan participants and the accumulated contributions are then invested in investment options selected by the participants or Plan trustee, as applicable. The contract offers various Pooled Separate Accounts from a variety of investment managers plus a General Account.

One of the Plan's fund options is the Principal Stable Value fund which invests in several fully benefit-responsive investment contracts. As of April 30, 2025 and 2024, all of the investments in the fund meet the fully benefit responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing plan investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

As the investment contract with Principal is fully benefit-responsive, contract value is the relevant measure. There are no realized or unrealized gains or losses related to the investment contracts included in the net increase in net assets available for benefits.

NOTE 6– Party-in-Interest Transactions:

Certain Plan investments are managed by Principal Life Insurance Company. Principal is the recordkeeper and custodian for the Plan, and therefore, these transactions qualify as party in interest transactions.

Principal provides certain administrative services to the Plan pursuant to a Service and Expense Agreement between the Company and Principal. Principal receives revenue from mutual fund service providers for services Principal provides to the funds. This revenue is used to offset certain amounts owed to Principal for its administrative services to the Plan.

NOTE 7 – Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

NOTE 8 – Tax Status:

Effective June 30, 2020, the plan adopted a prototype non-standardized basic savings plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 – Reconciliation with Form 5500:

Net assets available for benefits per the financial statements differs from the Form 5500 as the Form 5500 is prepared on the cash basis and does not include the employer contribution receivable. NOTE 10 – Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 11 – SECURE Act:

During 2024, the Plan implemented the SECURE 2.0 Act provisions, as required by law. Key takeaways are these:

- Long-Term Part-time (LTPT) employees will now be eligible to make elective deferrals to the Plan.
 - The minimum age for required minimum distributions (RMDs) is now 73, for those turning 72 on or after January 1, 2023.
 - Update of the dollar threshold for small amount force-out distributions, from \$5,000 to \$7,000.
