As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 30, 2025, December 31, 2024 and 2023 and for the period ended April 30, 2025 and the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Smithfoods, Inc. 401(k) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter

As discussed in Note 1 to the financial statements, the Trustees of Smithfoods, Inc. 401(k) Savings Plan adopted a resolution to terminate the plan effective December 31, 2024. In accordance with accounting principles generally accepted in the United States of America, the plan has changed its basis of accounting from the ongoing basis used in 2023 financial statements to the liquidation basis used in presenting the 2024 and 2025 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 DESCRIPTION OF PLAN

The following description of Smithfoods, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan originally effective January 1, 2011. The Plan was sponsored by SmithFoods Inc. (SFI) and participating employers, SmithFoods Orrville Inc. (SFO), SmithFoods Richmond Inc. (SFR) and SmithFoods Pacific Inc. (SFP) (collectively, the Company). The Plan was subject to ERISA. The Board of Trustees was responsible for the oversight of the Plan. The Board of Trustees also determine the appropriateness of the Plan's investment offerings, and monitor investment performance.

Termination of the Plan

Effective October 1, 2024, Prairie Farms completed the acquisition of SmithFoods, Inc., the plan sponsor.

The Trustees adopted a resolution to terminate the Plan effective December 31, 2024, subject to provisions of ERISA. The participants remained 100% vested in their Company contributions. Plan management intended to distribute, and did distribute, all assets of the plan by April 30, 2025.

Eligibility

Certain union and nonunion employees of the Company were eligible to participate in the deferral, Company match, and safe harbor match components of the Plan, as defined, upon completing six months of service and reaching 21 years of age. Nonunion participants were eligible for the profit sharing contribution if they met the eligibility requirements above, complete 1,000 hours of service during the Plan year and were employed on the last day of the Plan year.

Effective January 1, 2024, the Plan was amended to change the eligibility requirement age from 21 to 18. The amendment removed the six-month service requirement as well. Additionally, the effective date of participation was changed from the first day of the month coinciding with or next following date requirements met to simply date requirements met.

Contributions

The Plan include a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants were permitted to elect to have a percentage, up to 90%, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

Contributions (Continued)

The Company made matching contributions equal to the following:

SFO Teamsters Union – 25% of the salary deferral up to 8% of the employee's compensation provided that other criteria defined in the Plan document were met for union participants.

Union employees hired after July 1, 2016, or those hired prior that opted out of the defined benefit plan offered by the Plan Sponsor, received a match of 100% of the salary deferral up to 4% of the employee's compensation plus 50% of the salary deferrals exceeding 4%, but not exceeding 6% of the employee's compensation.

Effective June 2024, the Plan was amended to implement an enhanced matching contribution structure for eligible union participants:

- A 200% match on salary deferrals up to 1% of the employee's compensation.
- A 100% match on salary deferrals exceeding 1% but not exceeding 5.5% of compensation.
- An additional 50% match on salary deferrals exceeding 5.5% but not exceeding 7.5% of compensation,

These contributions were subject to the fulfillment of additional criteria as outlined in the Plan document.

The Company made a safe harbor matching contribution to nonunion employees equal to 100% of the salary deferral up to 3% of the employee's compensation plus 50% of the salary deferrals exceeding 3% but not exceeding 5% of the employee's compensation.

The Plan also provide for a discretionary match and profit sharing contribution to be made by the Company for nonunion employees. There were no Company discretionary match or profit sharing contributions for the period ended April 30, 2025 and the years ended December 31, 2024 and 2023.

Participants might also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's matching contributions, an allocation of the Company's profit sharing contribution, if any, and an allocation of Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided by the participant's vested account.

Vesting

Participants were immediately vested in their contributions and the Company's safe harbor matching contribution, plus actual earnings thereon, upon entry into the Plan. Vesting in the Company matching and profit sharing contribution portion of their accounts, plus actual earnings thereon, was based on years of credited service. A participant was 100% vested in Company matching contributions after five years of credited service. A participant is 100% vested in the profit sharing contribution after three years of credited service. Notwithstanding the above, a participant was fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants might borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at a rate of 1% above prime at the time the loan was taken. Principal and interest was paid ratably through payroll deductions.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant might elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allowed for in-service distributions if a participant reaches age 59½, hardship distributions subject to Plan provisions, and qualified birth and adoption distributions. If a participant terminated employment and the participant's account balance would not exceed \$5,000, the Plan administrator would authorize the benefit payment in the form of a lump sum without the participant's consent. If the balance of the terminated participant's account was between \$1,000 and \$5,000, the Plan Sponsor might authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeited Accounts

Forfeited nonvested accounts were used to reduce future Company contributions. Forfeitures might also be used to pay reasonable Plan expenses as provided in the Plan document. Forfeited nonvested accounts as of April 30, 2025, December 31, 2024 and 2023 totaled \$-0-, \$35,442 and \$31,338, respectively. There were \$-0-, \$17,234 and \$3,494 of forfeitures used to reduce Company contributions for the period ended April 30, 2025 and years ended December 31, 2024 and 2023, respectively. There were \$-0-, \$6,421 and \$-0- of forfeitures used to pay administrative expenses for the period ended April 30, 2025 and years ended December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As discussed in Note 1 to the financial statements, the Trustees adopted a resolution to terminate the Plan effective December 31, 2024, and determined liquidation was imminent. As a result, the Plan used the liquidation basis in presenting the financial statements for the period ended April 30, 2025 and the year ended December 31, 2024.

Under the liquidation basis of accounting, assets were stated at their estimated net realized cash value expected to be collected in settling or disposing of assets during the liquidation process and liabilities were stated at their anticipated settlement amounts. Investments were stated at fair value which approximates the amount the Plan expects to collect.

The financial statements of the Plan for the period ended December 31, 2023, were prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determined the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of December 31, 2024 and 2023. Delinquent notes receivable were recorded as distributions on the basis of the terms of the Plan document.

Benefit Payments

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments were charged directly to the participant's account and were included in administrative expense. Investment related expenses were included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through December 10, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and December 31 2023, and net appreciation in fair value of the investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and net appreciation in fair value of the investments, interest and dividends, and interest income on notes receivable from participants for the period ended April 30, 2025, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by ADP Retirement Service, LLC., the trustee of the Plan.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Fund – Valued at the NAV of shares held by the plan at year-end adjusted for any cash held for liquidity purposes and any fees imposed by the fund. The net asset value per unit is determined by dividing the net assets by the number of units outstanding on the day of valuation. Units are issued and redeemed daily, at the daily net asset value. Also, the net investment income (loss) and realized and unrealized gains (loss) on investments are reinvested.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of the investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TAX STATUS

The Plan were placing reliance on an opinion letter dated October 6, 2020, received from the IRS on the prototype plan indicating that the Plan was qualified under Section 401 of the IRC, and was therefore not subject to tax under current income tax law. The prototype plan had been amended since receiving the opinion letter. However, the Plan administrator believed that the Plan was designed, and was currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believed that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.
