

NOTES TO FINANCIAL STATEMENTS

May 31, 2025 and 2024

1. DESCRIPTION OF PLAN

The following description of Meat and Allied Food Workers Severance Pay Trust Fund No. 2 (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established to provide severance pay benefits to regular full-time employees under certain collective bargaining agreements of Kenosha Beef International, Ltd. and Birchwood Transport (the Employers). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Regular full-time employees eligible for coverage under the terms of the collective bargaining agreements working more than 20 hours per week at the time of any plant closing by any employer member of the trust are eligible for benefits. There is a one-year waiting period and, thereafter, each period in excess of six months is considered an additional year of service.

Benefits

The Plan provides severance pay to eligible participants, as defined in the plan document, in the event of a plant closing in the amount of \$40 per year of service, with a maximum allowance of 15 years of service, providing a maximum benefit of \$600.

Funding Policy

The Trustees of the Plan did not require any contribution to the fund from employers during the years ended May 31, 2025 and 2024. Additionally, based on the number of eligible employees as of May 31, 2025 and consideration of providing severance benefits as stated above in accordance with the Trustee resolution and agreement, the Plan holds sufficient funds to cover any liability that would exist if all operating employers ceased operations.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Cash

Cash is defined as currency on hand, in demand deposits.

Use of Estimates

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America (US GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits and Benefit Obligations

Benefit payments to participants are recorded when paid. The Plan has no benefit obligation unless a plant closing occurs. There were no plant closings that occurred during the years ended May 31, 2025 or 2024.

Administrative Expenses

Administrative expenses of the Plan include plan audit fees. The Employers provide accounting and other administration services to the Plan at no charge.

Recent Accounting and Regulatory Pronouncements

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor (DOL). The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended May 31, 2025 and 2024. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,
- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at May 31, 2025 and 2024.

Money market account: Valued at the closing price reported by the bank from an actively traded exchange.

3. FAIR VALUE MEASUREMENTS (Continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Trustees have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be distributed in such a manner as the Trustees may determine.

5. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Trustees by a letter dated September 1987, that the Trust and the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

5. TAX STATUS (Continued)

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Associated Bank, the custodian; therefore, these transactions qualify as party-in-interest. Certain employees of the Employers provide administrative services to the Plan for which no fees are charged.

7. RISKS AND UNCERTAINTIES

The Plan invests in a money market account. Money market accounts may be exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain money market accounts, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statements of net assets available for benefits.

8. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through December 16, 2025, which was the date that these financial statements were available for issuance and determined that there were no significant nonrecognized subsequent events through that date.
