U.S. Department of Labor:

The filing of Form 5500 for 2024 is late due to a misunderstanding between StatOS Inc. and Paychex Inc. on who would be filing Form 5500 for Stat OS for 2024. We apologize for this egregious error as it was not our intention to file late.

StatOS received an email notification from Paychex on April 17, 2025 stating that Paychex would be filing our Form 5500. StatOS understood this to be true as Paychex had filed Form 5500 for 2023 without issue. On September 10, 2025 StatOS received an email notification from Paychex stating that an extension had been filed for Form 5500. This triggered us to have our final distributions paid out. By November 2025 our final distributions were paid out to our former employees, and learned that Form 5500 for 2024 was not filed by Paychex, and that we needed to file manually. StatOS established an EFAST account to file, notified our accountant, and contacted Paychex to determine what information and schedules had been previously filed. After many delays connecting to the right person at Paychex, we gained access to the 2023 Form 5500 filing. After reviewing the previous filing, we started a 2024 filing. This filing has now been reviewed by our accountant and is ready for submission.
