Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audit of the financial statements of the Bravo Concrete Construction Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Bravo Concrete Construction Services, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Bravo Concrete Construction Services, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more detailed information of the Plan’s provisions.

General

The Plan is a qualified employer profit sharing non standardized plan, effective January 1, 2010, covering substantially all eligible employees of Bravo Concrete Construction Services, Inc. (the “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

According to the Plan, participants direct the investment of their accounts into various investment options offered by the Plan. Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Additionally, participants are 100% vested in their account and full benefits are available upon retirement at age sixty-five, early retirement, death, total disability, or in the event of complete discontinuance of contributions or termination of the Plan.

The Plan provides that forfeitures, if any, shall be used to reduce the Plan's ordinary and necessary administrative expenses and/or employer contributions. Expenses and employer contributions in excess of the forfeitures are generally paid by the Plan Sponsor.

Eligibility

Employees are eligible to participate in the Plan once they have completed 1 year of service or 1,000 hours and over the age of 21. Employees meeting the eligibility requirements can enter the Plan on the first day of the next payroll cycle coinciding with or next following the date eligibility requirements are met.

Employee Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. In addition, participants may elect to make after-tax contributions to the Plan of up to 100% of eligible compensation. Participants who are age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Elective contributions in any year may not exceed the dollar limit for the year set by the Internal Revenue Service.

Employer Contributions

For each Plan year, the employer contributes to the Plan on behalf of each eligible participant a Safe Harbor Non-Elective Contribution equal to 100% of the participant's elective deferral not less than 3% of such participant's compensation. For the year ended December 31, 2024, the Plan Sponsor made safe-harbor contributions of \$48,866.

Additionally, for each Plan year, the employer may contribute to the Plan on behalf of each eligible participant a discretionary profit sharing contribution. For the year ended December 31, 2024, the Plan Sponsor made discretionary profit sharing contributions of \$141,956.

Prevailing Wage Contributions

Certain participating employers perform services under the Davis-Bacon Act (DBA) and related prevailing wage laws. These laws require that contractors on federally funded construction projects pay their laborers and mechanics the local prevailing wage, which includes both a cash wage and an hourly credit for fringe benefits. As permitted under the law, the Company uses its contributions to this 401(k) plan to satisfy a portion of its prevailing wage fringe benefit obligations for employees performing covered work.

The Company determines its Prevailing Wage contributions based on the hourly fringe benefit rate specified in the applicable wage determination. For employees performing Davis-Bacon work, the Company may make additional contributions on their behalf to meet the prevailing wage fringe benefit requirement. These contributions are in addition to any standard company contributions (e.g., safe-harbor, matching or profit sharing) and are allocated based on hours worked on covered projects.

Contributions made for Davis-Bacon purposes are generally subject to special eligibility and vesting rules to ensure the Company can claim a full credit toward its prevailing wage obligation. To avoid potential "annualization" issues, Prevailing Wage contributions are immediately vested for participating employees. The special rules ensure that contributions can be fully used as a credit, regardless of whether the employee performs both Davis-Bacon and non-Davis-Bacon work. For the year ended December 31, 2024, the Plan Sponsor made prevailing wage contributions of \$638,207.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Plan Sponsor's discretionary contributions, (b) Plan Sponsor's safe-harbor contributions, and (c) Plan earnings which are charged with an allocation of certain administrative expenses. Allocations of the Plan Sponsor's contributions are based on participant contributions, as defined. Allocations of plan earnings and administrative expenses are based on participant balances or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

Vesting

Participants are immediately vested in their contributions and the Plan Sponsor’s prevailing wage contributions plus actual earnings less losses thereon. Vesting in the Plan Sponsor’s safe-harbor and discretionary profit-sharing contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of continuous service in accordance with the following schedule:

0-2 years of service	0%
2-3 years of service	20%
3-4 years of service	40%
4-5 years of service	60%
5-6 years of service	80%
6+ years of service	100%

Forfeitures

Amounts forfeited from terminating participants’ non-vested portion of their Plan Sponsor’s contributions and earnings on Plan Sponsor contributions are used to pay administrative expenses of the Plan or to reduce future employer contributions. Forfeitures available at December 31, 2024 were \$29. No administrative Plan expenses or employer contributions were paid from forfeited non-vested accounts during the year ended December 31, 2024.

Benefit Payments

On termination of service due to disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Upon death the beneficiary may elect a lump sum, or in distributions made over the life of the beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. All vested accounts not exceeding \$5,000 will be distributed in a single lump-sum payment.

In-Service Withdrawals

Hardship withdrawals, which meet a hardship purpose of immediate and heavy financial need, are permitted as provided in the plan agreement. Such amounts may be drawn from a participant’s deferral contributions only and may be subjected to certain income tax penalties. Disability withdrawals are permitted as provided in the plan agreement.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. For the year ended, December 31, 2024, interest rates on loans to participants ranged between 9.75% and 10.50%.

Administrative Expenses

The expenses necessary to administer the Plan, including, but not limited to, retaining necessary professional assistance from an attorney, an accountant, an actuary, or an investment advisor, are paid by the Plan Sponsor or through excess forfeitures. All expenses except for account maintenance fees, transaction fees, and investment fund management fees have been paid by the Plan Sponsor. Participants are charged service fees for any distribution transactions they request. Investment advisory and management fees paid by and for the Plan amounted to \$24,105 for the year ended December 31, 2024, and are included in administrative fees and investment advisory expenses on the statement of changes in net assets. Audit expenses are absorbed by the Plan Sponsor. In addition, certain investment-related expenses have been offset with net investment income and are not readily determinable.

Investment Options

Participants direct the allocation of their contributions, employer discretionary contributions, and safe-harbor contributions to any of the investment options offered by the Plan at their discretion. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis.

Basis of Presentation

The financial statements have been prepared in compliance with the Department of Labor Rules and Regulations for reporting and disclosure under ERISA.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are measured at quoted prices in an active market and have been certified complete and accurate by Ascensus LLC, the Plan's custodian (Note 4). Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Risk and Uncertainties

The Plan provides for various investment options in any combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

NOTE 3 – FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair value estimates are made at a specific point in time, based on available market information and judgments about the financial asset, including estimates of timing, amount of expected future cash flows, and the credit standing of the issuer. In some cases, the fair value estimates cannot be substantiated by comparison to independent markets. In addition, the disclosed fair values may not be realized in the immediate settlement of the financial asset. In addition, the disclosed fair values do not reflect any premium or discount that could result from offering from sale at one time an entire holding of a particular financial asset. Potential taxes and other expenses that would be incurred in an actual sale or settlement are not reflected in amounts disclosed.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's mutual funds and common collective trusts are valued at NAV which is based on the fair value of the underlying investments of the mutual funds, less any liabilities. The underlying investments of the mutual funds and common collective trusts are mainly equity and fixed income securities and short-term investments. The investment strategies of the Plan's mutual funds and common collective trusts vary generally based on the investment objectives of the asset class of which they are a part. Such investment strategies include investments in fixed income securities and investments in equity securities in domestic and international markets for growth and value objectives as well as to replicate market indexes and to invest in emerging markets. The Plan had no unfunded commitments related to its mutual funds and common collective trusts. The redemption of mutual funds and common collective trusts is subject to the preference of individual Plan participants and contains no restrictions on the timing of redemption.

NOTE 4 – INFORMATION CERTIFIED BY THE PLAN’S CUSTODIAN

No auditing procedures were performed by the independent auditor as permitted by ERISA Section 103(a)(3)(C) with respect to information certified as complete and accurate by Ascensus, LLC (the “custodian”), except for comparing such information with the information reported in the financial statements. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Ascensus, LLC, as complete and accurate to the best of their knowledge, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplemental schedule:

- Investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024.
- Net appreciation/(depreciation) in fair value of investments, interest and dividends reflected on the accompanying Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024.
- Investments and notes receivable from participants reflected in the Schedule of Assets (Held at End of Year).

NOTE 5 – TAX STATUS

The Employer adopted a non-standardized profit sharing pre-approved plan (“profit sharing plan”) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated January 1, 2018, which stated that the profit sharing plan, as then designed, was in compliance with applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and operated in compliance with applicable requirements of the IRC. Administration errors, if any, that are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date. being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, so that each participant receives 100% of his or her account balance as of the date of termination.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Notes receivable from the Plan participants and the related interest income and administrative expenses are also considered party-in-interest transactions. Fees paid by the Plan to the custodian, Ascensus, LLC for the recordkeeping services amounted to \$17,264 for the year ended December 31, 2024. The records of the Plan indicate no party-in-interest transactions, which are prohibited by ERISA and for which no statutory or administrative exemption exists.

NOTE 8 – SUBSEQUENT EVENTS

The Plan evaluated subsequent events through November 20, 2025, the date these financial statements were issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
