### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Petroleum Traders Corporation 401(k) Salary Reduction Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

## **Note 1. Plan Description**

The Petroleum Traders Corporation 401(k) Salary Reduction Plan and Trust (the "Plan") is a defined contribution plan sponsored by Petroleum Traders Corporation (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, ("ERISA"). The provisions of the Plan are included in the official Plan document which legally governs the operations of the Plan and is available for more detailed information.

### Eligibility

To be eligible to participate in the Plan, employees must be 18 years of age or older and have completed one year of service (1,000 hours). Employees may enter the Plan on the first day of the quarter following the completion of all eligibility requirements.

### Participant Contributions

Participants may make voluntary pre-tax or Roth contributions as a percentage of compensation up to the dollar limits set by the Internal Revenue Code. Participants who have attained age 50, before the end of the Plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

### Company Contributions

The Company may make discretionary profit sharing contributions to the Plan. Employees who have met eligibility requirements for the Plan, have worked 1,000 hours and were employed on the last day of the Plan year are eligible. The Company profit sharing contribution for the year ended June 30, 2025 was \$400,000.

### Participant Accounts

Each participant's account is credited with the participant's contribution, Company discretionary profit sharing contribution and Plan earnings and is charged with distributions and an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants have the option of investing in various investment options offered through Great-West Trust Company, LLC, the Plan's insurance company. All amounts in participant accounts are participant-directed and allocations can be changed daily.

## **Note 1. Plan Description (Continued)**

### Vesting

Participants are immediately vested in their elective (voluntary) contributions and income or loss thereon. Vesting in the Company's discretionary profit sharing contributions plus earnings thereon is based on years of service. A participant becomes partially vested after two years of service. Vesting percentages increase each year thereafter with 100% vesting after six years of credited service.

### Forfeitures

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their Company profit sharing contributions. These forfeitures can be used to reduce future Company contributions. At June 30, 2025 and 2024, forfeited nonvested amounts totaled \$29,107 and \$1,442, respectively. During 2025, forfeitures of \$0 were used to reduce Company contributions.

### Benefit Payments

Benefit payments are payable as a single lump-sum distribution or in installments. The full value of a participant's account is payable upon employee election at normal retirement, death or disability. For termination of service due to other reasons, a participant may elect to receive a lump-sum cash distribution, a direct rollover into another qualified plan, or remain in the Plan as an inactive participant if their account balance is greater than \$5,000. Hardship distributions are not permitted.

### Notes Receivable from Participants

The Plan allows participants to borrow from their accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and a minimum of \$1,000. Loans are only granted for the purpose of enabling a participant to meet certain specified financial situations. These situations include paying tuition or medical expenses, preventing foreclosure or purchasing a primary residence. A participant can have two loans outstanding from the Plan if one is for the purchase of a primary residence. The loans must be repaid within five years, unless the loan is for the purchase of a residence, in which case the term can be longer. Loans bear interest at a fixed rate set at prime rate plus 1% at the time of issuance. At June 30, 2025, rates on outstanding loans ranged from 4.50% to 9.50% and the loans mature through 2032.

### Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts and a lump sum distribution will be made to the participant.

## **Note 2. Significant Accounting Policies**

### Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor, insurance company, and third party administrator. See Note 4 for discussion of fair value measurements.

Purchases and sales transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net realized and unrealized appreciation includes the Plan's gains and losses on mutual funds bought and sold as well as held during the year.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 or 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net realized and unrealized appreciation in fair value of mutual funds.

Subsequent Events

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through December 5, 2025, the date the financial statements were available to be issued.

**Note 3. Financial Statement Information Certified by the Plan's Insurance Company**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Great-West Trust Company, LLC, (the insurance company), and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits.
- b. Total investment income (loss), as shown in the accompanying statement of changes in net assets available for benefits, including interest income from notes receivable from participants, interest and dividends from mutual funds, interest from investment contract, and net realized and unrealized appreciation in fair value of mutual funds.
- c. Schedule of assets (held at end of year).

## **Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Mutual funds:* Valued at quoted market prices, which represent the net asset values ("NAV") of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Investment Contract with Insurance Company**

The Plan holds a traditional investment contract with Great-West Life & Annuity Insurance Company (the insurance company). The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, (6) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

Discontinuance of the contract would result in certain surrender charges as defined by the contract. Guaranteed crediting rates are based on a formula agreed upon with the insurance company. Such interest rates are reviewed quarterly for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Principal and interest are guaranteed; however, there is no stated maturity date.

## **Note 6. Income Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2022.

## **Note 7. Transactions with Parties-In-Interest**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments at June 30, 2025 and 2024, are shares of an investment contract managed by the insurance company as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participant transactions are also party-in interest transactions.

Certain administration expenses are paid by the Company on behalf of the Plan. The Company also provides certain administrative services at no cost to the Plan.

## **Note 8. Risks and Uncertainties**

The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## **Note 1. Plan Description**

The Petroleum Traders Corporation 401(k) Salary Reduction Plan and Trust (the "Plan") is a defined contribution plan sponsored by Petroleum Traders Corporation (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, ("ERISA"). The provisions of the Plan are included in the official Plan document which legally governs the operations of the Plan and is available for more detailed information.

### Eligibility

To be eligible to participate in the Plan, employees must be 18 years of age or older and have completed one year of service (1,000 hours). Employees may enter the Plan on the first day of the quarter following the completion of all eligibility requirements.

### Participant Contributions

Participants may make voluntary pre-tax or Roth contributions as a percentage of compensation up to the dollar limits set by the Internal Revenue Code. Participants who have attained age 50, before the end of the Plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

### Company Contributions

The Company may make discretionary profit sharing contributions to the Plan. Employees who have met eligibility requirements for the Plan, have worked 1,000 hours and were employed on the last day of the Plan year are eligible. The Company profit sharing contribution for the year ended June 30, 2025 was \$400,000.

### Participant Accounts

Each participant's account is credited with the participant's contribution, Company discretionary profit sharing contribution and Plan earnings and is charged with distributions and an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants have the option of investing in various investment options offered through Great-West Trust Company, LLC, the Plan's insurance company. All amounts in participant accounts are participant-directed and allocations can be changed daily.

## **Note 1. Plan Description (Continued)**

### Vesting

Participants are immediately vested in their elective (voluntary) contributions and income or loss thereon. Vesting in the Company's discretionary profit sharing contributions plus earnings thereon is based on years of service. A participant becomes partially vested after two years of service. Vesting percentages increase each year thereafter with 100% vesting after six years of credited service.

### Forfeitures

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their Company profit sharing contributions. These forfeitures can be used to reduce future Company contributions. At June 30, 2025 and 2024, forfeited nonvested amounts totaled \$29,107 and \$1,442, respectively. During 2025, forfeitures of \$0 were used to reduce Company contributions.

### Benefit Payments

Benefit payments are payable as a single lump-sum distribution or in installments. The full value of a participant's account is payable upon employee election at normal retirement, death or disability. For termination of service due to other reasons, a participant may elect to receive a lump-sum cash distribution, a direct rollover into another qualified plan, or remain in the Plan as an inactive participant if their account balance is greater than \$5,000. Hardship distributions are not permitted.

### Notes Receivable from Participants

The Plan allows participants to borrow from their accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and a minimum of \$1,000. Loans are only granted for the purpose of enabling a participant to meet certain specified financial situations. These situations include paying tuition or medical expenses, preventing foreclosure or purchasing a primary residence. A participant can have two loans outstanding from the Plan if one is for the purchase of a primary residence. The loans must be repaid within five years, unless the loan is for the purchase of a residence, in which case the term can be longer. Loans bear interest at a fixed rate set at prime rate plus 1% at the time of issuance. At June 30, 2025, rates on outstanding loans ranged from 4.50% to 9.50% and the loans mature through 2032.

### Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts and a lump sum distribution will be made to the participant.

## **Note 2. Significant Accounting Policies**

### Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor, insurance company, and third party administrator. See Note 4 for discussion of fair value measurements.

Purchases and sales transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net realized and unrealized appreciation includes the Plan's gains and losses on mutual funds bought and sold as well as held during the year.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 or 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net realized and unrealized appreciation in fair value of mutual funds.

Subsequent Events

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through December 5, 2025, the date the financial statements were available to be issued.

**Note 3. Financial Statement Information Certified by the Plan's Insurance Company**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Great-West Trust Company, LLC, (the insurance company), and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits.
- b. Total investment income (loss), as shown in the accompanying statement of changes in net assets available for benefits, including interest income from notes receivable from participants, interest and dividends from mutual funds, interest from investment contract, and net realized and unrealized appreciation in fair value of mutual funds.
- c. Schedule of assets (held at end of year).

## **Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Mutual funds:* Valued at quoted market prices, which represent the net asset values ("NAV") of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Investment Contract with Insurance Company**

The Plan holds a traditional investment contract with Great-West Life & Annuity Insurance Company (the insurance company). The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, (6) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

Discontinuance of the contract would result in certain surrender charges as defined by the contract. Guaranteed crediting rates are based on a formula agreed upon with the insurance company. Such interest rates are reviewed quarterly for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Principal and interest are guaranteed; however, there is no stated maturity date.

## **Note 6. Income Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2022.

## **Note 7. Transactions with Parties-In-Interest**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments at June 30, 2025 and 2024, are shares of an investment contract managed by the insurance company as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participant transactions are also party-in interest transactions.

Certain administration expenses are paid by the Company on behalf of the Plan. The Company also provides certain administrative services at no cost to the Plan.

## **Note 8. Risks and Uncertainties**

The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
