### **Scope and Nature of the ERISA 103(a)(3)(c) Audit**

We have performed audits of the accompanying financial statements of the Generation US Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Generation US Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Generation US Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Generation US Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Generation US Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental Schedule of Assets Held at End of Year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### Note A - Description of Plan

The following description of the Generation US Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan sponsored by Generation US (the “Company”), a controlled group. The Plan covers employees of Generation US, and Jobs for Maine’s Graduates, Inc., the participating employers. The Plan was established in October of 1999 and was restated March 6, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC).

#### **Eligibility**

All employees of the Company are eligible to participate in the Plan immediately upon date of hire.

#### **Contributions**

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan, and in addition, participants may make Roth contributions. Effective August 1, 2024, the Plan was amended to allow In-Plan Roth conversion contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various mutual fund investment options offered by the Plan.

After two years of service (1,000 hours in each year), employees who make elective contributions and have attained the age of 21 are eligible for a matching employer contribution. The Company contributes a match equal to 100% of each participant’s deferral, subject to a maximum contribution of 1% of eligible compensation after two years of service, 2% after three years of service, and 3% for four or more years of service. Company contributions are invested directly in the investment option selected by the respective participant and are subject to certain limitations. Employee deferrals and employer match contributions are funded on a payroll basis. All contributions are subject to certain limitations.

Employees are eligible for discretionary employer non elective contributions after having attained the age of 21 and two years of service with 1,000 hours. During the year ended June 30, 2025, the Company elected to make a non elective contribution of \$500. The contribution is not dependent on the employee’s choosing to make elective contributions to the Plan. The contribution is funded on a payroll basis; therefore employees who leave employment during the year only receive a share of the annual contribution earned prior to termination.

## Notes to Financial Statements

### Generation US Retirement Plan

#### Note A - Description of Plan - Continued

##### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and charged with an annual administrative fee. The allocation of administrative expenses is based upon specific participant transactions and account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

##### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan.

##### Vesting and Withdrawals

Participants are immediately vested in their contributions plus allocated earnings thereon. All Company contributions are fully vested when made. Withdrawals are permitted from a participant's account prior to termination of employment in the case of death, disability, or financial hardship (as defined by the IRC). Participants who have reached age 59½ may receive an in-service distribution of all or part of their elective account, including Roth deferrals.

##### Notes Receivable from Participants

Participants may borrow from their account balances the lesser of \$50,000 or 50% of their vested account balances. The maximum number of loans a participant may have outstanding at any time is two. The maximum loan period is five years unless used to acquire a principal residence, in which case the repayment period will be fifteen years. Loans generally become due and payable in full immediately upon termination. The loans are secured by the balance in the participant's account and bear interest at the Wall Street Journal Prime Rate plus 1% when the loans were originated. Principal and interest is paid bi-weekly through a payroll deduction.

##### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a single lump sum payment in cash, or, in certain circumstances, in property. Additional distribution options may be available as allowed through the Plan's investment provider. The Plan will make a mandatory distribution following severance from employment if the non-forfeitable account balance does not exceed \$5,000. For distributions of more than \$200, a participant may elect to roll over the funds to another retirement plan. For vested balances in excess of \$5,000 the participant must consent to any distribution before it may be made.

### Note B - Summary of Significant Accounting Policies

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

#### **Estimates**

The preparation of financial statements in conformity with United States generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### **Notes Receivable from Participants**

Notes receivable are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 and 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the outstanding loan balance will be included in participants' gross income for federal income tax purposes as if it were distributed to him or her.

#### **Administrative Expenses**

Professional and administrative expenses of the Plan, at the Company's election, may be paid out of the Plan or directly by the Company. Plan participants pay an annual fee for administration of the Plan which is deducted from each participant's account. In addition, certain fees are assessed by the custodians for the processing of participant loans and participant withdrawals, and are charged directly to the participant's account. Personnel and facilities of the Company are used by the Plan for its accounting and other activities at no charge to the Plan.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### Note C - Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest, and dividends for the year ended June 30, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Capital Bank and Trust Company and TIAA, the record keepers and custodians of the Plan.

#### Note D - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, defines fair value and provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Note D - Fair Value Measurements - Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024. For the years ended June 30, 2025 and 2024, there were no transfers between Level 1 and Level 2 and no transfers in or out of Level 3.

*Mutual fund investments:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Variable annuity contracts:* Valued at the net asset value of units of a variable annuity. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

*Pooled separate account:* Valued at the net asset value of units of a pooled separate account. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

*Insurance Contracts:* Valued at cash contributions, interest credited, net of transfers in and out.

The preceding methodology may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) The stock variable annuity seeks a favorable long-term rate of return through capital appreciation and investment income by investing primarily in a broadly diversified portfolio of common stocks.
- (b) The money market variable annuity invests in high-quality debt securities and seeks to maximize current income consistent with liquidity and preservation of capital.
- (c) The social choice variable annuity seeks a favorable long-term rate of return that reflects the investment performance of the financial markets while giving special consideration to certain social criteria.
- (d) The global equities variable annuity seeks a favorable long-term rate of return through capital appreciation and income by investing primarily in a broadly diversified portfolio that consists of foreign and domestic stocks.

- (f) The equity variable annuity seeks a favorable long-term rate of return from a diversified portfolio designed to track the U.S. stock market as a whole through investments in stocks included on the Russell 3000 Index.
- (g) The inflation variable annuity seeks a long-term rate of return that outpaces inflation, primarily through the investment in inflation-indexed bonds.
- (h) The core bond variable annuity seeks a favorable long-term rate of return, primarily through high current income consistent with preserving capital.

*Pooled separate account* – This category consists of the TIAA Real Estate Account pooled separate account. The underlying investments of the TIAA Real Estate Account consist primarily of real estate and real estate-related investments. There are no unfunded commitments. Although the underlying assets of the account cannot be quickly sold and converted to liquid assets, the TIAA general account provides the account with a liquidity guarantee which ensures the account has the funds available to accommodate participant redemption requests. Redemptions are limited to one per calendar quarter.

The guaranteed investment contracts are with Teachers Insurance and Annuity Association of America (“the contract issuer”). Participants individually contract with TIAA to establish an account within the TIAA Traditional Annuity. The TIAA Traditional Annuity is offered through a variety of contracts including supplemental retirement annuities (“SRA”), group supplemental retirement annuities (“GSRA”), and retirement annuities (“RA”) as determined by the contract between TIAA and the participant. The SRA and GSRA contracts are considered fully benefit-responsive because they are liquid contracts (see note D). The RA contracts are not considered fully benefit-responsive due to certain illiquidity features discussed below and are valued at fair value measured using a discounted cash flow methodology.

Participant accumulations are available for pre-retirement withdrawal in 10 annual installments upon separation of service under an RA contract. The minimum crediting interest rates are contractually guaranteed to be not less than 3 percent for the RA.

Purchases and sales of the Plan's level 3 investments during the year ending June 30, 2025 were \$11,641 and \$13, respectively. There were \$2,818 transferred out of level 3 investments during the year.

#### Note E - Group Annuity Contract - TIAA Traditional Annuity

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with TIAA totaling \$6,508 and \$8,024 as of June 30, 2025 and 2024, respectively. TIAA maintains the contributions in a general account segregated into non-benefit and fully benefit responsive categories. The account is credited for earnings on the underlying investments and charged for participant withdrawals. The TIAA Traditional Annuity guarantees principal and pays a guaranteed minimum interest rate, which is generally 3%.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by TIAA, approximates market value and represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### **Note F - Related Party and Party-in-Interest Transactions**

Participant notes receivable transactions are considered to be party-in-interest transactions because they are transacted with Plan participants.

Certain Plan assets are invested in American Funds mutual funds. American Funds is a subsidiary of Capital Research and Management Company, an affiliate of Capital Bank and Trust Company – a Plan record keeper and custodian. Certain other Plan assets are invested in TIAA securities – a Plan record keeper and custodian. Therefore, these activities qualify as party-in-interest transactions.

For the years ended June 30, 2025, the plan paid certain direct and indirect recordkeeping fees to American Fund Services Company, totaling \$15,692. Fees charged by the third-party administrator are paid by the sponsor. The aforementioned activities qualify as party-in-interest transactions.

#### **Note G - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA.

#### **Note H - Tax Status**

The Company, as the Plan's sponsor, adopted a Pre-Approved 403(b) plan, which received an Internal Revenue Service opinion letter dated March 31, 2017, which states that the Pre-Approved document satisfies the applicable sections of the IRC. The Plan has subsequently been amended; however, the Plan's management believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC, and that the Plan continues to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### Note H - Tax Status - Continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

#### Note I - Risks and Uncertainties

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and statement of changes in net assets available for benefits.
