Opinion

We have audited the financial statements of the TriMark Corporation (Company) Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter—Investments

As discussed in Note 3, the financial statements include investments in Company common stock representing approximately 99% of total assets as of December 31, 2024 and 2023, whose fair value has been estimated by an independent appraisal, in the absence of readily ascertainable fair values, with the assistance of management and approved by the trustee. Because of the inherent uncertainty of the valuation, those estimated values may differ significantly from the values that would have been used had a market for the investments existed, and the differences could be material. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements, or to the financial statements themselves, and other additional procedures in accordance with GAAS.

Notes to Financial Statements

Note 1. Plan Description

The following description of TriMark Corporation Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: TriMark Corporation (the Company) established the Plan effective March 13, 1989, to provide a means by which employees may share in the ownership of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: All United States employees who are at least 21 years of age are eligible to participate in the Plan after completing one year of service, provided they worked at least 1,000 hours during such plan year.

Contributions: The Company's contributions to the Plan are discretionary. Contributions by participants or loans to participants are not permitted.

Participant accounts: Each participant's account is credited as of the last day of the plan year with an allocation of (1) the Company's discretionary contribution, (2) earnings and (3) forfeitures of terminated participant's nonvested accounts and charged with an allocation of administrative expenses paid by the Plan, if any. Participants must have completed 1,000 hours of service during the plan year to receive allocations of contributions and forfeitures, and those allocations are based on the ratio that each participant's eligible compensation bears to all participants' eligible compensation for the plan year. Allocations of earnings and expenses are based on participant account balances as defined in the Plan.

Vesting and forfeitures: Benefits are fully vested if a participant terminates due to normal retirement, death or disability. If a participant terminates for other reasons, the account will be vested based on qualifying years of service. A participant becomes 20% vested for each year of service until fully vested after five years of service. When a participant who is not fully vested terminates, the nonvested interest in his or her account is held in suspense until the earlier of a distribution of his or her vested interest or a five-year break in service has occurred. The account is then forfeited and allocated to the remaining participants in the same manner as Company contributions. Forfeitures allocated to participants during the year ended December 31, 2024, totaled \$13,042. There were no forfeited nonvested accounts to be allocated to participant accounts in future years as of December 31, 2024 and 2023.

Benefit payments: Upon separation from service with the Company due to death, disability, retirement or termination, distribution of a participant's benefit may be made in cash or Company stock. For cash distributions to participants whose vested account balance exceeds \$1,000, participants may receive a lump sum and/or installment payments on an annual basis over four years. A participant whose vested account balance is \$1,000 or less and has not commenced receiving installment payments will automatically receive an immediate lump-sum distribution equal to his or her vested account balance.

Diversification rights: Diversification is offered to participants close to retirement age so that they may have an opportunity to move part of the value of their investments in Company stock into investments that are more diversified. Participants are able to diversify a portion of their account when they reach age 55 and have participated in the Plan for 10 years. Diversification is offered to each eligible participant over a six-year period. In the first five years, a participant may diversify up to 25% of the total number of shares allocated to their accounts, less any shares previously diversified. In the sixth year, the percentage changes to 50%. The election to diversify is made subsequent to year-end based on the shares of Company stock in the participant's account at year-end.

Note 1. Plan Description (Continued)

Voting rights: All Company stock shall normally be voted by the Trustees at their sole discretion. However, a participant or beneficiary has the right to direct the Trustee regarding the voting of such Company stock allocated to his stock account with respect to any corporate matter involving the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business or such similar transactions as may be prescribed in Internal Revenue Code (Code) Regulations. Each participant or beneficiary shall have one vote per whole share of allocated Company stock. For any shares of unallocated Company stock or any shares of Company stock which a participant or beneficiary fails to vote, the Trustee will vote the Company stock as directed by the Employer or other party appointed by the Employer for such purpose.

Put option: Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or that is subject to trading limitations, includes a put option. The put option shall permit the participant or beneficiary to sell such Company stock at its estimated fair value, as determined by an independent appraiser. There are two 60-day periods in which a participant can sell stock back to the Company. The first period begins on the stock distribution date and ends 60 days thereafter. The second 60-day period begins approximately five months later, in which the participant will be notified when the second 60-day period begins. If a participant sells his or her stock back to the Company, the participant will receive a cash payment equal to the fair market value of the Company stock as of December 31 immediately preceding the date the shares are sold. Payment for Company stock purchased pursuant to a put option shall be made no later than 30 days after such participant exercises the put option. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires Plan management to make estimates and assumptions that affect the reported value of net assets available for benefits and changes therein. Actual results could differ from those estimates. Of particular significance are estimates related to the valuation of TriMark Corporation common stock. The Company believes the independent appraisal provides a reasonable estimate of its value. Because of the significance of the assumptions required in the valuation, the actual value could materially differ had a ready market for the securities existed.

Risks and uncertainties: The Plan investments consist primarily of the Company's stock, which is exposed to various risks such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with the investment in Company stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the Company's stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Significant Accounting Policies (Continued)

Benefit payments: Distributions to participants are recorded when cash is paid or shares are distributed. Cash distributions were \$2,999,885 for the year ended December 31, 2024. There were no shares distributed for the year ended December 31, 2024.

Administrative expenses: The majority of Plan administrative expenses are paid by the Company. The Plan paid no expenses for the year ended December 31, 2024.

Subsequent events: Management has evaluated subsequent events through December 9, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Company common stock: Valued at fair value as determined annually by an independent appraiser. The appraisal calculated the value of the Company's common stock by using a combination of the income approach as represented by a discounted cash flow model and the market approach using a merger and acquisition and guideline public company models. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

Note 3. Fair Value Measurements (Continued)

The valuation process involves the Plan fiduciary's selection of an independent appraiser under a written annual contract. Company management accumulates the data for the appraiser from the audited financial statements of the Company and prepares the models for future growth or profitability expectations. The appraiser prepares a preliminary report, which Company management, along with the Plan fiduciary, reviews in detail, discusses, modifies if appropriate, and ultimately approves. The results of this process are documented in the minutes of the Plan fiduciary.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 4, 2016, that the Plan and related trust were designed in accordance with the applicable regulations of the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
