## **INDEPENDENT AUDITOR'S REPORT**

To the Administrative Committee of  
the J.T. Magen & Company Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of J.T. Magen & Company Inc. 401K Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of J.T. Magen & Company Inc. 401K Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of J.T. Magen & Company Inc. 401K Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about J.T. Magen & Company Inc. 401K Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### **NOTES TO FINANCIAL STATEMENTS**

#### **1) DESCRIPTION OF PLAN:**

The following description of the J.T. Magen & Company Inc. 401K Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

(a) **General** - The Plan is a defined contribution plan covering all eligible employees. The Plan sponsor is J.T. Magen & Company, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan includes all full-time employees who have three months of service and are age 21 or older, excluding the following: employees of Hospitality 3 (an affiliate of the Company through common ownership), employees that were represented by a bargaining unit, a nonresident alien with no U.S. income or if all such income is exempt from U.S. income tax, or a leased employee.

(b) **Contributions** - Participants may make deferral contributions each year, subject to certain limitations. Participants who will attain age 50 before the end of the Plan year are permitted to make higher deferral contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company may contribute up to \$5,000 per participant, which is invested in a portfolio of participant-directed investments. Participants may direct both their elective deferrals and employer contributions into mutual funds and the pooled separate account.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% on a pre-tax basis of eligible compensation and their contributions invested in the Vanguard Target Retirement Funds, which most closely corresponds with the participant's retirement date until changed by the participant.

In addition, the Plan allows for qualified non-elective contributions ("QNEC") by the Company, equal to 50% of the employee's missed deferral.

(c) **Participant Accounts and Allocations** - Each participant account is credited with the participant's contributions, an allocation of any Company contributions and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined.

(d) **Vesting** - Participants are immediately vested in their voluntary contributions and the QNEC contributions plus actual earnings thereon. Vesting in the Company's contribution is based on years of continuous service. A participant is 100 percent vested after five years of credited service, or due to death, disability or retirement.

(e) Notes Receivable from Participants - Participants may borrow twice a year between \$1,000 and the lesser of \$50,000 or 50 percent of their vested balance. Outstanding loans must be paid off before obtaining a new loan. A loan is considered a note receivable of the Plan. The participant's account will be reduced by the amount of the loan. Any repayment made, including interest income, will be allocated to the participant's account in accordance with his or her current investment direction. Loans are secured by the account balance and bear interest based on rates for similar loans at commercial lending institutions. The range of interest rates for both 2024 and 2023 were 4.25% to 9.5%. Loans are repaid weekly for up to five years through payroll deductions. The loan shall be in default if the balance remains unpaid for more than 90 days after the due date. A terminated employee has 60 days to repay any loan balance. After 60 days, a loan balance will be deemed a distribution.

(f) Payment of Benefits - If termination is due to death, disability or retirement, participants, or beneficiaries in the case of death, may elect to receive vested balances as a lump-sum or in annual installments until age 70.5 if the vested balance is greater than \$5,000, and as a lump-sum if the vested balance is less than \$5,000. For termination of service due to other reasons, only a participant who has a greater than \$5,000 vested balance may leave that balance in the Plan. Participants may receive their vested balances as a lump-sum or as a rollover to another employer's qualified plan.

Hardship withdrawals – Under certain conditions, participants, while still employed by the Company, are permitted to withdraw in a single sum a portion of their vested balance for an immediate financial need. These conditions include unreimbursed medical expenses, the purchase of the participant's primary residence, the payment of post-secondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence, or to prevent eviction or foreclosure from the participant's principal residence. A participant's right to make deferrals to the Plan will be suspended for six months after the receipt of a hardship withdrawal.

(g) Forfeited Accounts – Amounts forfeited by terminated employees are first used to pay expenses of the Plan and then to reduce the Company's matching contributions. In 2024, \$5,100 from forfeited non-vested accounts were used to pay expenses of the Plan, and the remaining \$13,420 was used to reduce employer contributions.

(h) Form 5500 - Net assets available for benefits and changes in net assets available for benefits per the financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024 did not differ from the amounts reported on Form 5500 for those years.

## **2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

(a) Basis of Accounting - FASB Accounting Standard Codification (ASC) Topic 962, *Plan Accounting - Defined Contribution Pension Plans*, requires investment contracts held by a defined-contribution plan to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-

responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

(b) Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are reinvested and recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold or held during the year.

(d) Notes Receivable from Participants - Notes receivable from participants are presented at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions.

On January 1, 2023, the Plan adopted ASU 2016-13 "*Financial Instruments – Credit Losses: Measurement of Credit Losses on Financial Instruments*" (ASC 326). ASC 326 requires an entity to provide an estimate of credit losses for the remaining life of a financial asset using historical data, current conditions, and reasonable supportable forecasts. It generally applies to financial assets measured at amortized cost, including notes receivable from participants. Such assets are presented at the net amount expected to be collected by using an allowance for credit losses.

Management considers the following factors when determining the collectability of notes receivable from participants: participants can borrow the lesser of \$50,000 or 50 percent of their vested balance; loans are secured by the participant's account balance; loans are considered in default if not repaid within 90 days (or 60 days for terminated employees) after the due date. Unpaid balances after the default period are treated as distributions. Management believes there is minimal credit risk associated with notes receivable from participants.

The Plan adopted ASC 326 using the prospective transition approach. There was no material impact on the Plan's net assets available for benefits upon adoption of the new Standard.

(e) Excess Contributions Payable - Amounts payable to participants and employer for contributions in excess of their required payments are presented as a liability with a corresponding reduction to participant and employer contributions. At December 31, 2024 and 2023, excess contributions payable to participants were \$0 and \$26, respectively; excess contributions payable to employer were \$0 and \$642, respectively.

(f) Payment of Benefits - Benefit payments to participants are recorded when paid.

(g) Administrative Expenses - Certain plan administrative expenses, such as those related to recordkeeping, participant website access, and participant statements, are paid directly by participants. Fees associated with the administration of participant loans are charged to the respective participant's account and are included in administrative expenses.

Investment-related expenses that are embedded in the investment funds' expense ratios are not separately reported but are reflected in the net appreciation of fair value of investments in the accompanying Statement of Changes in Net Assets Available for Benefits.

Expenses paid directly by the Company are not included in these financial statements.

(h) Subsequent Events - The Plan has evaluated subsequent events through December 2, 2025, the date the financial statements were available to be issued.

### 3) FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value (ASC Topic 820, *Fair Value Measurements and Disclosures*). The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

Shares of mutual funds are valued at the quoted net asset value of shares held by the Plan at year end, which is deemed a level 1 input.

This PSA invests in a single mutual fund - the Principal Real Estate Securities R6 Fund (ticker PFRSX). The fair value of the mutual fund is a publicly quoted price used to determine the net asset value ("NAV") of the pooled separate account, which is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date. Therefore, this investment can be considered a "Readily Determinable Fair Value." The NAV is calculated in a manner consistent with GAAP for investment companies. The fair value of the underlying mutual fund is based on third-party pricing vendors and utilize observable market information. Because it is valued similarly to mutual funds, this separate account is considered a level 1 asset to allow for consistent disclosure.

#### **4) GUARANTEED INVESTMENT CONTRACT WITH THE PRINCIPAL LIFE INSURANCE COMPANY:**

In 2007, the Plan entered into a fully benefit-responsive guaranteed investment contract ("GIC") with Principal Life Insurance Company ("Principal Life"). Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal Life is obligated to repay the principal and a specified guaranteed interest rate. In 2024, the GIC was fully redeemed for \$2,994,128. Mutual funds were purchased with the redeemed amount.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than the guaranteed minimum interest rate, which ranges from one to three percent. Such interest rates are reviewed semiannually for resetting. Changes in future interest crediting rates will not affect the amount reported as an adjustment from fair value to contract value, if any, on the statement of net assets available for benefits for the portion of net assets attributable to fully benefit-responsive investment contracts.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan's sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under

ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit Principal Life to terminate the contract unless an irrevocable request for termination from the Company is received. The termination request must be received at least 12 months in advance, otherwise, the Company will be charged a 5 percent termination fee.

#### **5) PARTY-IN-INTEREST TRANSACTIONS:**

Certain Plan investments are managed by the trustee, Principal Financial Group (“Principal”), and, therefore, these transactions qualify as party-in-interest transactions. In 2024, the Plan paid Principal investment management fees totaling \$130,486.

#### **6) PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such manner as the Company may determine.

#### **7) TAX STATUS:**

The Company has adopted the Principal Prototype Plan, a word-for-word Internal Revenue Service (“IRS”) approved document, and the IRS has issued Principal a favorable opinion letter for the Prototype Plan. The Plan and related trust are designed and currently are being operated in compliance with the applicable provisions of the Internal Revenue Code.
