INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
International Brotherhood of Electrical Workers
Local Union No. 163 Annuity Fund

Opinion

We have audited the accompanying financial statements of the International Brotherhood of Electrical Workers Local Union No. 163 Annuity Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the International Brotherhood of Electrical Workers Local Union No. 163 Annuity Fund as of March 31, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.


Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED MARCH 31, 2025 AND 2024

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the International Brotherhood of Electrical Workers Local Union No. 163 Annuity Fund (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution annuity plan covering eligible members of the International Brotherhood of Electrical Workers Local Union No. 163 (the Union). Any Union employee working for a contributing contractor in the jurisdiction of the Union under the terms of a collective bargaining agreement is eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - The Plan is funded solely by contributions based on the rate specified in the collective bargaining agreements between various contributing employers and the Union. Contributions are subject to certain limitations.

Participant Accounts - Each participant's account is credited with the employer's contributions and allocations of the Plan's earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting - Participants are 100% vested in their individual account balances at all times.

Benefits - The Plan provides retirement, death, disability and termination benefits to its participants. Normal retirement benefits are payable at age 60. Retirees have an option to withdraw all funds or proceed with the scheduled terms of the Plan. Termination benefits are payable after a six-month separation of employment for any reason other than normal retirement, death or disability. The amount of benefits is based upon each participant's account balance at the date of termination.

Benefits are distributed either monthly in accordance with a fixed schedule or in the form of a single lump sum payment.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Employer Contributions - Revenue from employer contributions is determined by hours of work reported by participating employers and the contractual employer contribution rates in effect. Employer contributions are included in revenue during the period in which the work is performed. The accounts receivable represents uncollected contributions for hours worked through end of the Plan's year end and are based on verified subsequent period cash collections.

Reciprocal Contributions - Reciprocal contributions represent payments received from other local pension plans for work performed out of the local union's area of operation.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value, except for the fully benefit-responsive contract which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's Board of Trustees (Trustees) determines the Plan's valuation policies utilizing information provided by its investment advisors and custodians. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits payments to participants are recorded when paid.

Administrative Expenses - Administrative expenses are paid by the Plan.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3. INCOME TAX STATUS

The Internal Revenue Service (IRS) determined and informed the Trustees by a letter dated September 10, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan's administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.



NOTE 3. INCOME TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4. PLAN TERMINATION

The Plan shall terminate upon the occurrence of any one or more of the following events:

- a) If the Plan assets are, in the opinion of the Trustees, inadequate to carry out the intent and purpose of the Plan, or are inadequate to meet the payments due or which may be come due to participants and beneficiaries;
- b) If the Union and employers agree to terminate the Plan; or
- c) Any other event which may, by law, require termination.

In the event of termination, partial termination, or discontinuance of the Plan, each participant and beneficiary account shall be 100% fully vested. In no event shall any funds ever revert to the employers.

NOTE 5. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.



NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at March 31, 2025 and 2024.

Mutual funds: Valued at the daily closing prices as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7. PARTY-IN-INTEREST

Certain assets of the Plan are managed by John Hancock Trust Company, LLC, the custodian and trustee, as defined by the Plan. Participant accounts are maintained by John Hancock Trust Company. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.



NOTE 8. RELIANCE TRUST STABLE VALUE FUND

The Plan's insurance company contract, the Reliance Trust Stable Value Fund - MetLife Series 25157 (the Fund), is a fully benefit-responsive insurance contract. Under this contract, participants may direct all or a portion of their contributions to this investment. The participant's account is credited with deposits and interest less withdrawals and fees. Interest is using a single portfolio rate approach. Under this method, a single rate is applied to all contributions to the account regardless of the timing of the contributions. The Fund provides a fixed interest rate for a fixed period that will apply to the entire guaranteed value. The interest rate is reset every quarter as determined by MetLife with considerations of the fair value of the separate accounts, expected payments into and out of the contract, amortization of the difference, if any, between the fair value of the separate accounts and the guaranteed value of the contract, and the fees allowed under the contract. MetLife guarantees that the interest rate will never be less than zero. The fixed interest rate on the contract is reset every quarter and is calculated as the three-month London Interbank Offered Rate (LIBOR) plus 0.54% on the date of calculation.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because of this the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Metlife, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include amendments to the Plan documents including complete or partial plan termination or merger with another plan, changes to the Plan's prohibition on competing investment options, bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan or the failure of the trust to qualify for exemption from the federal income taxes or any required prohibited transaction exemption under ERISA or premature termination of the contract. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation, or a material amendment to the agreement without the consent of the issuer. The Plan's administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The total amount that the Plan held in this contract was \$9,618,727 and \$10,183,809 as of March 31, 2025 and 2024, respectively. There are no unfunded commitments related to this contract.



NOTE 9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through December 3, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
