Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

1. Description of Plan

The following description of ImageTrend, Inc. (“Company”) 401(k) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all eligible employees of the Company. Employees are eligible for participation if employed on the entry dates after reaching twenty-one years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and the requirements of section 401(k) of the Internal Revenue Code (IRC).

Contributions - The Plan permits contributions up to the maximum percentage allowable by IRS Code Sections 401(k), 402(g), 404 and 415. The Company can make discretionary matching contributions. The Company made matching contributions equal to 50% of the employee contributions up to 8% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may contribute a discretionary amount to the profit sharing plan to be determined annually by the Board of Directors. There were no discretionary contributions for the years ended December 31, 2024 and 2023.

Participant accounts - Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s matching contribution; (b) the Company’s discretionary contribution, if any; and, (c) Plan earnings and forfeitures of terminated participants’ non-vested accounts. Allocations of the Company’s discretionary contribution are based on participant compensation, and allocation of plan earnings are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Under the 401(k) plan, participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s contributions allocated to a participant’s account is based on years of continuous service. A participant is 100% vested after five years of credited service.

1. Description of Plan (continued)

Notes receivable from participants - Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their non-forfeitable account balance. The loans are secured by the balance in the participant's account and bear interest rates from 4.25% to 9.50%, which are commensurate with local prevailing rates. Principal and interest is paid through bi-weekly payroll deductions. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits - Benefits may be withdrawn if any of the following occur: normal retirement age, which is defined as age 62; hardships; disability; termination of employment; termination of the Plan; death. Vested balances of less than \$5,000 are paid out as soon as administratively possible after the participant is eligible to receive them. Vested balances over \$5,000 are paid out as requested by the participant.

Forfeited accounts - Forfeitures of non-vested accounts totaled \$400 and \$716 for the years ended December 31, 2024 and 2023, respectively. These amounts have been applied to employer contributions.

2. Summary of Accounting Policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Payments of benefits - Benefits are recorded when paid.

Administrative expenses - Expenses incurred by the Plan for audit fees, Plan administrative fees, and substantially all other operating expenses are paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in expenses. Record keeping and investment related expenses are charged to participant accounts and are included in expenses.

2. Summary of Accounting Policies (continued)

Investment valuation and income recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Subsequent events – Plan management has evaluated subsequent events through September 10, 2025, which is the date the financial statements were available to be issued.

3. Investments

The December 31, 2024 and 2023, Statements of Net Assets Available for Benefits, the investment activities included on the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the custodian in accordance with 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The information certified includes total investments of \$30,233,887 and \$24,143,716 as of December 31, 2024 and 2023, respectively, and income of \$6,091,434 and related losses of \$5,680,585 for the years ended December 31, 2024 and 2023, respectively. 4. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC (the custodian of the plan).

5. Fair Value Measurements

The Fair Value Measurements Topic of the FASB Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Level 2 - Inputs are inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 - Inputs are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed Portfolio Fund: The net asset value is based on the market value of the underlying investments. This fund contains synthetic investments comprised of both underlying investments and other components which have observable Level 1 or Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets.

6. Guaranteed Portfolio Fund

The Plan entered into an investment with Empower Trust Company, LLC. Empower Trust Company, LLC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fund is included in the financial statements at fair value as reported to the Plan by Empower Trust Company, LLC. Fair value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at fair value, which approximates market value. The guaranteed portfolio fund issuer is obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

6. Guaranteed Portfolio Fund (continued)

The fair value of the investment contract was \$756,621 and \$700,817 as of December 31, 2024 and 2023, respectively. The average yield and crediting interest rate was approximately 1.41% and 1.23% for the years ended December 31, 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

For participants who have \$2,500 or more in the guaranteed account at the beginning of the Plan year, the maximum transferable amount is 20% of the balance as of the beginning of the year. For amounts less than \$2,500 at the beginning of the Plan year, any amount may be transferred during the Plan year.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Plan Amendments and Tax Status

The prototype plan obtained a favorable determination letter on March 31, 2008, in which the Internal Revenue Service stated the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, and the plan administrator believes the Plan is operating in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Nonparticipant-Directed Investments

There are no nonparticipant-directed investments.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

11. Party-in-Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption applies. For the plan years ended December 31, 2024 and 2023, Empower Trust Company, LLC is a party-in-interest, as defined by ERISA, as a result of its investing plan assets. However, such transactions are exempt under Section 408(b)(8) and are not prohibited by ERISA.

The Plan paid investment advisory, investment management, and record keeping fees totaling approximately \$100,000 and \$80,000 during the years ended December 31, 2024 and 2023, respectively.

Certain plan investments are shares of mutual funds managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan sponsor pays directly any other fees related to the Plan's operations.
