We have performed audits of the accompanying financial statements of Tietex International, Ltd., 401(k) Retirement Savings Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Note 1—Description of the Plan

The following description of the Tietex International, Ltd., 401(k) Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees of Tietex International, Ltd., and Interflex Limited Liability Company (through November 30, 2024) (collectively the “Company” or “Plan Sponsor”), who have three consecutive months of service. Plan entry occurs on the first day of any month immediately following satisfaction of eligibility requirements. Fidelity Management Trust Company is the “qualified institution” of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Each participant may contribute to the Plan up to 80% of their pre-tax annual compensation as defined in the Plan. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations; additionally, participants can contribute an additional after-tax deferral subject to the maximum IRC limitations. Plan entrance occurs on the first of each month at which time eligible employees are automatically enrolled at 6%. Eligible employees may elect to decline enrollment. The Plan has a provision which automatically enrolls participants to be increased by 1% per year up to a maximum automatic deferral of 10%. Effective January 1, 2023, the Plan Sponsor changed to a non-elective profit share contribution, equal to 5% of eligible compensation of each eligible participant. An additional discretionary profit-sharing amount may be contributed at the discretion of the Company’s Board of Directors. No discretionary profit-sharing contributions were made for the year ended December 31, 2024. Profit sharing contributions were made for the plan years ending December 31, 2024 and 2023 in the amount of \$1,009,408 and \$1,028,449, respectively (see Note 8 for funding of these contributions). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined-contribution plans. Such contributions are recorded as rollover contributions in the accompanying financial statements.

Participant Accounts – Each participant’s account is credited with (a) the participant’s contributions, (b) the Company’s contributions, and (c) an allocation of the Plan’s earnings (losses). Each participant’s account is charged with participant withdrawals and an allocation of the Plan’s expenses. Allocations of Plan earnings and administrative expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions and employer non-elective profit sharing contributions to the Plan, plus investment earnings thereon. Participants are fully vested in other discretionary employer contributions after three years of service.

Forfeitures – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures available for use totaled \$4,525 and \$1,705 as of December 31, 2024 and 2023. During the year 2024, no forfeitures were used to reduce employer contributions.

Investment Options – Participants may change their investments with the trustee at any time. Participants may direct their accounts into various investments offered by the Plan.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, a participant may elect to receive withdrawals upon reaching the age 59½.

Note 1—Description of the Plan (continued)

Hardship Withdrawals – The Plan allows participants to make hardship withdrawals to satisfy certain immediate and heavy financial needs. A participant may request a hardship withdrawal for certain qualifying expenses as defined by the Plan document. The hardship withdrawal is subject to certain conditions: 1) the distribution is not in excess of the amount of any immediate and heavy financial need and 2) the participant has exhausted all other distribution types.

Notes Receivable from Participants – Participants may borrow from the Plan up to 50% of their vested account balance, but not less than \$1,000 or more than \$50,000. In addition, participants are allowed only one loan at a time. Effective July 2, 2018, a participant with the maximum number of existing loans may not apply for another loan until one year following the date an existing loan is paid in full. Generally, loan terms may not exceed five years unless such funds are used to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates were 4.25% to 9.50% with maturities through October 2034 as of December 31, 2024. Principal and interest is paid ratably through payroll deductions. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the Plan document.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Such estimates include those regarding fair value. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Net appreciation in fair value of investments is comprised of realized, as well as unrealized, gains or losses resulting from investment transactions. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date.

Fair Value Measurements – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Interest Bearing Cash – This investment consists of deposits in primarily cash accounts valued at cost plus accrued interest, which approximates fair value due to their short-term maturities and high liquidity. Interest-bearing cash is classified within Level 1 of the valuation hierarchy.

Mutual Funds – These investments are public investment vehicles valued using net asset value (“NAV”) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares, outstanding. NAV is a quoted price in an active market, investments are classified within Level 1 of the valuation hierarchy.

Common Collective Trust – Investment in the common collective trust fund are stated at estimated fair values, which are determined based on the unit values of the funds. Unit values are determined by the organization sponsoring such funds by dividing the funds' net assets at fair value by its units outstanding at each valuation date. As there is no readily determinable fair value and the trust is valued at the NAV practical expedient, it is shown outside the fair value hierarchy.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis.

Administrative Expenses – Except as discussed in Note 5, administrative expenses are paid by the Plan Sponsor.

Payment of Benefits – Benefit payments to participants are recorded when paid.

Note 5—Related party and party-in-interest transactions

Plan investments are shares of mutual funds and common collective trusts managed by the qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

Certain fees are paid by the Plan to the trustee for recordkeeping and administrative services amounted to \$8,225 and fees of \$15,463 were paid to an advisor for the year ended December 31, 2024, which are included within administrative expenses on the statement of changes in net assets available for benefits. Notes receivable from participants qualify as party-in-interest transactions.

Note 6—Plan termination

Although the Company has not expressed any intention to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, all participants will become fully vested in their accounts.

Note 7—Tax status

The Plan has not obtained a determination letter from the Internal Revenue Service (“IRS”) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the volume submitter profit sharing plan with a cash or deferred arrangement the plan is utilizing. The IRS has determined and informed the trustee by a letter dated June 30, 2020, that the volume submitter plan document was designed in accordance with applicable sections of the IRC. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Transfer from closed pension plan

The Company sponsored the Pension Plan for the Employees of Tietex International, Ltd. (the “Pension Plan”), a defined benefit pension plan in addition to the Tietex International, Ltd. 401(k) Retirement Savings Plan presented within these financial statements. During 2022, the Company terminated the Pension Plan and in accordance with the Pension Plan adoption agreement, remitted certain remaining undistributed funds to the Plan during 2023. This transfer totaled \$1,950,000 and is to be used by the Plan to fund current and future profit-sharing contributions over a period not to exceed seven years. During 2024, \$918,120, plus accrued dividends, was used to satisfy profit sharing contributions. During 2023, \$1,031,979 was used to satisfy profit sharing contributions.

Note 9—Prohibited transactions

During 2020, 2021, and 2023 participant salary deferral contributions and loan payments from participants to the Plan totaling \$38,125, \$92,713, and \$7,151 respectively, were not remitted to the Plan in accordance with DOL rules regarding timely remittances on multiple occasions. Plan management calculated the lost earnings on these deferrals and plans to correct the late remittances through DOL’s voluntary Fiduciary Correction Program (“VFCP”) during 2026. The lost earnings are not significant to the financial statements.
