### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of SigmaTron International, Inc. 401(k) Retirement Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SigmaTron International, Inc. 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Note 1. Description of the Plan**

The following description of SigmaTron International, Inc. 401(k) Retirement Savings Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all eligible employees of SigmaTron International, Inc. (Company) who have at least one month of service and are age 18 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

### **Contributions**

Participants may elect to contribute 100% of their pretax annual compensation to the Plan as permitted under the Internal Revenue Code (IRC). Participants who have attained age 50 by the end of the plan year are eligible to make catch-up contributions as permitted under the IRC. Effective September 1, 2019, all employees who are eligible to make pretax salary deferrals can also make Roth deferral contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Prior to September 1, 2019, the Company provided a matching contribution equal to 100% of the first \$300 of all participant contributions. Effective September 1, 2019, the Plan was amended to change the Company-matching contribution for all eligible employees except participants who are members of a union and who are covered by a collective bargaining agreement. The Company-matching contribution is 25% of the first 5% of the participant's plan compensation contributed as elective deferral and/or employee after-tax contributions not to exceed 1.25% of each participant's plan compensation up to a maximum of \$2,000 per year. Participants who are members of a union and who are covered by a collective bargaining agreement will continue to receive the matching contribution equal to 100% of the first \$300 of participant contributions.

Prior to September 1, 2019, the Company could also make a discretionary contribution to all eligible employees except participants who were members of a union and who were covered by a collective bargaining agreement between the union and the Company as those employees were not eligible for the discretionary contribution. Effective September 1, 2019, the discretionary contribution of 1% stopped when the new matching contribution went into effect.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company-matching contributions and allocations of the Company's discretionary contributions (if any) and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Participants direct the investment of all contributions to various investment options offered by the Plan. The Plan currently offers various registered investment companies, money market funds, self-directed brokerage accounts, and common or collective trust funds as investment options for participants. Participants may also elect to invest amounts into certain GoalManager portfolio investment options which invest in a mix of the investment funds available to participants of the Plan. There are five portfolio models

including conservative, conservative to moderate, moderate, moderate to aggressive, and aggressive. Each portfolio model is intended for a different level of investment risk and potential return, and each portfolio model is rebalanced on a regular basis to maintain an allocation (percentage of stocks, bonds and cash equivalents investments) within each portfolio and promote a diversified investment. Participants may change their investment options at any time.

***Vesting***

Participants are immediately vested for all participant contributions, Company contributions and actual earnings thereon.

***Payment of Benefits***

In the event of retirement, death, disability, termination of employment or financial hardship, the balance in the participant's account is distributed to the participant or the participant's beneficiary in a single lump-sum payment. If the vested portion of the participant's account is not more than \$5,000, benefits will be distributed in a single payment in cash or rolled over into an individual retirement account.

***Notes Receivable From Participants***

Participants may borrow from their fund accounts an amount equal to the lesser of \$50,000 less the highest outstanding loan balance incurred in the 12 months prior to the loan origination date or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate of interest determined by the Company. The participant may only have one note receivable outstanding at a time. The loan must be repaid over a period of no more than five years, unless it is used to acquire a principal residence, in which case the repayment period may exceed five years. Interest rates range from 3.25% to 8.50% at April 30, 2025.

***Forfeitures***

As of April 30, 2025 and 2024, the forfeiture account totaled \$4,730 and \$4,570, respectively. The balance in this account may be used to offset administrative fees, reduce employer contributions, or be allocated to participants. No forfeitures were used during 2025 and 2024.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

The Plan's investments are stated at fair value. The Plan's investments in shares of registered investment companies are valued at quoted market prices. Money market funds are valued at cost, which approximates fair value. Self-directed brokerage accounts consist of common stocks, money market funds, short-term investments, and a mutual fund which is further described in Note 4.

The common or collective trust funds are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at April 30, 2025 and 2024.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Loan processing fees are paid by the participant and certain other administrative expenses are paid by the Plan. Additionally, certain employees of the Company provide administrative and trustee services to the Plan and are not reimbursed by the Plan for such services.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

**Note 3. Party-in-Interest Transactions**

Investment, managerial, legal and auditing fees for the Plan are paid by the Company or the Plan. Certain plan investments are shares of registered investment companies, interests in common or collective trust funds, and money market funds managed by the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan recognizes income from revenue sharing agreements when received. During 2025, revenue sharing income of \$3,733 was offset against administrative expenses of \$20,544 for a net of \$16,811 which is included in deductions on the statement of changes in net assets available for benefits. During 2024, revenue sharing income of \$32,918 was offset against administrative expenses of \$20,398 for a net of \$12,250 which is included in additions on the statement of changes in net assets available for benefits. During 2025 and 2024, \$18,769 and \$18,638 was used to pay professional service fees, respectively.

The revenue credit account had a balance of \$44,333 and \$59,023 at April 30, 2025 and 2024, respectively. The balance in this account can be used to pay plan expenses or allocated to eligible participant accounts.

#### **Note 4. Fair Value Measurements**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants and the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; and other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at April 30, 2025 and 2024.

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). Money market funds are carried at cost, which approximates fair value (Level 1 inputs). Self-directed brokerage account investments in money market funds and short-term investments are carried at cost, which approximates fair value (Level 1 inputs). Self-directed brokerage account investments in publicly traded common and preferred stock values are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). Self-directed brokerage account investments in the mutual fund are valued at quoted market prices of shares held by the Plan at year-end (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Bank of America, N.A., a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Cash, investments, and notes receivable from participants as shown in the statements of net assets available for benefits as of April 30, 2025 and 2024
- Investment income components and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended April 30, 2025 and 2024
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of April 30, 2025

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

## **Note 6. Income Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype defined contribution plan and trust sponsored by Merrill Lynch Pierce Fenner & Smith Inc. This prototype plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 7. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants remain 100% vested in their accounts.

**Note 8. Subsequent Events**

During 2025, Transom Capital Group acquired the Company. There is no impact to the Plan at this time.

Subsequent events have been evaluated through December 12, 2025, which is the date the financial statements were available to be issued.
