**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of Liberty Bank 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

**Opinion**

**Basis for opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). **Responsibilities of management for the financial statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**NOTE 1 - DESCRIPTION OF PLAN**

The following brief description of the Liberty Bank 401(k) Plan (the “Plan”) is provided for general informational purposes only and is not intended to be a complete description of the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering eligible employees of Liberty Bank (the “Bank” or “Employer”). An employee is eligible to become a participant of the Plan on the first day of the month following 90 days of employment, if they are at least 21 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

***Plan Administration***

The Bank and the Charles Schwab Bank (the “Trustee”) administer the Plan.

***SECURE Act***

The Plan has implemented certain requirements by Setting Every Community Up for Retirement Enhancement Act of 2019 and the Securing a Strong Retirement Act of 2022 (together, the “SECURE Act”). Under the SECURE Acts, The Plan implemented changes to allow employees with at least 500 hours of service over three consecutive 12-month periods who have attained age 21 to participate in the Plan and adopted the increase in age for Required Minimum Distributions from 70½ years to 72 years in 2022 and 73 years in 2023 for qualified retirement plans.

***Contributions***

A participant may elect to authorize a pre-tax payroll deduction or after-tax compensation of 1% to 80% of his/her eligible compensation, as defined, as an elective salary deferral contribution to his/her account in the Plan up to the limit prescribed by the Internal Revenue Service (“IRS”) of \$23,000 for the years ended December 31, 2024. Additionally, a participant age 50 or older may be eligible to make a catch-up contribution with maximum limit of \$7,500 for the year ended December 31, 2024. Contributions are allocated among the available investment funds, or self-directed brokerage account, at the direction of the participant. Amounts contributed by the participant are not taxed to the participant for federal and state withholding until a distribution is received from the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

For employees hired prior to January 1, 2015, the Bank matches 100% of the amount of the participant's elective deferral up to a cap of 1% of the participants' eligible compensation plus 75% of the participant's elective deferral in excess of 1% but not in excess of 5%; accordingly, the maximum matching contribution is 4% of the participants' eligible compensation. For employees hired on or after January 1, 2015, the Bank matches 75% of the first 4% of a participant's elective deferral.

***Vesting***

Participants are fully vested with respect to participant contributions and the vesting schedule for the Bank's matching contributions is based on a three-year cliff-vesting schedule (100% vesting upon completing three years of service; no vesting prior to that time).

***Forfeitures***

Forfeitures arising during a plan year are used by the Bank to fund its matching contribution for such plan year and, if any forfeiture remains, for the subsequent plan. Forfeitures of \$67,646 and \$64,131 for 2024 and 2023, respectively, were used to reduce the Bank's contributions. Outstanding forfeiture balances at December 31, 2024 and 2023 were \$66,554 and \$78,443, respectively.

***Payment of Benefits***

Upon retirement from service, a participant who has reached the age of retirement allowed by the Plan, will receive the full value of his/her account, of which the balance can be withdrawn as a lump-sum payment or continued to be maintained with the trustee. The participant can elect to receive annual installments over a period of whole years not to exceed the participant's life expectancy. When a participant is no longer employed by the Bank for any reason other than death, the Plan will make a lump-sum payment if the participant's balance is less than \$1,000 as of the applicable participant's retirement or termination date. Lump-sum payments are composed of total vested cash contributions as of the retirement or termination date, plus earnings. When a participant or former participant dies, the Plan pays the account balance, which is composed of total vested cash contributions plus earnings, to the designated beneficiary. Payment is made as soon as reasonably practicable after notice of death is received.

A participant may apply to the Plan to withdraw amounts from his/her matched and/or unmatched portion of his/her account only in the event of termination of employment, disability, retirement or attainment of age 59 1/9. A participant may request an in-service withdrawal of his/her rollover portion of his/her account, including earnings thereon at any time.

At any time, for hardship reasons, a participant may request to withdraw any amount from the total amount of the participant's contributions and earnings thereon.

***Notes Receivable from Participants***

The Plan allows participants to borrow amounts not to exceed the lesser of (a) \$50,000 reduced by the excess of the highest outstanding balance of loans from the Plan to the participant or beneficiary during the prior one-year period over the outstanding loan balance as of the date such loan is made, or (b) 50% of the vested interest in the participant's account. All loans are considered to be an investment of the borrowing participant's account only and are not considered investments of the Plan for the benefit of other participants. Loans are required to be repaid over not more than five years unless the loan is used to acquire a principal place of residence, in which case the repayment period cannot exceed ten years. A participant may have two loans outstanding at the same time; however, only one loan may be applied for during any Plan year. The interest rate on the loan will be based on the prevailing market interest rate at the time of the loan. Interest rates are set to the Prime rate.

***Plan Termination***

Although the Bank expects to continue the Plan and the contributions to the Plan indefinitely, such continuance is not assumed as a contractual obligation, and in order to protect both participants and the Bank against unforeseen contingencies, the Bank may, by action of its Board of Directors, amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their employer matching contributions and, after payment of all Plan liabilities and expenses, participants are entitled to receive their respective shares of the Plan's net assets.

***Participant Accounts***

A separate account is maintained in the name of each participant reflecting all contributions by the participant, all amounts contributed by the Bank under the Plan on the participant's behalf, interest and dividend earnings and investment gains or losses on all such contributions, and any distributions or withdrawals. The amount of benefit available to each participant at any point in time depends upon the value of the participant's own vested account.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Management's Use of Estimates in the Preparation of Financial Statements***

U.S. GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

***Investments Valuation and Income Recognition***

Investments are reported at fair value, except for the fully benefit-responsive investment contracts which are reported at contract value. Management determines the Plan's valuation policies utilizing information provided by its investment advisors and trustee. Contract value represents contributions made under the contract, plus interest at the contract rate, less withdrawals and administrative expenses. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The difference between the fair value of Plan assets at the beginning of the year, or at the time of purchase during the year, and the fair value of investments at the end of the year, is recorded as net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

***Fair Value Measurements***

The Plan follows the *Fair Value Measurements* topic of the Financial Accounting Standards Board ("FASB") Codification. This topic defines fair value and establishes a framework for measuring fair value in generally accepted accounting principles. It defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (exit price) in principal, or most advantageous market for the asset or liability in an orderly transaction between market participants as of the measurement date. This topic also establishes a fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

Three levels of inputs that may be used to measure fair values:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

When available, quoted market prices are used. In other cases, fair values are based on estimates using present value or other valuation techniques. These techniques involve uncertainties and are significantly affected by the assumptions used and judgments made regarding risk characteristics of various financial instruments, discount rates, estimates of future cash flows, future expected loss experience and other factors. Changes in assumptions could significantly affect these estimates. Derived fair value estimates cannot be substantiated by comparison to independent markets and, in certain cases, could not be realized in an immediate sale of the instrument.

Fair value estimates are based on existing financial instruments without attempting to estimate the value of anticipated future business and the value of assets and liabilities that are not financial instruments. Accordingly, the aggregate fair value amounts presented do not purport to represent the underlying market value of the Plan.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset values ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trusts:* The collective trusts are valued based on the NAV of units of the fund. The NAV, as provided by the trustee, is used as a practical expedient for estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Investments in the collective trusts can be redeemed daily without restriction, have no redemption notification provision or unfunded commitments.

*Self-Directed Brokerage Account:* Valued based on the fair value of the underlying investments, which are carried at fair value based on quoted market prices.

**Benefit Payments**

Benefits are recorded when paid.

***Administrative Expenses***

All costs, fees, and other administrative expenses are paid from the Plan and are allocated to participant accounts in the Plan.

***Investment Fees***

Investment fees are netted against investment income in the accompanying statement of changes in net assets available for benefits.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

***Subsequent Events***

The Plan monitored and evaluated subsequent events for footnote disclosures or adjustments required in its financial statements for year ended December 31, 2024 through October 14, 2025, the date on which the financial statements were available to be issued. No subsequent events were identified that required adjustment to or disclosure to the financial statements.

**NOTE 4 - INVESTMENT AT CONTRACT VALUE (NEW YORK LIFE INSURANCE ANCHOR ACCOUNT IV)**

The Plan has a fully benefit-responsive investment contract with Charles Schwab Trust Bank, which maintains the contributions in a pooled separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The objective of the contract is to provide a low risk, stable investment offering competitive yields, allowing investors to accumulate current income while preserving principal. The contract is included in the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal of all or a portion of their investment at contract value.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Charles Schwab Trust Bank. The plan administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

**NOTE 5 - FEDERAL INCOME TAX STATUS**

The Plan obtained its latest determination letter dated September 21, 2020 in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "Code"). Although the Plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the plan is designed, and is currently being operating, in compliance with the applicable requirements of the Code and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

U.S. GAAP require plan management to evaluate tax position taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the federal taxing authorities. Management evaluated the Plan's tax positions and concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions that require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank and New York Life Insurance Company have certified that the following data included in the financial statements and supplementary schedule is complete and accurate:

- Investments at fair value and contract value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan provides for various types of investment securities. Investment securities are exposed to various market risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

**NOTE 8 - TRANSACTIONS WITH PARTIES-IN-INTEREST AND RELATED PARTIES**

The Plan provides for participant loans. Certain investments are managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee of the Plan assets. These transactions qualify as party-in-interest transactions as defined by ERISA, however they are exempt from prohibited transaction rules.
