### **Opinion**

We have audited the financial statements of Precision Walls, Inc. **Note 1. Description of Plan**

The following description of Precision Walls, Inc. Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

Precision Walls, Inc. (the “Company”) established the Plan effective as of May 1, 2019. The Plan operates as an employee stock ownership plan (“ESOP”) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (the “IRC”) of 1986, as amended and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by the Precision Walls, Inc. ESOP Employee Advisory Committee (the “Committee”) consisting of employees of the Company.

On September 30, 2019, the Plan purchased 1,000,000 shares of common stock from the Company through a loan payable to the Company (see Note 5) and holds the common stock in a trust established under the Plan. The stock was initially purchased at a price of \$3.70 per share, for an aggregate purchase price of \$3,700,000. As the Plan makes debt payments, an appropriate percentage of stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Company. The Company, who sold shares to the ESOP, has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of and for the year ended April 30, 2024, present separately the assets and liabilities, and changes therein pertaining to:

- (A) the accounts of employees with vested and unvested rights in allocated common stock (“allocated”), and
- (B) common stock not yet allocated to employees (“unallocated”).

***Administration of Plan Assets***

The Plan’s assets, which consist principally of Company common shares, are held by the trustee of the Plan. Company contributions are held and managed by the trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

***Eligibility***

Employees of the Company are generally eligible to participate in the Plan after attainment of age 18 and completion of one hour of service. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year. An eligible employee will still receive an allocation of the Company contributions for a plan year if employment is terminated on account of retirement, death, or disability in such year.

***Contributions***

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan’s dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Additional amounts may be contributed at the discretion of the Company’s board of directors. Employee contributions are not permitted.

***Participant Accounts and Forfeitures***

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance less forfeitures and withdrawals made during the plan year to all participants' beginning of the year account balances. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on the proportion that each such participant's compensation for that plan year bears to the compensation of all participants eligible to share in the Company contributions for that plan year. The Plan was amended effective May 1, 2021, to revise the definition of a forfeiture to be any amount credited to a terminated participant's account that is not vested at the time of the participant's termination of employment upon completion of a five-year break in service. During the year ended April 30, 2025, approximately 113 shares of stock were forfeited and reallocated to plan participants.

***Vesting***

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service in the Plan. Participants vest 20 percent after two years of credited service and 20 percent for each additional year of service. A participant is 100 percent vested after six years of credited service.

***Payment of Benefits***

Distributions of benefits will be made in shares of Company stock, cash or a combination of the two. In the event of retirement, total disability or death of a participant, benefits will commence no later than the last day of the plan year following the plan year on which a participant retires, suffers a disability, or dies while employed by the Company. Distributions related to terminations may commence by the end of the sixth plan year following the plan year in which the participant separated from service. Distributions from the Plan shall be made pursuant to a uniform, nondiscriminatory written distribution policy adopted by the Plan administrator, as amended from time to time; provided however, any such policy shall not violate the accrued benefits rule under Section 411(d)(6) of the IRC.

***Plan Termination***

The Company reserves the right to terminate or amend the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Employee Benefits Administration Committee shall direct the trustees to pay all liabilities and expenses of the trust fund and to sell shares of financed stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.

***Administrative Expenses***

As provided in the Plan document, administrative expenses may be paid either by the Plan or by the Company. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

***Voting Rights***

The trustee shall vote all shares of Company stock held by the Plan. Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee shall vote such allocated shares of Company Stock as instructed by participants. Allocated shares for which no direction is received shall be voted by the trustee in its discretion.

***Put Option***

Under Federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the trust buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The trust can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments, which are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Allocations***

The financial statements of the Plan present separately the assets and liabilities, and changes therein pertaining to (a) the accounts of employees with rights in common stock ("allocated"), and (b) common stock not yet allocated to employees ("unallocated"), including Company common stock that is committed to be released.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on the payment date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded upon distribution.

**Note 4. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1**   Observable inputs such as quoted prices in active markets.
- Level 2**   Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3**   Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

**Company Common Stock**

The Company's common stock is valued at the price per share which is calculated based upon a third-party valuation of the fair market value of the Company's common stock. This valuation was based upon the discounted cash flow method to value the Company from an income approach. The income approach is based on the premise that the value of an investment is a function of the income that will be generated by that asset over its expected life. The valuation specialist took into account historical and projected cash flows and net earnings, weighted average cost of capital, and applicable discounts. This income stream can be examined on an historical basis and capitalized to arrive at a value estimate, or it can be projected into the future and discounted to its present value. Since the value of the Company's common stock is not based on observable inputs, it is classified as level 3 within the valuation hierarchy.

Level 3 assets are measured at fair value on a recurring basis for year ended April 30, 2025. There were no purchases and no transfers in or out of Level 3 assets for the year ended April 30, 2025.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Loan Payable**

On September 30, 2019, the Plan entered into a \$3,700,000 loan agreement with the Company to purchase 1,000,000 shares of Company stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as annual principal payments plus interest at 2.21% per annum are made. The number of shares released in any year is the number of shares held as collateral, multiplied by the ratio of the current-year principal payments divided by (1) the total of the current-year principal and interest payments plus (2) all future years' principal and interest payments. This resulted in a total of 31,959 shares being released and allocated for the year ended April 30, 2025.

The agreement provides for the loan to be repaid over 40 years beginning September 30, 2019. The fair value of the loan as of April 30, 2025, and 2024, was approximately \$2,670,000 and \$2,750,000, respectively, determined by using interest rates currently available for issuance of debt with similar terms, maturity dates, and nonperformance risk.

**Note 6. Employer Contributions**

The Company contributed \$1,740,850 to the Plan for the year ended April 30, 2025.

**Note 7. Related Party and Exempt Party-in-Interest Transactions**

The Plan invests in the Company's common stock and has indebtedness guaranteed by the Company. These are related party and party in interest transactions under ERISA.

**Note 8. Tax Status**

The Internal Revenue Service (the "IRS") has determined and informed the Company by letter dated July 7, 2021, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the "IRC"). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
