Opinion

We have audited the accompanying financial statements of Benson Integrated Marketing Solutions Group Medical Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and statements of benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and statement of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

NOTE 1. PLAN DESCRIPTION

The following description of the Benson Integrated Marketing Solutions Group Medical Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The Benson Integrated Marketing Solutions Group Medical Plan is a Taxable ERISA Trust (the Trust) and is a single-employer plan. The Trust is funded by a trust agreement established to comply with the Employee Retirement Income Security Act of 1974 (ERISA), which governs the operation and administration of employee benefit plans.

The Plan, established January 1, 2024, provides health (medical, hospital, surgical, major medical) and drug benefits to full time employees of Benson Integrated Marketing Solutions, Inc. (the Company) who regularly work at least 30 a week and to the eligible dependents of such employees. Employees are eligible for benefits after 30 days from the first day the employee reports for employment. Benefits begin on the first day of the month following the completion of the 30-day waiting period. Part-time, temporary, leased, seasonal, and independent contractors are not eligible to receive benefits.

Benefits

The Plan is a self-insured plan. The claims for self-insured benefits are processed by the Plan's third-party claims processors under an administrative service only arrangement. The claims processor pays claims directly to or on behalf of participants and are then reimbursed by either the Plan's trust, or the general assets of the Company. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits

Premium payments paid by the Company are recorded as premiums paid in the Statement of Changes in Net Assets Available for Benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payable to claims administrator in the Statements of Net Assets Available for Benefits.

Stop-Loss Coverage

For the year ended December 31, 2024, premiums of \$351,333 for stop-loss coverage are included in employer contributions and premiums paid in the Statement of Changes of Net Assets Available for Benefits as these premiums are paid by the Company. For the year ended December 31, 2024, stop-loss refunds of \$18,480 were netted against claims paid in the Statement of Changes of Net Assets Available for Benefits.

Refunds

Refunds due from the Plan's pharmacy benefit manager are recorded when earned. Refunds due as of the financial statement date are reported as a receivable. For the year ended December 31, 2024, the Plan's rebates were \$44,518, which are netted against claims paid in the Statement of Changes in Net Assets Available for Benefits.

Benefit Obligations

The Plan has calculated its estimate of benefit obligations using subsequent period claims history and other relevant information provided by the third-party administrator. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Subsequent Events

The Plan has evaluated subsequent events through December 15, 2025, the date the financial statements were available to be issued, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.

NOTE 3. CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at December 31, 2024, for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment. At December 31, 2024, claims incurred but not reported were \$79,749.

NOTE 4. TAX STATUS

The Plan's assets are held in a Trust (the Trust) which is non-qualified for tax exemption under Section 501(c)(9) of the Internal Revenue Code (IRC). Accordingly, the Trust's net investment income is subject to federal and state income taxation.

The Trust has not received a favorable determination letter from the Internal Revenue Service. However, Plan management believes the Plan is currently designed and operated in compliance with applicable IRC requirements.

The Plan accounts for uncertainties in income tax law in accordance with FASB ASC 740, Income Taxes. As of December 31, 2024, the Plan has no unrelated business income and has not recognized any uncertain tax positions, as all positions are considered more likely than not to be sustained upon settlement. The Plan is subject to routine audits by tax authorities; however, there are no current audits in progress.

NOTE 5. CONCENTRATIONS OF CREDIT RISK

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of cash accounts with various banks. The Plan's deposit accounts are insured by the Federal Deposit Insurance Corporation up to \$250,000 per banking institution at December 31, 2024. At December 31, 2024, the Plan had no uninsured balances.

NOTE 6. RISKS AND UNCERTAINTIES

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 7. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has arrangements with service providers, including Meritain Health (Meritain) for medical and pharmacy claims processing and Benecon Group, LLC (Benecon) for third-party administrator and benefits consortium services. These transactions are party-in-interest transactions under ERISA. For the year ended December 31, 2024, fees paid for these services were \$135,396. This amount is included in employer contributions and administrative expenses on the Statement of Changes in Net Assets Available for Benefits.

NOTE 8. PLAN TERMINATION

Although it has not expressed any intention to do so, the employer has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the employer or be used for purposes other than for the exclusive benefit of the Plan's participants.
