### Report on the Financial Statements

#### *Opinion*

We have audited the accompanying financial statements of Relief Enterprises, Inc. Health & Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statements of net assets available for benefits and of Plan's benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and of changes in Plan's benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.



**NOTE 1 DESCRIPTION OF PLAN**

The following description of Relief Enterprises, Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan and Trust were established July 1, 2001 to provide health and other benefits to eligible participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Eligibility**

Employees of Relief Enterprises, Inc. (the Company) are eligible to participate in the Plan on the first day of the month following one month of continuous employment.

Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

**Contributions**

The Company makes contributions for participating employees covered under the Plan. For employees covered under contracts issued by Federal, State, municipal or other contracting authorities which require the payment of specified fringe dollar amounts, the Company contributes to the Plan based upon an hourly funding formula. Employer contributions are recognized as income in the month the employees worked. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. In addition to deductibles and copayments, participants may contribute specified amounts to extend coverage to their eligible dependents.

**Benefits**

The Plan provides medical, dental, vision, prescription drug coverage, life, accidental death and dismemberment, supplemental accident, short term disability and dismissal wage/unemployment benefits for eligible participants and their beneficiaries. The Plan provides medical, prescription, vision, life, accident and employee assistance program through various contracts with insurance companies. The Plan purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid to the insurance company directly from the assets of the Plan. The Plan provides medical and prescription drug coverage, dental, and short-term disability on a self-funded basis. The Plan also carries a stop-loss insurance policy which covers both specific and aggregate claims in excess of the deductibles as specified in the contract.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Health Reimbursement Arrangement**

The Plan provides a health reimbursement arrangement (HRA) that is funded solely through Company contributions. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. Amounts remaining as of March 31 each year are forfeited. The Employer is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical expenses; and remaining amounts are not portable upon termination once the employee leaves the Employer. Included in the accompanying statements of Net Assets are amounts available to reimburse participants for qualifying medical expenses as of December 31, 2024 and 2023 totaling \$78,843 and \$101,449, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Concentration of Credit Risk**

The Plan's cash balances are held at three financial institutions located in California. Accounts at these institutions are insured by a government agency up to \$250,000. At times, the balance in these accounts may exceed the insured limit.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Interest income is recorded on the accrual basis.

**Contributions Receivable**

Employer contributions due but not paid at year-end are recorded as contributions receivable. See Note 3.

**Prescription Rebates**

Prescription rebates are recorded when earned, with the offset being netted against prescription claims paid. Prescription rebates totaling \$120,570 and \$103,313 for the years ended December 31, 2024 and 2023, are included in Other Receivables in the accompany statements of net assets available for benefits.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Payment of Benefits**

Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Benefits are recorded when paid. Amounts due to claims administrators' that have yet to be reimbursed by the Plan are recorded as benefit claims payable in the accompanying statements of Plan's benefit obligations.

**Insurance Premiums Payable**

Insurance premiums payable are based upon the actual premiums due for December 31, 2024 and 2023, but paid by the Plan after year-end.

**Benefit Claims Incurred But Not Reported**

The obligations for benefit claims incurred but not reported is an estimate for self-funded benefits incurred on or prior to December 31, 2024 and 2023, but reported to and paid by the Plan after year-end. The estimates were calculated based on the funding factor as noted in the insurance contract, with a maximum exposure limit. The funding factor contains certain assumptions pertaining to claims lag and historical claims data.

**Administrative Expenses**

All administrative expenses may be paid out of the Plan unless paid by the Company. During the year ended December 31, 2024, the Plan paid for substantially all administrative expenses, which consisted of administration fees, broker fees, trustee fees, accounting fees, and other miscellaneous expenses.

**Income Taxes**

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes. The Plan is required to pay federal and state taxes on unrelated business income as defined by Internal Revenue Code (IRC) Section 512(e)(3)(E). Unrelated business income consists of the investment income earned on the excess of the net assets available for benefits over the required reserve balance allowable under the IRC. The Plan administrator believes the Plan does not have any net taxable income for the years ended December 31, 2024 and 2023, therefore, no tax liability is reflected in these financial statements.

**Subsequent Events**

The Plan has evaluated subsequent events through December 3, 2025, the date the financial statements were available to be issued.

During the Plan years ended December 31, 2024 and 2023, the Plan recovered contributions previously allowed for of \$57,365 and \$24,192, respectively. The Company has made payments of contributions necessary to fund the ongoing operations of the Plan.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Interest-bearing Cash* – Valued at cost, which approximates fair value.

**NOTE 5 TAX STATUS**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service (IRS). The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 PLAN TERMINATION**

The Plan shall remain in existence from year-to-year unless written termination notice is given by the Plan management or Plan administrator to the other at least 60 days prior to the anniversary date of effective coverage under the Plan.

**NOTE 6 PLAN TERMINATION (CONTINUED)**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE 7 EXCESS LOSS COVERAGE**

The Plan has entered into an excess loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The Plan maintained an insurance policy with Fidelity Security Life Insurance Company. The policies provide reimbursement to the Plan for claim amounts paid in excess of the monthly funding factor for each participant. There is no limit on the maximum eligible claim expense per covered person under the policy. The insurance company is responsible for paying claims incurred in excess of the funding factor account balance, which was \$(249,978) and \$(5,026) at December 31, 2024 and 2023, respectively.

The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants from Plan assets and the Plan is subsequently reimbursed by the insurance company if the funding factor is exceeded. During the year ended December 31, 2024, there were reimbursements from the insurance company in the amount of \$619,613. There were reimbursements due from the insurance carrier of \$249,978 and \$5,026 as of December 31, 2024 and 2023, respectively.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

The estimate for claims incurred but not reported is based on certain assumptions pertaining to claims lag and historical claims data. The liability recorded is the Plan's maximum exposure to the claims incurred but not reported. Should the Plan's claims totals be lower than the amount deposited into the funding factor account, the Plan may be entitled to receive a refund from the insurance company. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
