The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Specialists Hospital Shreveport, LLC 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Specialists Hospital Shreveport, LLC 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Supplemental Schedules Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of Schedule H, Line 4i (assets held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) **Description of the Plan**

The following description of the Specialists Hospital of Shreveport, LLC (the “Company”) 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a tax-qualified defined contribution plan under Section 401(a) of the Internal Revenue Code of 1986, as amended, which provides retirement, disability and death benefits for eligible employees of the Company. To attain eligibility, employees must be age twenty-one (21), and must have completed one year of service, as defined by the Plan. The Plan is subject to various provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The plan as herein discussed is effective as of January 1, 2022.

**Contributions and Allocations**

Each year, eligible participants may contribute up to one-hundred percent (100%) of their pretax annual compensation (“eligible compensation” as defined under the Plan), not to exceed maximum annual contribution limits established by the Federal Government. The annual elective deferral limitations for 2024 and 2023 totaled \$23,000 and \$22,500, respectively. In addition, during the year which a participant attains age fifty (50) and in subsequent years, the participant may elect to make additional, pretax “catch up” contributions. Maximum catch-up contributions for 2024 and 2023 totaled \$7,500.

Participants may also designate all or a portion of their elective deferral contributions as Roth elective deferrals.

Participants direct the investment of their contributions into various options offered by the Plan.

A safe harbor non-elective contribution by the Company is discretionary for each plan year. Safe harbor non-elective contributions shall be equal to three percent (3%) of a participant’s compensation, as defined by the Plan. Eligible participants do not need to satisfy any eligibility requirements, beyond those outlined above, to be eligible to receive a safe harbor non-elective contribution. Safe harbor non-elective contributions totaled \$456,800 for the year ended December 31, 2024.

The Company may make non-safe harbor non-elective contributions to the plan. The amount of the Company’s non-safe harbor non-elective contribution is discretionary on the part of the Company. To be eligible to receive a non-safe harbor non-elective contribution, participants who terminate service during the Plan year for any reason, must be credited with at least one (1) hour of service during the allocation period. All other eligible participants do not need to satisfy any eligibility requirements, beyond those outlined above, to be eligible to receive a non-elective contribution. There were no non-safe harbor non-elective contributions for the year ended December 31, 2024.

(1) **Description of the Plan (cont.)**

Rollover contributions are permitted by the Plan. Rollover contributions remain in segregated rollover accounts and are always one hundred percent (100%) vested. Rollover contributions may be withdrawn by the participant at any time.

Voluntary employee contributions to the Plan are not allowed.

***Participant Accounts***

Under the Plan, elective deferrals made by participants and any employer contributions are placed into investment accounts, as directed by the participant, which are then credited with gains and losses at each valuation date. Valuation is performed daily. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

***Vesting***

Under the Plan, participants are immediately one-hundred percent (100%) vested in their elective deferral contributions and safe harbor non-elective contributions plus actual earnings thereon. Participants are vested in the Company's non-safe harbor non-elective contribution portion of their accounts plus actual earnings thereon based on years of continuous service. All participants are fully vested after completing at least six (6) years of service.

The vesting schedule for non-safe harbor non-elective employer contributions (also applies for top-heavy plan years) is as follows:

Completed Years of Service	Percentage Vested
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

***Notes Receivable from Participants***

Active employees, former employees who qualify as a party-in-interest, and the beneficiaries of deceased active or former employees may borrow, from their fund accounts, a minimum of \$1,000 up to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. Participants may not have more than two (2) outstanding loans at a time.

Loans must be secured with an irrevocable pledge and assignment of the participant's vested interest in his or her account. No more than fifty percent (50%) of the balance in the participant's account may be considered by the Plan as security.

Loans bear interest at a reasonable fixed rate established by the Plan Administrator. This rate is set at one percentage point higher than the prime lending rate when the loan is made.

Principal and interest is paid ratably as of each payroll withholding period by the participant, typically through payroll deductions. If the applicant is not an active employee, loan payments

(1) **Description of the Plan (cont.)**

are paid directly by the applicant, at least quarterly. Loan repayment periods may not exceed five (5) years.

The Plan allows for existing loans to be refinanced, provided certain conditions are met, as outlined in the Plan's loan policy.

***Payment of Benefits***

On termination of service for any reason, if a participant's vested interest in his or her account is one thousand dollars (\$1,000) or less, it will be distributed in a lump sum. Participants may also elect to roll their account balance over to another qualified retirement plan or to an individual retirement account (IRA.)

On termination of service for any reason other than death, if a participant's vested interest in his or her account is more than one thousand dollars (\$1,000), they may elect to have the balance distributed in a lump sum or as partial payments in amounts of their choosing.

On termination of service due to death, distributions from the Plan are dependent upon several factors including whether the participant has attained their minimum distribution requirement date and information regarding the beneficiary listed on their account. Generally, a participant's account will be distributed as a lump sum.

In-service distributions are permitted by the Plan if a participant has attained age fifty-nine and one-half (59 ½) and is one-hundred percent (100%) vested in the account from which the distribution is made.

Hardship distributions are permitted by the Plan, provided the participant provides documentation demonstrating the existence of a hardship event, as defined by the Plan.

***Forfeited Accounts***

Forfeitures are amounts which cannot be paid to terminated participants because they were not one hundred percent (100%) vested upon separation from service with the Company. Forfeitures of company contributions will be used to pay plan expenses and supplement employer contributions. The Plan, as of December 31, 2024 had forfeited non-vested account balances totaling \$36,220 and forfeited non-vested account balances of \$26,411 as of December 31, 2023. During the plan year ended December 31, 2024, the Plan did not use any forfeitures to pay plan expenses or supplement employer contributions.

(2) **Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

(2) **Summary of Significant Accounting Policies (cont.)**

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits at the date of the financial statements and the changes in net assets available for Plan benefits during the reporting period and, when applicable, the disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Net appreciation (depreciation) in the fair value of Plan assets reflected in the Plan's statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of investments are recorded on a trade-date basis. Interest income, including interest earned on notes receivable from participants, is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Loan defaults are considered to have occurred if any scheduled payment remains unpaid as of the end of the last day of the calendar quarter following the calendar quarter in which the required payment was due.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Although not required, the Company, as Plan Sponsor, may pay the related costs of administering the Plan. Expenses paid by the Company on behalf of the Plan are not reflected in the financial statements of the Plan.

(3) **Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 - inputs to the valuation methodology include the following:
  - Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market accounts:* Valued at cost which approximates fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed Brokerage Accounts:* Consists of cash and money market accounts valued at cost which approximates fair value and mutual funds and exchange traded funds valued at NAV of shares held at year end. The mutual and exchange traded funds held in these accounts are deemed to be actively traded.

**(4) Transactions with Parties in Interest**

Certain plan investments include interest in insured savings accounts managed by Morgan Stanley. Morgan Stanley serves as custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Additionally, the plan issues loans to participants, which are secured by the vested balances in the participants' accounts and the Plan sponsor, Specialists Hospital Shreveport, LLC, provides certain accounting and administrative services for which no fees are charged. These transactions qualify as party-in-interest transactions.

**(5) Plan Amendment or Termination**

The Company has reserved the right to terminate the plan or reduce or cease contributions at its discretion or to amend the plan at any time and in any respect. However, no amendment can reduce benefits already earned by the participants. In the event of termination, participants are entitled to the full amount in their account as of the date of termination, regardless of the percent vested at the time of termination.

**(6) Tax Status**

On December 10, 2020, the Internal Revenue Service stated that the Plan, as then designed, qualified under Internal Revenue Code (IRC) Section 401(a). The Plan has been amended since receiving the original determination letter. However, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the plan's financial statements.

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.

(8) **Subsequent Events**

The Plan Administrator has evaluated all events or transactions that occurred after December 31, 2024 through November 14, 2025, which is the date the financial statements were available to be issued. During this period there were no material subsequent events requiring disclosure.
