Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SFMB Management, LLC Cash Balance Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SFMB Management, LLC Cash Balance Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A- DESCRIPTION OF PLAN

The following description of the SFMB Management, LLC Cash Balance Pension Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The terms "Company" and "Plan" shall refer to SFMB Management, LLC, and the Cash Balance Pension Plan, respectively.

General:

The Plan is a cash balance defined benefit pension plan providing retirement, disability, and death benefits to all eligible employees. The plan sponsor is SFMB Management, LLC (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan includes all full-time employees who have completed one year of service, beginning on the date of hire and are age twenty-one years or older. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee oversees governance of the Plan's investments, monitors investment performance, and reports to the Plan's Board of Trustees.

On April 1, 2021, the Company elected to freeze the Cash Balance Pension Plan. As part of this "freezing" amendment, no employees may commence initial participation in the Plan on or after April 21, 2021. In addition, compensation pay credits as described below, were reduced to zero during the Plan's frozen status. Also, effective January 1, 2021, any Top-Heavy minimum will be provided under the SFMB Management, LLC 401(k) Savings Plan.

Participant's Accounts:

Under the Plan provisions, amounts are credited by the Company to the participants' hypothetical accounts. The accounts are allocated compensation credits and interest credits on an annual basis.

The retirement benefit is the actuarial equivalent of the hypothetical account balance derived from annual Pay Credit and Interest Credits (but not less than the Top-Heavy defined benefit minimum benefit).

As noted above, the Company elected to freeze the Plan, and no compensation pay credits were allocated during 2024 and 2023.

Participants' hypothetical accounts receive Interest Credits, at the end of each year. The applicable Interest Credits are the lesser of 5% or the 30-year Treasury rate for December of the previous plan year, but not less than 3.5%.

NOTE A- DESCRIPTION OF PLAN (CONTINUED)

Funding Policy:

Every pension plan must have a procedure for establishing a funding policy for plan objectives. A funding policy relates to how much money is needed to pay promised benefits. The funding policy of the Plan is that the Company will periodically contribute amounts at least equal to the amounts required to meet the minimum funding standards of ERISA. As of December 31, 2024 and 2023, the Plan Actuary determined that the Company's minimum required funding contribution was \$46,304 and \$87,353, respectively.

Pension plans also have investment policies. These generally are written guidelines or general instructions for making investment management decisions. The investment policy of the Plan is designed to achieve a long-term rate of return sufficient to meet the actuarial requirements of the Plan. The Company intends to realize its return objectives by investing in a diversified portfolio of equity, fixed income, and money market instruments that will provide a balance of current income and capital appreciation while maintaining adequate liquidity for future benefit payments.

Pension Benefits:

Benefits are determined based on the participant's hypothetical account balance. Plan participants are eligible for their plan benefit after terminating employment with vested rights. Participants become vested in the Plan upon completion of 3 or more years of service or attainment of the later of age 65 or the fifth anniversary of the first day of the plan year in which the employee commenced participation in the Plan. If employees terminate before rendering 3 years of service, they forfeit the right to receive the portion of their accumulated plan benefits attributable to the Company's contributions. Upon termination of employment, participants have the option of receiving their vested benefit in various optional forms.

Death and Disability Benefits:

If an active employee dies or becomes disabled, a benefit equal to the value of the employee's accumulated benefit is paid on behalf of the participant.

NOTE B- SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting:

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Accordingly, actual results may differ from those estimates.

NOTE B- SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisors, custodians, and the insurance company. See Note E for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits:

Benefit payments to participants are recorded upon distribution.

Administrative Expenses:

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value investments presented in the accompanying statement of changes in net assets available for benefits.

NOTE C - ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service that employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are accumulated based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances-retirement, death, disability, and termination of employment-are included, to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits.

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan

benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in

the valuation as of January 1, 2024, and January 1, 2023 were (a) life expectancy of participants (the RP 2014 combined Mortality table for males and females, projected to 2024 was used), (b) retirement age assumptions (the assumed average retirement age was 65), and (c) investment return. The effective interest rates used to discount the obligation for 2024 and 2023 were 4.15% and 3.66%, respectively.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024 and January 1, 2023. Had the valuations been performed as of December 31, the plan actuary estimates the present value to be \$4,445,062.

NOTE D- PLAN TERMINATION

The Company has the right under the Plan to discontinue its contribution at any time and terminate the Plan subject to the provisions of ERISA. Should the Plan terminate at some future time, its net assets generally will not be available on a pro rata basis to provide participants' benefits. Whether a particular participant's accumulated plan benefits will be paid depends on both the priority of those benefits and the level of benefits guaranteed by the Pension Benefit Guarantee Corporation ("PBGC") at that time. Some benefits may be fully or partially provided by the then existing assets and the PBGC guaranty while other benefits may not be provided for at all.

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.
2. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.
3. All other vested benefits (that is, vested benefits not insured by the PBGC).
4. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

NOTE E- FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE E- FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2- Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued based on underlying investments which have quoted market prices in exchange and active markets, which represent the net asset values of shares held by the Plan at year end and are classified as Level 2.

NOTE F- RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term, would be material to the financial statements.

NOTE G- PLAN AMENDMENT

On April 21, 2021, the Company elected to freeze the Cash Balance Pension Plan. As part of this “freezing” amendment, no employees may commence initial participation in the Plan on or after April 21, 2021. In addition, compensation pay credits described in Note A, were reduced to zero during the Plan’s frozen status. Also, effective January 1, 2021, any Top-Heavy minimum will be provided under the SFMB Management, LLC 401(k) Savings Plan. These amendments were recognized and included with the January 1, 2024 and January 1, 2023, actuarial valuations.

NOTE H- TAX STATUS

The Plan obtained its latest opinion letter on March 30, 2018, in which the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan was amended under the terms of the current opinion letter, and the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE I- PARTY IN INTEREST TRANSACTIONS

The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA. In addition, certain plan investments are managed by Empower Retirement, LLC (“Empower”). As Empower is the Custodian for the Plan, these transactions also qualify as party-in-interest transactions. Empower acquired the retirement business of Massachusetts Mutual Life Insurance Company (“Mass Mutual”) on December 31, 2020. As of December 31, 2024 and 2023, Empower certified the data summarized in Note J below.

NOTE J- INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Retirement, LLC has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate:

- Total investments, at fair value, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Total investment income, including net appreciation/depreciation in fair value of investments, as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024;
- The Schedule of Assets (Held at End of Year) at December 31, 2024 as shown in the supplemental schedule;

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

NOTE K - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through November 25, 2025, the date the financial statements were available to be issued. On April 25, 2025, the plan sponsor agreed to terminate the Plan with an effective date of June 30, 2025.

NOTE L – REISSUED FINANCIAL STATEMENTS

The accompanying financial statements were originally issued on August 18, 2025. These financial statements have been reissued on November 25, 2025 solely to update supplemental schedule of assets (held at end of year), including cost of investments. No changes were made to the amounts reported in the previously issued financial statements, and the reissuance did not affect the Company's financial position, results of operations, or cash flows for any period presented.
