We have performed an audit of the financial statements of MWW Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### 1. Description of the Plan

The following description of the MWW Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary Plan description for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of MWW Group LLC (the Company or Employer) and its affiliate, Stone America Licensing, LLC, who are aged 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Fidelity Management Trust Company (Fidelity) is the recordkeeper and trustee of the Plan.

#### *Contributions*

Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan, through a salary reduction, up to the maximum amount permitted by the Internal Revenue Service (IRS). Contributions may be made to the Plan on a pre-tax and/or after-tax Roth basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Plan allows discretionary employer matching and nonelective employer contributions. For 2024, the annual discretionary employer matching contributions of \$142,539 was based on a 12.5% match of the employee deferrals made in 2023, for employees who were actively employed as of September 21, 2024. There were no nonelective employer contributions made in 2024.

#### *Participant Accounts*

The Plan maintains individual accounts for each Plan participant. Each participant's account is credited with the participant's contributions; an allocation of the employer contributions; an allocation of the Plan's investment earnings or losses; and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Investment Options*

Participants direct the investment of participant contributions in any of the investment options offered by the Plan.

### ***Vesting***

Participants are immediately vested in their salary deferral and rollover, plus actual earnings thereon. Vesting in the employer matching contributions and nonelective employer contributions, plus actual earnings thereon, is as follows:

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with current rates charged for similar loans made by local commercial banks, as determined by the Plan administrator. Interest rates on outstanding loans ranged from 3.25% to 8.50%. Principal and interest are paid ratably through semi-monthly payroll deductions.

### ***Payment of Benefits***

Participants are eligible to receive distributions from their accounts at the normal retirement age (age 65), disability, death, or termination of employment. Withdrawals from deferral contributions sub-account may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan, as well as at age 59½ if certain criteria are met. Participants receive the value of their vested account balance in the form of a single-sum payment or partial withdrawals. Participants may elect to rollover their vested balance to another qualified retirement plan or individual retirement arrangement. Accounts \$1,000 or less will be distributed lump-sum directly to the participant or rolled to an individual retirement account (IRA) or to another retirement plan.

### ***Forfeitures***

If a participant leaves employment before becoming fully vested, any non-vested employer contributions and related investment earnings thereon are forfeited. These forfeitures are used to reduce any employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$56,768 and \$36,250, respectively. No forfeitures were used to reduce employer contributions or plan expenses in 2024.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### *Contributions Receivable*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Matching contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### 3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - This level consists of inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are actively traded.

*Money Market Fund* - Valued at the daily closing price as reported by the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Tax Status

The Plan uses a pre-approved plan document sponsored by FMR LLC. FMR LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Plan management believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

## 6. Related Party and Party-in-Interest Transactions

Certain investments are managed by Fidelity. The transactions related to these investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules under ERISA. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments. Participant loan and distribution processing fees of \$606 are paid to Fidelity by participants. Notes receivable from participants also qualify as party-in-interest transactions.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances, and the amounts reported in the statements of net assets available for benefits.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their accounts.

### 9. Late Remittances

During the Plan years ended December 31, 2021 and 2022, employee withholdings in the amount of \$2,527 and \$3,413, respectively, were not remitted within the appropriate time period. These transactions constitute prohibited transactions, as defined by ERISA. The Company has taken correction action to make participant accounts whole and earnings are restored in 2024.

### 10. Operational Compliance

During 2021, the Company identified an operational failure of late remittances. The Company has restored lost earnings in 2024. The Plan's ERISA counsel is in the process of preparing a Voluntary Fiduciary Correction Program (VFCP) to the Department of Labor (DOL) to address the Plan's late remittances for the 2021 Plan year.

During 2021, the Company identified an operational failure in connection with distributions with two participants. It appears that two participants, who were not fully vested, when they terminated in 2009 and 2013 took full distributions of their plan accounts in 2022. The Company will correct any overpayments due to the improper calculation of vesting service in accordance with IRS guidance, by distributing an appropriate notice to the affected participants and contributing the overpayment amounts, adjusted for earnings, to the Plan. ERISA counsel has advised the Company that this issue can be corrected under the IRS's Self-Correction Program (SCP). This operational error remains open as of the date the financial statements are available to be issued.

During 2021, the Company identified an operational failure in connection with the deferral election for some participants. The Company is working with ERISA counsel, to correct the 2021 elective deferral failures by calculating and depositing appropriate Corrective Qualified Non-elective Contributions, missed matching contributions, and earnings, in accordance with IRS guidance. ERISA Counsel has advised the Company that this issue can be corrected under the IRS's SCP. In March 2024, the Company, in conjunction with the advice of ERISA counsel, corrected this 2021 operational error in compliance with IRS guidelines.

During 2022, the Company identified an operational failure of late remittances. The Company has restored lost earnings in 2024. The Plan's ERISA counsel is in the process of preparing a VFCP to the DOL to address the Plan's late remittances for the 2022 Plan year.

During 2023, the Company identified an operational failure of late remittances. The actual amount of late remittances is not yet determined. The Plan's ERISA counsel is in the process of preparing a VFCP to the DOL to address the Plan's late remittances for the 2023 Plan year. In addition, ERISA counsel is also working with the Company to review their 2023 payroll records and reconcile any differences in the deferral and loan repayment amounts remitted to the Plan for the 2023 Plan year. If it is determined that the Company did not make sufficient contributions to the Plan, ERISA counsel will advise the Company on how to correct the issue and include it in the VFCP application or under the SCP.

The Company and the Company's ERISA counsel believe that correction of the above matters will not have an adverse impact on the Plan's qualified tax status.

### **11. Subsequent Events**

The Plan has evaluated subsequent events through December 12, 2025, which is the date the financial statements were available to be issued. There were no subsequent events requiring adjustments to the financial statements or disclosures as stated herein.
