## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Cantaloupe, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cantaloupe, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of June 30, 2025 and 2024 and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

#### 1. DESCRIPTION OF PLAN

The following description of the Cantaloupe, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**—The Plan is a defined contribution plan that was established effective July 1, 1997 covering all eligible employees of Cantaloupe, Inc. (the “Plan Sponsor”). Effective April 2025, John Hancock Trust Company LLC became the trustee of the Plan.

There is no age or service requirements to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

**Plan amendments**—Effective May 2025, the Plan was amended to allow distributions of participants who have attained age 59 1/2, to the extent vested, whether or not they are still employed by the Plan Sponsor.

**Plan merger**—Cheq Lifestyle Technology 401(K) Plan (“Cheq Plan”) merged into the Plan effective April 2025. As a result, Cheq Plan’s net assets available for benefits of \$314,073 transferred into the Plan for the year ended June 30, 2025.

**Contributions**—Employees may enroll in the Plan at any time. Participants in the Plan may change their deferral percentage at any time. Participants may contribute up to 100 percent of their eligible compensation, as defined by the Plan. These deferrals may be made as either pretax or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment elections daily.

As a safe harbor plan, the Plan Sponsor is required to contribute safe harbor matching contributions. The safe harbor matching contribution is equal to 100 percent of the participant’s contribution up to the first three percent of compensation and 50 percent of the next two percent of compensation. The Plan Sponsor may contribute a discretionary matching contribution or a discretionary profit-sharing contribution to the Plan. The matching or profit-sharing contributions may be established at any level or omitted if so chosen. There were no discretionary contributions made by the Plan Sponsor for the year ended June 30, 2025. Employee and employer contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

**Participant accounts**—Each participant’s account is credited with the participant’s contributions and the Plan Sponsor’s contributions (safe harbor matching, discretionary matching, and discretionary profit sharing), as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**—Participants are vested immediately in their contributions and the Plan Sponsor’s safe harbor matching contributions plus actual earnings thereon. A participant is 100 percent vested in the Plan

Sponsor's discretionary matching and discretionary profit-sharing contributions after one year of credited service.

**Benefits paid to participants**—The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased, as defined by the Plan. In-service withdrawals are also permitted for certain financial hardships. Benefits are payable in lump sum or installment payments with certain exceptions allowed.

**Forfeitures**—Forfeitures resulting from the non-vested portion of the Plan Sponsor's discretionary contributions shall be used to restore account balances, pay Plan expenses, or reduce future Plan Sponsor contributions. There was no forfeiture balance as of June 30, 2025 and 2024, nor were any forfeitures used during the year ended June 30, 2025.

**Notes receivable from participants**—Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a fixed interest at prime plus 1 percent as of the date of origination. There is no maximum number of loans. Payments (principal and interest) are made through payroll deduction from each regular paycheck over a period of 5 years or less, with the exception of loans to purchase a primary residence, which may have a longer term.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting**—The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of estimates**—The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition**—Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan's management deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of both June 30, 2025 and 2024.

**Benefits paid to participants**—Benefits are recorded when paid. There were no participants, who elected to withdraw from the Plan, but had not yet been paid at June 30, 2025 and 2024, respectively.

**Administrative Expenses**—Certain expenses incurred for administering the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses, include fees related to the administration of the Plan, are charged directly to participant’s accounts. Investment-related expenses are included as a reduction of the return earned in net appreciation in the fair value of investments. Participants also pay administrative costs for loans, distributions and qualified domestic relation orders.

**Excess Contributions Payable**—The Plan is required to return contributions received during the Plan year in excess of the Internal Revenue Code of 1986 (“IRC”) limits. There were no excess contributions due to participants as of June 30, 2025 and 2024.

### 3. CERTIFIED INVESTMENT INFORMATION

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year), including investments and notes receivable from participants held at June 30, 2025 and 2024, were prepared by John Hancock Trust Company LLC and John Hancock Life Insurance Company (U.S.A.), respectively, and furnished to the Plan administrator. Net appreciation in the fair value of investments and interest income on notes receivable from participants for the period from April 2, 2025 to June 30, 2025 and for the period from July 1, 2024 to April 1, 2025, were prepared by John Hancock Trust Company LLC and John Hancock Life Insurance Company (U.S.A.), respectively, and furnished to the Plan administrator. The Plan administrator has obtained certifications from John Hancock Trust Company LLC and John Hancock Life Insurance Company (U.S.A.) that such information is complete and accurate.

### 4. FAIR VALUE MEASUREMENTS

Accounting Standard Codification 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded and therefore classified as level 1 in the fair value hierarchy. The fair value of mutual funds as of June 30, 2025 is \$26,459,066.

**Stable Value fund:** A collective trust fund that is composed primarily of fully benefit-investment contracts that is valued at the NAV of units of the collective trust in the account held by the Plan at year-end. The NAV is not a public-quoted price in an active market. The NAV, as provided by John Hancock Trust Company LLC, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities.

This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. In accordance with GAAP, the stable value fund using NAV as the practical expedient to measure fair value has not been classified in the fair value hierarchy. The fair value of the stable value fund as of June 30, 2025 is \$296,743.

**Pooled separate accounts:** Valued based on the NAV per share held by the Plan at year-end. The NAV was determined by John Hancock Life Insurance Company (U.S.A.) and not publicly quoted. The NAV was primarily based on the quoted market prices of the underlying investments held in the account and was adjusted for liabilities and fees. The NAV per share was used as the practical expedient to estimate fair value. In accordance with GAAP, the pooled separate accounts using NAV as the practical expedient to measure fair value have not been classified in the fair value hierarchy. The pooled separate accounts held as of June 30, 2024 were liquidated during 2025. The fair value of the pooled separate accounts as of June 30, 2024 was \$18,620,952.

#### 5. FEDERAL INCOME TAX STATUS

Effective July 1, 2021, the Plan has adopted a non-standardized pre-approved profit-sharing plan that received an opinion letter from the IRS dated June 30, 2020, which states that the document satisfies the applicable provisions of the IRC.

Although the non-standardized pre-approved profit-sharing plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan itself has not received a determination letter from the IRS, however the Plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC, and therefore no provision for income tax has been included in the Plan's financial statements.

#### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in discretionary contribution made by the Plan Sponsor.

**7. RELATED-PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan's investments are managed by John Hancock Trust Company LLC and John Hancock Life Insurance Company (U.S.A.) and therefore qualify as exempt party-in-interest transactions. Fees paid by the Plan to John Hancock Trust Company LLC and John Hancock Life Insurance Company (U.S.A.) totaled \$91,404, which is recorded in administrative expenses on the statement of changes in net asset available for benefits for the year ended June 30, 2025.

The Plan also allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. Wells Fargo Advisors Insurance Agency, LLC and The Mand Marblestone Group, LLC represent the investment advisory and other third-party administrator of the Plan, respectively. As such, transactions with these parties qualify as exempt party-in-interest transactions. Fees paid by the Plan to these parties was \$4,897 and included in administrative expenses on the statement of changes in net Assets available for benefits for the year ended June 30, 2025.

Certain employees of the Plan Sponsor who are involved in the administration of the Plan are participants in the Plan. No such employees receive compensation from the Plan.

The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts.

**8. RISKS AND UNCERTAINTIES**

The Plan provides various investment options to its participants. Investment securities are exposed to various risks, such as, interest rate, credit and market risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**9. NONEXEMPT PARTY-IN-INTEREST TRANSACTION**

During the years ended June 30, 2024 and 2023, participant contributions and loan repayments were not remitted by the Plan Sponsor within the appropriate time period as prescribed by the Department of Labor Regulations. These transactions constitute prohibited transactions as defined by ERISA. During the year ended June 30, 2025, the Plan corrected \$1,530 and \$109 in late contributions for the 2024 and 2023 Plan years, respectively.

There were no late participant contributions and loan repayments for the Plan year ended June 30, 2025.

**10. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through December 17, 2025, the date the financial statements were available to be issued. No events occurred that require additional disclosure or adjustments to the Plan's financial statements.
