Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of Corvus Insurance Holdings 401(k) Plan (the Plan) provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering employees of Corvus Insurance Holdings, Inc. (the Company) who are age twenty-one or older. Union employees under collective bargaining agreements, leased employees, and non-resident aliens are excluded from participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Senior management of the Company is responsible for oversight of the Plan; they determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Effective January 1, 2025, the Plan was merged into The Travelers 401(k) Savings Plan, and net assets were transferred out of Ascensus Trust Company to the new plan effective February 28, 2025. Contributions to this plan ceased after December 31, 2024.

Contributions – Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan and subject to IRS limitations of \$23,000 (\$22,500 in 2023). The Plan provides a Roth contribution option. Participants who have attained age 50 before the end of the plan year are eligible to make additional catch-up contributions up to a maximum of \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of common collective trusts and mutual funds as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan. Auto-enrollment begins on the first full pay period after hire and the deferral rate is set at 4%. Participants may change the percentage withheld at any time, including to 0%. The funds are invested in a designated target date fund until changed by the participant.

The Company may make a discretionary matching contribution each plan year based on a percentage of the participant's contributions. In 2024 and 2023, the Company provided a matching contribution equal to 100% of each participant's elective deferrals up to 4% of compensation. The Plan also provides for discretionary profit sharing contributions to be made by the Company. No such contributions were made during the years ended December 31, 2024 or 2023. Contributions are subject to certain limitations.

Participant accounts – Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are always 100% vested in their contributions and Company contributions plus actual earnings thereon.

1. DESCRIPTION OF THE PLAN (CONTINUED)

Notes receivable from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest as determined by the plan administrator based on prevailing market conditions at the time of the loan and fixed over the life of the loan (9.5% at December 31, 2024). Principal and interest are paid ratably through periodic payroll deductions.

Payment of benefits – If a participant terminates service, the entire amount in his or her account may be distributed or rolled over in the form of a lump-sum payment. Hardship withdrawals and in-service withdrawals are also available under certain conditions as defined in the Internal Revenue Code.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The accompanying financial statements are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Senior management of the Company determines the Plan’s valuation policies utilizing information provided by investment advisers and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses paid directly by the Company are excluded from these financial statements. The Plan pays for investment adviser fees and recordkeeping fees charged by Vanguard, and transaction costs for loans and distributions are charged to participant accounts. Investment related expenses are included in net appreciation in fair value of investments.

3. INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, trustee of the Plan.

4. TAX STATUS

The Plan adopted a non-standardized defined contribution pre-approved plan document, which was approved by the Internal Revenue Service (IRS) in an opinion letter dated June 30, 2020. The IRS stated that the non-standardized pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has not received a determination letter specific to the plan itself; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as: (a) quoted prices for similar assets and liabilities in active markets, (b) quoted prices for identical or similar assets and liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, or (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation method are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. FAIR VALUE MEASUREMENTS (CONTINUED)

Common collective trusts – valued at the NAV of the units of the collective trusts. The NAV, as provided by the trustee, is based on the fair value of the underlying investments held by the funds less their liabilities. The majority of the underlying net assets have observable Level 1 and/or Level 2 quoted pricing inputs. Participant transactions (purchases and sales) may occur daily.

Stable value fund – valued at the NAV of the units of the fund based on investments in high-quality investment contracts and similar contracts issued by insurance companies, banks and other financial institutions. The NAV is used as a practical expedient for fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

6. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants’ account balances and the amounts reported in the statement of net assets available for benefits.

7. PARTY IN INTEREST TRANSACTIONS

Vanguard Group, Inc. is recordkeeper of the Plan and charges fees for services, which are included in administrative expenses. Such transactions are exempt from the prohibited transactions rule under ERISA.

8. SUBSEQUENT EVENTS

The Plan sponsor, Corvus Insurance Holdings, Inc. was acquired by a subsidiary of The Travelers Companies, Inc. effective January 2, 2024. As discussed in Note 1, effective January 1, 2025, this Plan was merged into The Travelers 401(k) Savings Plan. Net assets of this Plan were transferred to The Travelers 401(k) Savings Plan effective February 28, 2025.

The Plan has evaluated subsequent events through December 2, 2025, the date the financial statements were available to be issued.
