Re: Late Filing of Form 5500-SF for Plan Year Ending 2024

To Whom It May Concern,

We respectfully submit this reasonable cause statement in connection with the late filing of Form 5500-SF for Global Processing Services US, EIN 92-1001333, Plan Number 058583, for the plan year ending 2024. We request that any applicable late filing penalties be waived.

Reason for the Late Filing

Thredd (previously named Global Processing Services) is a foreign corporation headquartered in London, United Kingdom. During the relevant plan year, the organization was in the process of expanding operations into the United States and establishing a permanent presence. This was the first full plan year in which the company sponsored a U.S. based 401(k) retirement plan.

Due to the company's foreign status and lack of prior experience with U.S. retirement plans, management was not familiar with the requirement to file Form 5500. There were no previous U.S. HR or benefits personnel in place during the plan year, and as a result, the annual reporting requirement was not communicated internally.

I was hired as the first U.S.-based Human Resources professional hired recently and upon gaining administrative access to the 401(k) platform and reviewing plan compliance requirements, I discovered that Form 5500-SF had not been filed. The oversight was unintentional, and once identified, corrective action was taken immediately.

Corrective Action Taken

The form is being submitted promptly upon discovery of the error. The company has now put controls in place to prevent recurrence, including:

- Assigning responsibility for annual plan filings to our U.S. HR function,
- Calendar reminders and internal compliance checkpoints, and



- Ongoing coordination with our plan administrator and advisors.

Request for Waiver of Penalties

The late filing was the result of a good-faith misunderstanding and lack of prior knowledge, not willful neglect. As a foreign company new to U.S. retirement plan administration, the company did not have sufficient familiarity with Form 5500 requirements. Once the issue was identified, corrective steps were taken immediately.

In light of these circumstances, we respectfully request that the late filing penalties be waived.
