INDEPENDENT AUDITOR'S REPORT

To the Trustees of
Sertoma Centre, Inc. Defined Contribution Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sertoma Centre, Inc. Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets in liquidation available for benefits as of January 1, 2024 and December 31, 2023, and the related statement of changes in net assets in liquidation available for benefits for the period ended January 1, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 1, 2024 and December 31, 2023, and the period ended January 1, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS
JANUARY 1, 2024 AND DECEMBER 31, 2023

(1) DESCRIPTION OF PLAN:

The following description of Sertoma Centre, Inc. Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The financial statements were available to be issued on December 10, 2025 with subsequent events being evaluated through this date.

General -

The Plan is a defined contribution plan covering all employees of the Sertoma Centre, Inc. (The Organization) who are at least eighteen (18) years of age except for:

- Members of a bargaining unit;
- Independent contractors or students;
- Non-resident aliens.

The Plan is a defined contribution plan under Section 403(b) of the Internal Revenue Code and is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participants are eligible for participation in the plan on the date of their hire. Participants become eligible for employer contributions when they complete 12 months of service.

In October, 2023, the Plan Sponsor merged with another non-profit organization. As a part of the merger, the Plan was terminated, and all assets were transferred to the plan of the merged entity as of January 1, 2024.

The period ended January 1, 2024 is from January 1, 2024 through the end of the day when all assets transferred.

Contributions -

Participants may contribute up to 100 percent of their compensation as defined by the Plan, limited to the maximum amount allowable under the IRS. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans. The Organization will make safe harbor matching contributions on behalf of eligible participants who made a pretax compensation contribution to the Plan during the year in the amount equal to the sum of (i) 100% of salary reductions limited to 4% of eligible compensation, plus (ii) 50% of salary reductions that exceed 4% of eligible compensation but are not in excess of 6% of eligible compensation. For the period ended January 1, 2024, Organization made no safe harbor matching contributions. The Organization also has the option of making an annual discretionary nonelective contribution as determined by the Organization. The Organization did not make any discretionary nonelective contributions during 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options daily. Contributions are subject to certain limitations.

(1) DESCRIPTION OF PLAN: (Continued)

Participant Accounts -

Each participant's account is credited with the participant's elective and, if applicable, rollover contributions and allocations of a) the Organization's safe harbor matching contributions, b) the Organization's discretionary nonelective contributions and c) Plan earnings and charged with an allocation of administrative expenses.

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting -

Participants are immediately fully vested in their salary deferral contributions as well as the Organization's contributions plus actual earnings thereon.

Notes Receivable from Participants -

Participants may borrow from their funds a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range between one to five years but can be extended to 10 years when the loan is for the purchase of a principal residence. The Loans are secured by the balance in the participant's account and bear interest at fixed rates if funds are loaned from TIAA-CREF registered investment companies and bear interest at variable rates if funds are loaned from other investments. Principal and interest are paid ratably through automatic payroll deductions. There were no outstanding loans as of January 1, 2024 due to the termination of the Plan.

Participants may also obtain a TIAA-CREF Plan loan, which is a loan issued directly from funds owned by TIAA-CREF. For Plan loans, a portion of the participant's account is reserved, or held as collateral, to cover 110% of the outstanding loan balance in case of default. The collateral associated with a Plan loan is a plan asset and is reflected in the overall balance of the TIAA Traditional Benefit Responsive guaranteed investment contract. For all Plan loans, interest is paid directly to TIAA-CREF.

Payment of Benefits -

Participants withdrawing during the year for reasons of minimum required distribution at age 72, disability, retirement, death or termination of employment are entitled to their vested balance.

On termination of service, a participant may elect to receive an amount equal to the value of the vested interest in his or her account as a lump-sum distribution, in installments, or in the form of an annuity. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. In-service withdrawals are available to participants who meet certain hardship requirements or attain age 59 ½ .

Basis of Accounting -

The financial statements of the Plan are prepared under the accrual method of accounting.

(1) DESCRIPTION OF PLAN: (Continued)

Estimates -

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(2) SUMMARY OF ACCOUNTING POLICIES:

Basis of Accounting –

The financial statements of the Plan are prepared under the liquidation method of accounting.

Investment Valuation and Income -

Appreciation or depreciation in the market value of an investment held both at the beginning and end of the year is equal to the difference between the market value at the beginning and end of the year. Appreciation or depreciation in the market value of an investment acquired during the year and held at the end of the year is equal to the difference between the cost and the market value of the investment at the end of the year.

The Plan's Personnel Committee determines the Plan's valuation policies utilizing information provided by the custodian.

Gain or loss recognized from the disposition of an investment held at the beginning of the year is equal to the difference between the market value of the disposed asset the proceeds from disposition. Gain or loss realized from the disposition of an investment acquired during the year is equal to the difference between the cost and the proceeds from disposition.

Notes Receivable from Participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Defaulted participant loans are treated as distributions based upon the terms of the Plan Document.

Payment of Benefits -

Benefits are recorded when paid.

Administrative Expenses -

Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid by the Organization. No administrative expenses were paid by the Plan during the period ended January 1, 2024.

(3) PLAN TERMINATION:

In October 2023, the Plan Sponsor merged with another Organization. As a part of the merger, on January 1, 2024 the Plan was terminated and all assets were transferred to another plan.

(4) CERTIFIED INVESTMENTS:

The Plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the investment information certified by Teachers Insurance and Annuity Association – College Retirement Equities Fund (TIAA-CREF), which included total investments as of January 1, 2024 and December 31, 2023, the total investment income, including net realized and unrealized gains (losses) on investments for the period ended January 1, 2024.

(5) FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2023.

(5) FAIR VALUE MEASUREMENTS: (Continued)

Registered investment companies: Valued at the daily closing price as reported by the fund. Shares in registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed annuity contract: The TIAA Traditional Non Benefit Responsive investment is a guaranteed annuity contract that is reported at contract value which approximates fair value. This determination is based on TIAA's credit rating and yield during 2024 and 2023 being compatible to similar alternative investments and the interest rate which resets annually being comparable to a ten-year Treasury bond.

Pooled separate account: The value of the units of pooled separate account is principally derived from the market value of the underlying real estate holdings or other real estate-related investments.

Variable annuity contracts: Valued at the net asset value (NAV) of shares held at year end which is based on the fair value of the underlying investments. The Plan's interest in the variable annuity contract is valued based on the information reported by the contract holder.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(6) FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT:

The Plan holds an investment in the TIAA Traditional Benefit Responsive, a guaranteed investment contract managed by TIAA-CREF. The contract value of the guaranteed investment contract at January 1, 2024 and December 31, 2023 was \$-0- and \$754,155, respectively. TIAA maintains the underlying investments in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

(6) FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT:

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreement without the consent of the issuer.

(7) INCOME TAXES:

The Organization has adopted a prototype plan from TIAA-CREF. Currently, the IRS has no procedures for processing determination letter applications for 403(b) prototype plan documents. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 1, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for fiscal years prior to 2021.

(8) RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(9) PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are funds managed by TIAA-CREF. TIAA-CREF is the trustee as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. As of January 1, 2024 and December 31, 2023, \$-0- and \$2,200,883 of the Plan's investments are shares of investments offered by TIAA-CREF.

(9) PARTY-IN-INTEREST TRANSACTIONS: (Continued)

Certain employees of the Company that provide administrative services for the Plan are not reimbursed for their services from the Plan.

Participants covered under the Plan are considered to be parties-in-interest. Participant loans in the amount of \$-0- and \$91,727 at January 1, 2024 and December 31, 2023, respectively, are considered to be party-in-interest transactions.
