Note 1. Description of the Plan

The following description of the Volato Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering most employees of Volato, Inc. (the "Company") who have completed at least one hour of service and are age twenty-one or older. Certain employees covered by a collective bargaining agreement, leased employees, interns, and nonresident aliens are excluded from participation in the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The custodian of the Plan is John Hancock Life Insurance Company (U.S.A.) (the "custodian").

Contributions:

Each year, participants may contribute up to the maximum percentage of eligible compensation as pre-tax or Roth contributions, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a match of 100 percent of the participant salary deferrals that do not exceed 6 percent of eligible compensation. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. There was no discretionary profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts:

Each participant's account is credited with the participant's contributions and Company contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their voluntary contributions and all Company contributions, plus actual earnings thereon.

Notes receivable from participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is fixed at one percent above the prime rate. Principal and interest are paid ratably through payroll deductions.

Payment of benefits:

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or the installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59½.

Forfeited accounts:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,671 and \$30,084, respectively. These accounts will be used to reduce future Company contributions or to reduce administrative expenses. During 2024, Company contributions were reduced by \$7,413 from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Contributions:

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through December 18, 2025, the date the financial statements were available to be issued.

Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

Note 3. Custodian Certification

The following is a summary of the Plan's asset information as of and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedules, that was prepared by or derived from information provided by the custodian and furnished to the plan administrator. The plan administrator has obtained a certification from the custodian that the information provided to the plan administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets:

The custodian also certified to the completeness and accuracy of \$966,898 of appreciation in the fair value of investments and \$10,233 of interest on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Company has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts, Stable Value Guaranteed Income Fund: Valued at net asset value (NAV). The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment advisor reserves the right to temporarily delay withdrawal from the accounts in order to ensure that securities liquidation will be carried out in an orderly business manner.

- (a) Investments in the Plan's pooled separate accounts and the stable value guaranteed income fund are subject to the short-term trading guidelines of the custodian, which allow a maximum of two investment exchanges per calendar month.
- (b) Withdrawals caused by the Plan may either be paid out immediately (subject to a market value adjustment) or at the full contract value over a period of five years.
- (c) The investment option is a "fund of funds" that invests in Institutional Class shares of other funds of the Trust and potentially in other investment pools or investment products (collectively, the "underlying funds"). In general, the investment option is designed for investors who have recently retired or have an approximate target retirement year within a few years, and the underlying funds are adjusted from more aggressive to more conservative over time as the target retirement year approaches and for approximately seven to ten years afterwards.
- (d) This category includes a broadly diversified portfolio with significant exposure to developing markets by investing in securities of issuers based in "qualified developing countries," as well as in equity securities of issuers based in the developed world with significant assets or revenues attributable to developing countries. The portfolio also invests in bonds offering exposure to developing countries.
- (e) This category includes funds which invest only in U.S. domestic stocks. The portfolio also seeks long term growth of capital but has relatively high levels of risks and volatility.
- (f) This category includes funds that seek to provide stock exposure to any nation in the world outside the United States by investing in stocks of companies based outside the US. This includes developed and emerging markets across Asia, Europe and Latin America.
- (g) This category includes funds that provide a steady stream of investment income and protection against stock market volatility.
- (h) Equity investments with exposure to an asset class with low correlation to most major equity and fixed income market, which provides diversification benefits over time.
- (i) A diversified portfolio combining equities and fixed income to achieve a mix of growth and income with moderate risk.

Note 5. Stable Value Guaranteed Income Fund

The Plan invests in a guaranteed interest account, a group annuity contract which is a type of guaranteed investment contract, with John Hancock Life Insurance Company ("John Hancock") totaling \$199,224 for 2024 and \$209,310 for 2023. John Hancock maintains the contributions in a general account.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract does not meet fully benefit-responsive investment contract criteria and therefore is reported at fair value.

The Plan's ability to receive amounts due in accordance with investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by the future economic and regulatory developments.

Note 6. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by the custodian. Therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third-party administrator totaling \$60,870 which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

In September 2024, the Company entered into an agreement with flyExclusive, Inc., ("flyExclusive") a leading provider of private jet charter services, to transition the management of its aircraft ownership fleet operations to flyExclusive. This move was intended to bring substantial cost savings and allow the Company to focus on its potential high-growth areas, including aircraft sales and proprietary software. Due to these changes, operations downsized, which resulted in a partial plan termination. This affected 234 participants, 94 of whom have taken distributions from the plan of approximately \$2,886,000 in 2024. As the plan is a safe harbor plan, participants were already 100 percent vested in their accounts prior to the distributions being made.

Note 8. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax provisions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Note 10. Plan Sponsor Financial Condition

The Company has incurred significant operating losses and negative cash flows from operations. The Company's future results of operations and cash flows could have a material impact on the Plan. Plan management does not believe the Company's operating losses impact the Plan's ability to continue operations for the 12 months following the issuance of this report. There has been no decision to terminate the Plan or modify its provisions, and Plan management intends to continue to operate the Plan as designed.

Note 11. Plan Errors and Prohibited Transactions

The Company inadvertently failed to withhold deferrals and make matching contributions on flight pay, commissions and other compensation in accordance with plan provisions. The Company determined \$110,185 in missed deferrals and match is owed by the Company to the participants, which has been recorded as Other company contribution receivable in the accompanying 2024 statement of net assets available for benefits. The Company intends to file form 5330 and pay applicable excess tax related to 2022 through 2024 contributions made in 2026. The Company intends to calculate, self correct and remit contributions as well as lost earnings related to the 2022, 2023 and 2024 missed deferrals in 2026.

The Company inadvertently failed to remit participant deferrals and match contributions in 2023. The Company determined \$114,904 in participant deferrals and match is owed by the Company to the Plan participants, which has been recorded as Other company contribution receivable in the accompanying 2024 statement of net assets available for benefits. The Company intends to file form 5330 and pay applicable excise tax related to the missed contributions. The Company has calculated lost earnings and intends to remit the correction in 2026.

During 2023, the Company inadvertently failed to make deposits of \$322,252 of participant deferrals within the timeframe as required by the DOL. The DOL considers late deposits, without regard to materiality, to be prohibited transactions. The general rule for deposits of 401(k) withholdings requires that the Company remit withheld employee 401(k) deferrals to the Plan as of the earliest date on which such amounts can reasonably be segregated from the Company's general assets, but in no event later than 15 business days after the end of the month in which the contributions were withheld.

The Company made deposits ranging from 9 days to 52 days after the date in which the contribution was withheld. The Company intends to file form 5330 and pay applicable excise tax related to 2024 contributions in 2026. The excise tax payments will be made from the Company's assets and not from the assets of the Plan. In 2026, the Company intends to calculate, self correct and remit the amount of investment income which would have been earned had participant contributions been remitted on a timely basis related to the 2024 deferrals.
