Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Vantiva 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Vantiva 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Vantiva 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Vantiva 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Vantiva 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



NOTE 1 DESCRIPTION OF PLAN

The following description of Vantiva 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Vantiva USA Shared Services Inc., Technicolor Home Entertainment Services, Inc., and Vantiva USA, LLC (collectively, the Company) and Subsidiaries, excluding leased employees, nonresident aliens, and employees covered by a collective bargaining agreement unless the collective bargaining agreement requires the employees to be included under the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendments

The Plan was amended effective January 1, 2024 to allow for rollover distributions to an individual retirement plan account if an account value exceeds \$1,000 but is less than or equal to \$7,000.

The Plan was amended effective January 2, 2024 to include ARRIS Solutions, LLC as a predecessor employer and allow all employees with prior service with CommScope Holding Company, Inc. to participate in the Plan. The amendment also stated that the Company would make a discretionary nonelective contribution on the last day of the 2024 Plan year for such employee members who are employed as of December 31, 2024 in an amount equal to 2% of such members' earnings under the Plan for the 2024 Plan year.

The Plan was amended effective February 29, 2024 to exclude Technicolor Creative Services, Inc. as a participating employer in the Plan and spin off any employee employed by Technicolor Creative Services, Inc. or its Controlled Group on or after September 26, 2022 into a separate plan sponsored by Technicolor Creative Services, Inc. Effective March 1, 2024 the Plan returned to its status as a single-employer plan.

Eligibility

Employees of the Company are eligible to participate in the deferral component of the Plan immediately upon their date of employment. Participants are eligible for the match component after completing one year of service.

Contributions

The Plan provides for the following contributions:

Pre-Tax and Roth Contributions – A participant may contribute, at his or her discretion, amounts between 1% and 75% in whole percentages of the participant's earnings up to Internal Revenue Service (IRS) limits.

After-Tax Contributions – A participant may elect to contribute after-tax contributions to the Plan through regular payroll deductions from 1% to 20% in whole percentages of the participant's earnings up to IRS limits.

Contributions (Continued)

Pre-Tax and Roth Catch-Up Contributions – A participant who has obtained age 50 before the close of the Plan year is eligible to make catch-up contributions between 1% and 75% in whole percentages of the participant's earnings up to IRS limits.

Company Contributions – The Company will contribute for each eligible participant a matching contribution in an amount equal to the sum of the participant's pre-tax contributions and after-tax contributions, up to 4.5% of a participant's eligible compensation calculated on a Plan year basis. The Company may also, at its discretion, elect to make a nonelective contribution to the Plan. For the year ended December 31, 2024, the Company made a discretionary nonelective contribution equal to 2% of eligible compensation for employees of ARRIS Solutions, LLC as of January 2, 2024 who were employed on December 31, 2024.

Pre-Tax, After-Tax, and Roth Rollover Contributions – The Plan allows for direct rollovers of eligible rollover distributions from qualified retirement plans as specified by the participant.

Participants direct the investment of contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Company matching contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The terms of the notes shall not exceed five years except for notes used to purchase a primary residence, the terms of which shall not exceed ten years. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

Upon termination of service for any reason other than by death, a participant can elect to receive a lump-sum distribution or elect to defer distribution until required under the provisions of the Plan. Upon the death of a participant, a participant's account is distributed to the surviving spouse or to the designated beneficiary in a lump sum.

Benefit Payments (Continued)

The Plan allows for in-service distributions if a participant reaches age 59½ or becomes disabled. In addition, the full value of a participant's after-tax savings account, prior savings plan account and rollover account can be withdrawn at any time.

Prior to age 59½, a participant may withdraw Company contributions and participant pre-tax contributions only if the participant satisfies certain financial hardship requirements as defined by the Internal Revenue Code (IRC).

The Plan also provides for automatic cash-out and/or rollover distributions into an individual retirement account for terminated participants whose balance does not exceed certain limits as prescribed by the Plan document and IRC.

Forfeited Accounts

Forfeited nonvested accounts are first used to reduce administrative expenses and then are used to reduce qualified nonelective contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$11,643 and \$136,966, respectively. There were \$120,040 of forfeitures used to pay administrative expenses for the year ended December 31, 2024. There were \$11,542 of forfeitures used to reduce Company contributions for the year ended December 31, 2024. The balance in the forfeiture account at December 31, 2024 is primarily comprised of uncashed benefit payments.

Revenue Sharing

The Plan holds assets in a plan expense account which receives deposits as a result of a revenue sharing arrangement with Fidelity. During the year ended December 31, 2024, deposits to the account totaled \$168,773, which are included in other income on the statement of changes in net assets available for benefits. Funds in the account are used to pay qualified plan expenses. For the year ended December 31, 2024, revenue sharing credits totaling \$43,244 were used to pay plan expenses and \$99,104 were reallocated to plan participants. The revenue sharing account totaled \$84,269 and \$54,242 as of December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution retirement plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Expenses paid by the Plan are recorded as administrative expenses in the accompanying statement of changes in net assets available for benefits.

Expenses incurred in connection with the general administration of the Plan that are paid by the Plan are allocated to participant accounts as provided by the Plan document. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through December 5, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Fidelity Management Trust Company (Fidelity), the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Self-Directed Brokerage Funds: Self-directed brokerage funds consist primarily of mutual funds, common stock, corporate bonds, and government bonds that are valued on the basis of readily determinable market prices as reported on the active market on which the individual securities are traded. Bank deposit accounts held within self-directed brokerage funds are money market deposit accounts. These interest-bearing bank accounts are valued at their stated cash balances which are considered Level 1 inputs. Investments in certificates of deposit held within self-directed brokerage funds are valued based on fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

Collective Funds: Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 GUARANTEED INVESTMENT CONTRACT

During 2023, the Plan entered into a benefit-responsive guaranteed investment contract with Lincoln Financial Group (Lincoln). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Lincoln is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract Value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract is a traditional investment contract. The contract value of the investment contract as of December 31, 2024 and 2023 was \$27,288,247 and \$27,969,844, respectively.

The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with Lincoln. Such events include the following: 1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would remain 100% vested in their Company contributions.

NOTE 8 PLAN TAX STATUS

The Plan has received a determination letter from the IRS dated January 9, 2017, stating that the Plan, as then designed, was qualified under Section 401(a) of the IRC and is therefore not subject to tax under current income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

As described in Note 2, fees are incurred by the Plan for recordkeeping and trustee services, and for the administration of notes receivable from participants and benefit payments, which are paid to Fidelity. There were \$253,390 in such fees (net of forfeitures) which were charged directly to the participant accounts and are included in administrative expenses for the year ended December 31, 2024. The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation.

NOTE 10 PLAN TRANSFER

Effective February 29, 2024, the Plan was amended to remove Technicolor Creative Services, Inc. (TCS) as a participating employer. All employees of TCS or its Controlled Group as of September 26, 2022 were spun off into a separate plan sponsored by TCS. In connection with the spin off, the account balances of the TCS participants totaling \$50,269,060 were transferred to the Technicolor Creative Services USA, Inc. 401(k) Plan effective March 1, 2024.
