Greetings,

My apologies for not having a timely filing of form 5500-SF for 2023. Our company stopped having employees at the end of 2022, and I was not aware of a need to file for 2023. Unknown to me, the plan continued briefly into 2023 before being shut down (our 2023 filing shows only \$172 in employee contributions).

Once receiving the notice from the IRS, I promptly got in contact with the helpful staff as efast, who helped me investigate the issue and to find the current filings (which were done by our administrator at the time, ADP) and also helped me to see that the final form provided by ADP was for the 2023 period but printed on a 2022 form. I have now fixed ADP's error and am now correctly filing the 2023 form.

Thank you for providing the notice to prompt my action, and I hope it is understandable why the filing was late. Given the very small size and short duration of the plan (two years and about \$14,000), I hope you can forgive any penalties that could have resulted from this delay.
