### **Opinion**

We have audited the financial statements of the Haylor, Freyer & Coon, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits in liquidation as of August 15, 2025 (Date of Liquidation) and August 31, 2024, and the related statements of changes in net assets available for benefits in liquidation for the period September 1, 2024 through August 15, 2025 (Date of Liquidation), and for the year ended August 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits in liquidation of the Plan as of August 15, 2025 (Date of Liquidation) and August 31, 2024, and the changes in net assets available for benefits in liquidation for the period September 1, 2024 through August 15, 2025 (Date of Liquidation), and for the year ended August 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the **Auditor's Responsibilities for the Audits of the Financial Statements** section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

## **Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting**

As further discussed in Notes 1 and 2 to the financial statements, the Board of Directors of Haylor, Freyer and Coon, Inc., the Plan Sponsor, voted to terminate the Plan effective October 3, 2022, and management determined liquidation is imminent. As a result, the Plan's financial statements as of August 15, 2025 (Date of Liquidation) and August 31, 2024, and for the period September 1, 2024 through August 15, 2025 (Date of Liquidation), and year ended August 31, 2024, have been prepared on the liquidation basis of accounting in accordance with U.S. GAAP. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audits of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

### Notes to Financial Statements

#### Note 1 - Description of Plan

General - Haylor, Freyer & Coon, Inc. (the “Company”) Employee Stock Ownership Plan (the “Plan”) was a stock bonus plan (see Plan termination below) under Sections 401(a) and 4975(e)(7) of the Internal Revenue Code and the Employee Retirement Income Security Act (ERISA) of 1974. The following descriptions provide only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

Plan termination - Effective October 3, 2022, Haylor, Freyer and Coon, Inc., the Plan Sponsor, elected to terminate the Plan, at which time the Plan no longer accepted any new participants or contributions, and all existing participants became 100% vested. See Note 3 for additional disclosures related to the plan termination.

Administration of plan assets - The plan assets included certificates of deposit, registered investment companies and money market funds, which are held by several different custodians. However, all assets were managed by the Board of Trustees. The Board of Trustees was comprised of officers and stockholders of the Company. Effective March 1, 2022, the Board of Trustees, appointed Isaacks & Associates, Ltd., LLP as an independent ESOP Trustee to oversee the day-to-day operations as well as oversee the termination process and distribution of plan assets as a result of the plan termination discussed above.

Plan year - The Plan maintained a fiscal year ending August 31.

Eligibility - The Plan covered all employees of the Company who had completed one year of service (in which they were credited with at least 1,000 hours of service). Eligible employees began participating in the Plan as of the earlier of the first day of the seventh month or the first day of the plan year, whichever came first, after meeting the eligibility requirements.

Contributions - The Company was obligated to make contributions to the Plan, which when aggregated with the Plan’s dividends and interest earnings, equals the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loans. In addition, the Company could have made a discretionary contribution as determined by the Board of Directors of the Company. As disclosed above under Plan termination, the Plan no longer accepts contributions, therefore, there was no employer contribution for the period September 1, 2024 through August 15, 2025 (Date of Liquidation), and for the year ended August 31, 2024.

Participant accounts - The Plan was a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account was credited with an allocation of the Plan’s earnings and charged with an allocation of administrative expenses. Allocation is based on the eligible participants’ available beginning of year cash balance in their account, relative to the total available beginning of year cash for all eligible

participants. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Investment options - The ESOP Trustee invested any plan assets in such prudent investments as the ESOP Trustee deemed to be desirable for the Plan.

Vesting of benefits - Vesting in the Company's contribution was based on years of credited service. Participants were fully vested in the Company's contribution after six years of credited service. However, upon election to terminate effective October 3, 2022, (discussed above), all participants became 100% vested.

Forfeitures - Forfeitures occurred on the earlier of the distribution of a participant's entire vested account balance or the last day of the plan year in which the participant incurred five consecutive one-year breaks in service. Forfeitures were allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the plan year. However, upon election to terminate effective October 3, 2022, (discussed above), all participants became 100% vested. There were no forfeitures allocated for the period September 1, 2024 through August 15, 2025 (Date of Liquidation), and for the year ended August 31, 2024. There were no unallocated non-vested accounts as of August 15, 2025 (Date of Liquidation) and August 31, 2024.

Payment of benefits - If a participant's employment was terminated as a result of retirement, disability or death, distributions began no later than the plan year following the plan year in which their employment terminated. If a participant's employment were terminated for another reason, distributions would have begun no later than the sixth plan year following the plan year in which their employment terminated, unless the participant was reemployed by the Company. Distributions generally commenced following the later of the date a participant's employment ended or the date the participant reached age sixty-five. The trustees could have chosen a lump sum distribution or substantially equal annual instalments over a period generally not exceeding five years or any combination thereof. However, upon election to terminate the Plan (discussed above) in January 2023, the ESOP Trustee distributed up to 70% of the value of each plan participant's cash account balance in a single cash lump sum. In February 2025, the Plan received a favorable determination that the termination of the Plan does not adversely affect the Plan's tax-qualified status from the Internal Revenue Service and distributed the remaining amounts in April 2025 with the Plan showing a zero balance as of August 15, 2025 (Date of Liquidation).

Other provisions - Under the plan provisions, the Plan was prohibited from allowing participants to borrow against the account balance, take hardship withdrawals, take in-service distributions or purchasing life insurance contracts.

Subsequent events - Management has evaluated subsequent events through December 1, 2025, the date that the financial statements were available for issue.

## Note 2 - Summary of accounting policies

Method of accounting - The Plan's financial statements have been prepared on the liquidation basis of accounting, in accordance with U.S. GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of the Plan is probable and imminent, and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realizable value and liabilities are stated at their anticipated settlement amounts.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expenses during the reporting period. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, credit and overall market risk. Market risks include domestic and global events which could impact the value of investment securities.

Investment valuation - Investments were stated at fair market value (see Note 4). Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold, as well as held.

Economic dependency and concentration of credit risk - The Plan maintained cash balances at one financial institution. Cash balances at the financial institution in excess of the amount insured by the Federal Deposit Insurance (FDIC) were subject to credit risk. The plan had approximately \$29,400,000 in excess of FDIC insured limits as of August 31, 2024. The Plan had not experienced any losses in such accounts. All of the other investments were exposed to market risk as discussed above.

Payment of benefits - Benefits were recorded when paid.

Administrative costs - Certain administrative functions were performed by officers and/or employees of the Company. No such officer or employee received compensation from the Plan. Administrative costs, including maintaining participant accounts, legal, trustee and accounting costs, were the obligation of the Plan; however, the Company could have paid for such expenses or reimbursed the Plan for any payment of these expenses. Costs of managing the investments and trustee services were paid directly out of the Plan's assets (see Note 5).

### Note 3 - Plan termination

As discussed in Note 1, effective October 3, 2022, Haylor, Freyer and Coon, Inc., the Plan Sponsor, elected to terminate the Plan, at which time the Plan no longer accepted any new participants or contributions, and all existing participants became 100% vested. As of the effective date above, the Plan was no longer considered an employee stock ownership plan and converted into a profit-sharing plan. In October 2022, all of the Company stock held by the Plan was sold for cash proceeds. In January 2023, up to 70% of the value of each participant's cash account balance were distributed. In February 2025, the Plan received a favorable determination that the termination of the Plan does not adversely affect the Plan's tax-qualified status from the Internal Revenue Service. In April 2025, all remaining assets were distributed to the participants. All benefit payments have cleared on August 15, 2025 (Date of Liquidation) for which the Plan was terminated.

### Note 4 - Fair value measurements

The Financial Accounting Standards Board (FASB) has established authoritative guidance regarding accounting for fair value measurements. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy measurement under this FASB statement are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in inactive markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's assets measured at fair value:

*Registered Investment Companies* - Valued at the closing price reported on the active market on which the individual security is traded (Level 1).

*Money Market Funds* - Managed portfolios including commercial paper, certificate of deposits, U.S. government agency obligations, corporate bonds and notes, repurchase agreements and other assets and liabilities valued at the closing price reported on the active market on which the individual security is traded (Level 2).

For the term notes payable, the fair value, which approximates the book value, was based on present value techniques using inputs derived principally or corroborated from market data. Financial assets and liabilities that use Level 3 inputs are primarily valued by valuation experts using externally developed models that consider unobserved market inputs. Valuation techniques utilized to determine fair value are consistently applied.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of August 15, 2025 (Date of Liquidation) and August 31, 2024.

#### Note 5 - Related party transactions

The Plan contracted with Transition Finance Strategies (formerly Blue Ridge ESOP Associates) to provide third-party administrative services, Isaacks & Associates, Ltd., LLP to provide independent third-party trustee services, Dannible & McKee, LLP to provide independent auditor services, Haylor, Freyer & Coon, Inc. (an ALERA Group Company) to provide insurance services and LPL Financial to provide investment advisory services for the period September 1, 2024 through August 15, 2025 (Date of Liquidation), and for the year ended August 31, 2024. The Plan paid \$102,902 and \$114,738 for these services for the period September 1, 2024 through August 15, 2025 (Date of Liquidation), and for the year ended August 31, 2024, respectively, and are included in administrative fees in the accompanying statements of changes in net assets available for benefits in liquidation. The Plan contracted with Dannible & McKee, LLP to provide auditing services, which qualifies as party-in-interest transactions. Fees for these services were paid for by the Company for the period September 1, 2024 through August 15, 2025 (Date of Liquidation), and for the year ended August 31, 2024 (in Liquidation).

#### Note 6 - Income tax status

The Plan was established to qualify under Section 401(a) of the Internal Revenue Code (the “Code”) and therefore, is not subject to tax under present income tax laws. The Internal Revenue Service has determined and informed the Plan Sponsor that the Plan is designed in accordance with applicable Sections of the Code. The Plan has been amended since receiving the determination letter. The management of the Company and the plan trustees are not aware of any matters that would disqualify the Plan. Accordingly, the Plan has been accounted for as a tax-exempt plan. However, as disclosed in Note 1, management of the Company has elected to terminate the Plan effective October 3, 2022. In February 2025, the Plan received a favorable determination that the termination of the Plan does not adversely affect the Plan’s tax-qualified status from the Internal Revenue Service.

The Plan has reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and interest for the period September 1, 2024 through August 15, 2025 (Date of Liquidation), and for the year ended August 31, 2024. The Plan is no longer subject to regulatory examinations by tax authorities for the closed years before 2022.
