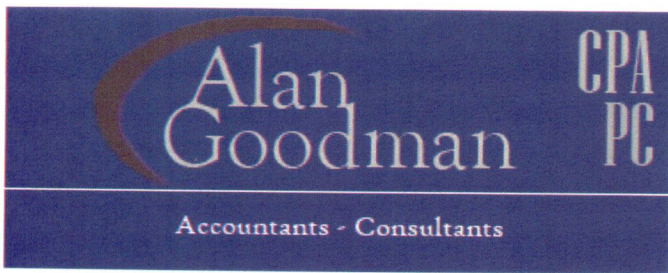

INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Allure Healthcare Management 401 (K) Plan an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the **Allure Healthcare Management 401 (K) Plan** (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Allure Healthcare Management (the “Plan Sponsor”) who are age 21 or older and have completed 3 month’s service. The plan is administered by the participants of the Plan (Employer elected to offer the Plan).

The Plan was established on January 1, 2017, and was amended and restated most recently effective December 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended and is intended to qualify as a tax-exempt plan under Section 401(a) of the Internal Revenue Code. The plan changed its name in 2024.

The Plan’s trustee is Michael Nudel.

Contributions

Each year, participants may contribute the maximum amount allowed to the Internal Revenue Service, plus catch-up contributions. Participants may make voluntary, pre-tax contributions through payroll deductions. The Company may make discretionary matching contributions. Participants must make elective deferrals into the Plan based on a percentage of their compensation.

For the year ended December 31, 2024, contributions were in the amount of \$1,133,3901; respectively in 2023, contributions were in the amount of \$899,752.

Participant accounts

Each participant’s account is credited with the participant’s contributions, the Company’s matching contribution, and Plan earnings, and charged with allocations of administrative expenses. Income and expenses are allocated monthly.

Vesting

Participants are fully vested immediately in their contributions plus actual earnings thereon. Employer matching and profit-sharing contributions have the following vesting percentage schedule: Years of Service | Vesting Percentage

Investment options

Participants direct the investment of their account balances into various investment options offered by the Plan. The Plan currently offers a variety of registered mutual funds and other investment options for participants.

Loans to participants

Loans are not permitted under the Plan.

Payment of benefits

On retirement, death, disability, or termination of service, a participant may elect to receive a lump-sum distribution of the value of his or her vested interest or begin receiving benefits in accordance with Plan provisions.

Forfeitures from participants' non-vested accounts may be used by the Company to pay administrative expenses or reduce future employer contributions. Forfeitures that occurred during the years ended December 31, 2024 and 2023, were \$0 and \$0, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as of the end of the year measured using the inputs and valuation techniques discussed in Note 4. Securities purchased and sold are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend

date. The Plan records investment income as interest, dividends, and net appreciation or depreciation in the fair value of investments.

Benefits Payments

Benefits are recorded when paid.

NOTE 3 – TAX STATUS

The Plan has adopted a plan document sponsored by a national provider which received an opinion letter from the Internal Revenue Service to the effect that the Plan is designed in accordance with applicable provisions of the Internal Revenue Code.

The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 4 – INVESTMENTS AND FAIR VALUE MEASUREMENTS

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024.

Pooled separate accounts: Valued at the net asset value, which is based on the values of the underlying mutual funds as determined by quoted market prices, less any liabilities.

The Plan's assets at fair value as of December 31, 2024, was \$7,162,754, and is considered Level 2 investments within the fair value hierarchy.

As permitted by Section 2520.103-8 of the Department of Labor's Rules and regulations for Reporting and Disclosures under the Erisa, the plan has elected the alternative method of compliance with respect to the required audit of the financial statements. As a result of adopting this method, the trustee, who also maintains the primary records of the plan, certified to the plan administrator that the statements of the trustee were complete and accurate and the reported assets were under their control.

NOTE 5 – FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan invested in collective trusts and pooled separate accounts which contain a fully benefit-responsive investment contract.

This contract is recorded at contract value because this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

At December 31, 2024 and 2023, certain Plan investments represent transactions with entities considered to be parties-in-interest. Such transactions are exempt from prohibited transaction rules provided they meet regulatory guidelines.

NOTE 7 – PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to market, credit, and interest rate risks.

Due to the level of risk, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances.

NOTE 9 – RECONCILIATION TO FORM 5500

The following is a reconciliation of net assets available for benefits and changes in net assets available for benefits to the amounts reported in Form 5500 for the year ended December 31, 2024.
