Independent Auditors' Report

To the Participants and Trustees of

Opinion

We have audited the accompanying financial statements of BLS Trucking, Inc. NOTE A - DESCRIPTION OF THE PLAN

The following description of the BLS Trucking, Inc. Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan sponsored by BLS Trucking, Inc., and Southeast Trucking, Ltd., (referred to collectively as the Company or Plan Sponsor) and covers substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The investments of the Plan are all non-participant directed.

Eligibility

Under the terms of the Plan, employees are eligible to become participants on the first day of the first month of the Plan Year following or coincident with completion of at least 1,000 hours of service over one full year and upon reaching age 21. The allowable entry date is July 1.

Contributions

A profit sharing contribution, if any, will be determined each year by the Board of Directors of the Company, at its sole discretion at the Plan's year-end. This contribution is allocated based on compensation of all participants eligible to share in the discretionary amount. Eligible employees must be employed on the last day of the plan year to receive the contribution for the year, with the exception of certain employees who are granted an eligibility waiver, are non-highly compensated employees, and are eligible for another allocation. The Company accrued a discretionary profit sharing contribution of \$1,000,000 and \$1,200,000 as of June 30, 2025 and 2024, respectively.

Participant Accounts

Each participant's account is credited or charged with the above contributions, rollover contributions, and an allocation of Plan earnings thereon.

The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account balance.

Vesting

Participant vesting is based on service years. The discretionary profit sharing contributions vest according to the following schedule:

Forfeited Accounts

Forfeitures are reallocated following the date on which a terminated participant incurs five consecutive one-year breaks in service or following the date on which a terminated participant receives payment of his vested account balance. Amounts forfeited from a participant's account shall be used to restore forfeitures, reduce Company contributions (or reallocated as Company contributions), or pay plan expenses. At June 30, 2025 and 2024, forfeited, non-vested accounts totaled \$34,761 and \$33,620, respectively. During the year ended June 30, 2025, forfeitures of \$333,879 were used to fund a portion of the Company's profit sharing contribution, and forfeitures of \$24,325 were used to pay plan expenses.

Payment of Benefits

Upon termination of service, a participant may elect to receive:

- (a) A lump sum distribution equal to the value of his or her account
- (b) Equal installments over a period of not more than the participant's assumed life expectancy, or
- (c) A joint and survivor annuity

Participants may take certain in-service withdrawals if they are fully vested in their account balance. Participants may also take an in-service distribution on account of a qualified birth or adoption from the vested portion of their account upon satisfying certain criteria detailed in the Plan Document.

Hardship Withdrawals

Participants may receive a distribution on account of hardship if they are fully vested in their account balance and the hardship meets criteria detailed in the Plan Document.

Amendments

Effective January 28, 2025, the Plan was amended and restated to increase the threshold for cash lump sum distributions upon termination without required consent from \$1,000 to \$5,000. During 2025, the Plan implemented certain provisions of the SECURE 2.0 Act of 2022 to increase the threshold to \$7,000. A written amendment to the Plan to reflect the operational change will be adopted at a later date in accordance with applicable laws and IRS guidance.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in interest and dividends. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the Plan are allocated to the participants' accounts and are included in administrative expenses. Certain withdrawal expenses are paid for by the affected participant. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

NOTE C - FAIR VALUE MEASUREMENTS

FASB ASC 820-10, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below.

Level 1: Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodologies include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Money market funds: Valued at the daily closing price as reported by the fund.

Common stocks, mutual funds and exchange traded funds: Valued at the closing price reported on the active market on which the funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - INCOME TAX STATUS

The Company has adopted the Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by CCH Incorporated. The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the restated prototype plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the determination letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in accordance with the IRC. Therefore, no income taxes have been provided for in the financial statements.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - PARTY-IN-INTEREST TRANSACTIONS

Certain administrative services are provided by the Plan Sponsor at no cost to the Plan, and certain administrative costs incurred by the Plan are paid by the Plan Sponsor.

The Plan's administrative expenses result from services rendered by parties-in-interest.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become one hundred percent (100%) vested in their accounts.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H - SUBSEQUENT EVENTS

Subsequent events were evaluated through December 12, 2025, which is the date the financial statements were available to be issued.
