### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Innersea Discoveries, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Innersea Discoveries, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. **NOTE A.--DESCRIPTION OF PLAN**

The following description of the Innersea Discoveries, LLC (Company or Sponsor) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The plan is a defined contribution 401(k) plan originally established by the Company effective January 1, 2001. The plan was most recently restated effective January 1, 2023 to change the matching contributions to 100% of participant deferrals not exceeding 3%. See also Note K. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee is any person employed by the Company excluding non-resident aliens and residents of Puerto Rico. An employee becomes eligible to participate in the plan after completing twelve months of service and reaching 21 years of age. Participants receive credit for one year of service for a 12 consecutive month period in which they complete 1,000 hours of service. The entry dates are monthly, the first day of each month following completion of eligibility requirements.

*Contributions:* The Plan is funded by eligible participant elective deferrals which may range from 1% to 90% of eligible compensation and discretionary employer non-elective and matching contributions. Effective January 1, 2023, the Plan was amended to add an employer matching contribution equal to 100% of elective deferrals that do not exceed 3% of eligible compensation. See also Note K.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Also, all participants who are eligible to make elective deferral contributions may elect to designate all or any portion of their future deferrals as Roth elective deferral contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Contributions are subject to certain limitations.

*Participant Accounts:* Each participant's account is credited with the participant's contributions, allocation of the employer contributions, plan earnings (losses), and charged with certain administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

*Vesting:* Participants are immediately vested in their rollover contributions and elective deferrals. The employer non-elective and matching contributions are 100% vested after two years of service, or upon death or disability.

*Retirement:* The normal retirement date is the date the participant turns 65. There is no early retirement.

**NOTE A.--DESCRIPTION OF PLAN (Continued)**

*Payment of Benefits:* On termination of service due to disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals, or installments over a certain period. If the balance is less than \$5,000, there is no option other than lump sum. Upon death of a participant, if death benefit is more than \$5,000, payments made to a beneficiary shall be made payable in a lump-sum payment, installments over a certain period, or partial withdrawals. If the balance is less than \$5,000, there is no option other than lump sum.

For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or may continue to participate in the plan investments and benefits will be provided upon retirement or death. For terminated and disabled participants, if the balance of the vested accounts is \$5,000 or less, payment may be made in a lump-sum without the participant's consent. If such balance is less than \$5,000 but greater than \$1,000, it will automatically be rolled over into an IRA established by an IRA provider selected by the Company, without other election. If balance is less than \$1,000 it will be distributed in a lump sum. In service distributions at age 59 1/2, qualified reservist distributions, and hardship distributions may be made in accordance with the provisions of the Plan.

*Forfeited Accounts:* Forfeitures of terminated participants' non-vested account balances may be used for employer contributions, to pay Plan expenses, restore forfeitures, or be re-allocated to participants' accounts. The Plan used forfeitures of \$1,933 to offset administrative expenses during the year ended December 31, 2023. The balance of unused non-vested account balances forfeited into the Plan as of December 31, 2023 and 2022, was \$10.

*Notes Receivable from Participants:* Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are issued by the Plan and secured by the balance of the participant's account. Loan transactions are treated as a transfer to the investment fund from (to) the loan fund. The loans are to bear a reasonable rate of interest based on prime plus 2% to be determined at the loan issuance date. One outstanding loan is permitted per person. Principal and interest are paid through payroll deductions.

*Investment Options:* Participants are allowed to direct their contributions and account balances in various investment options offered under the Plan. The Sponsor periodically reviews the investment options available to participants and changes them as warranted. Participant may change their investments at any time.

*Plan Expenses:* Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees such as for distributions and loans are charged directly to the participant's account and are included in administrative expenses.

*Plan Expenses (Continued):* Investment related expenses including 12b-1 fees and revenue sharing fees are deducted from each funds' earnings and are included in net appreciation (depreciation) in fair value of investments.

**NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates:* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition:* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by the investment advisor and custodian and trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

*Payment of Benefits:* Benefits are recorded when paid.

*Excess Contributions Payable:* Amounts payable to participants totaling \$34,168 for contributions in excess of amounts allowed by the IRS are recorded as accounts payable at December 31, 2024, with corresponding reduction to 2024 contributions. The Plan distributed 2024 excess contributions prior to March 15, 2025. See Note J.

**NOTE C.--CERTIFIED INFORMATION**

Certain information related to investments, and notes receivable from participants disclosed in the accompanying financial statements and ERSIA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee and custodian of the Plan.

**NOTE D.--FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded

*Collective trust funds:* Valued at NAV of units held by the Plan at year end. The NAV, as provided by the trustees and custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a collective trust is calculated based on a compilation of primarily observable market information. The number of units of the trust that are outstanding on the calculation date is derived from observable purchase and redemption activity in the trust.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are in funds managed by the trustee and custodian, Reliance Trust Company; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**NOTE F.--TAX STATUS**

The Plan was amended and restated effective June 1, 2022 and adopted a non-standardized pre-approved profit sharing/money purchase plan with a cash deferral arrangement that received a favorable opinion letter from the Internal Revenue Service (IRS) on October 6, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

**NOTE F.--TAX STATUS (Continued)**

Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G.--PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan including employer contributions shall become fully vested and non-forfeitable. See Note H.

**NOTE H.--RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE K.--SUBSEQUENT EVENTS**

Effective April 1, 2024, the Plan changed providers from ADP and Reliance Trust Company to Vanguard.

Effective April 1, 2024, the Plan adopted a new adoption agreement number 001, that changed employer match contributions to safe harbor employer contributions. Then the Plan again, effective April 30, 2024, discontinued the safe harbor employer contributions and elected a fixed matching contribution formula equal to 100% of salary deferrals up to 4%.

The Plan has evaluated subsequent events through December 12, 2025, the date the financial statements were available to be issued.
