## INDEPENDENT AUDITORS' REPORT

To the Trustees  
Markel 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Markel 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements are comprised of the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Markel 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note F to the 2024 financial statements, is complete and accurate.

### **Opinion**

NOTE A: DESCRIPTION OF PLAN

The following description of the Markel 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) retirement plan covering all employees of Martech Medical Products, Inc., Medical Components, Inc., and Point Medical Corporation ("Companies") who have completed one year of service, worked 1,000 hours and are age twenty-one or older. The Plan is subject to the provisions of Employee Retirement Income Security Act (ERISA). The Plan Administrator and Plan Trustee are responsible for oversight of the Plan. The Plan Trustee determines the appropriateness of the Plan's investment offerings and monitors investment performance and discusses with the Plan sponsor any suggested changes.

Effective January 1, 2003, employees of Point Medical Corporation, a business acquired by the common owner of the Companies, are included in the Markel 401(k) Plan. Amounts transferred from the original Point Medical profit sharing plan became 100% vested. Any new employees of Point Medical are subject to the Markel Plan vesting percentages on January 1, 2003.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation as defined in the Plan subject to the Federal dollar limitation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into the investment options offered by the Plan. The Plan currently offers pooled separate accounts and a guaranteed portfolio account. The Companies elected to contribute 70 percent of the first 5 percent that participants contribute to the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Companies' matching contributions, as well as an allocation of the Plan earnings less administrative and investment expenses. Plan earnings are based on participant account balances at the time of allocation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their elective contributions plus actual earnings thereon. Vesting in the Companies' contribution portion of their accounts is based on years of continuous service. Prior to January 1, 2002, participants were vested 100% in the Company match after five years of credited service. Effective in 2002, participants are vested 20% after two years of credited service and 20% per year thereafter, becoming 100% vested in the Companies' match after six years of credited service. Participants will become 100% vested in the Companies' matching contribution if actively employed upon reaching early or normal retirement age, or upon termination of employment due to death or disability.

Payment of Benefits

On termination of service, a participant will receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum amount (participants become 100% vested upon death or disability, while still an employee), if the balance does not exceed \$5,000. If the balance exceeds \$5,000, the participant may request a lump-sum payment, installments over a period of not more than his or her assumed life expectancy (and that of his or her beneficiary, if applicable), or ad-hoc distributions.

Due to timing differences there may be benefit payments payable for employees who terminated their employment and requested their distributions prior to the end of the Plan year but had not yet been paid. At December 31, 2024 and 2023, \$923,106 and \$- were payable for these benefits.

NOTE A: DESCRIPTION OF PLAN (Continued)

The Plan was amended to reflect hardship withdrawal provisions which were included in the Bipartisan Budget Act of 2018.

Forfeitures

Forfeited non-vested accounts may be used to pay Plan expenses or reduce employer match contributions. Forfeiture balances at December 31, 2024 and 2023 were \$4,920 and \$-, respectively. In 2024 and 2023, employer contributions were reduced by \$43,017 and \$31,271, respectively, from forfeited non-vested accounts.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. These financial statements include information about the significant assumptions used in determining the fair value of the investments. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value as determined by Empower Annuity Insurance Company of America (Empower). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment custodian and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation/depreciation in fair value of investments is recorded net of fund expenses and Plan maintenance fees. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan did not have any excess contributions for either the 2024 or 2023 plan years.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to the administration of distributions from the plan are charged directly to the participant's account. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through the date the financial statements were available to be issued which was December 14, 2025.

NOTE C: FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The preceding methods describe the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**NOTE D: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Employer contribution portion of their accounts.

**NOTE E: TAX STATUS**

The IRS has determined and informed the Companies by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE F: INFORMATION CERTIFIED BY CUSTODIAN**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower, the custodian, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

**NOTE G: RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain plan investments are shares of pooled separate accounts managed by Empower. Empower is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan. Plan audit fees are paid directly by the Companies; these fees were \$14,875 and \$14,600 for the years ended December 31, 2024 and 2023, respectively.

**NOTE H: RISKS AND UNCERTAINTIES**

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
