### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of the Kovalus 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the year ended December 31, 2024 and for the period December 29, 2023 through December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 and for the period December 29, 2023 through December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors’ Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedules Required by ERISA***

The supplemental schedules, (1) Schedule H, Line 4i - Schedules of Assets (Held at End of Year) as of December 31, 2024 and 2023 and (2) Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## *Notes to Financial Statements*

### **Note 1 - Description of the Plan**

The following description of the Kovalus 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan established on December 29, 2023, covering all employees of Kovalus Separation Solutions, LLC and Relco LLC (together “Company” or “Employer”), except employees covered by a collective bargaining agreement, leased employees, nonresident aliens and interns (“Participants”). Effective April 1, 2024, the Plan was amended to allow interns to participate. Employees become eligible to commence salary deferrals once they have attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Investment options available under the Plan are determined by fiduciaries. Substantially all investments are participant-directed.

#### **Plan Transfer**

Effective December 29, 2023, as part of a divestiture or spin-off from the Koch Industries Employees’ Savings Plan (in 2024 the Plan name changed to Koch Employees’ Savings Plan), the Plan Sponsor authorized the transfer of participant accounts. Accordingly, \$47,641,718 of Plan assets were transferred into the Plan during the period December 29, 2023 through December 31, 2023.

#### **Participant Contributions**

Participants may elect to defer up to 75% of their compensation, subject to dollar limits set by Federal law. Eligible employees are automatically enrolled in the Plan to defer 6% of their compensation once they meet the requirements of eligibility unless an alternative election is made. Participants who have reached the age of 50 by the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute amounts to the Plan representing distributions for other qualified plans (“Participant Rollovers”).

#### **Employer Contributions**

##### **Employer Matching Contributions**

The Company contributes 100% of the first 6% of eligible compensation that all Plan participants contribute to the Plan. In order to receive Employer matching contributions, participants must complete twelve months of service, as defined and begin on the first day of the month following eligibility requirements being met. All participants in the Plan as of December 29, 2023 became immediately eligible. For the year ended December 31, 2024, the Employer matching contribution totaled \$1,795,166. There were no Employer matching contributions made for the period December 29, 2023 through December 31, 2023.

#### Employer Contributions (Continued)

##### Employer Nonelective Contributions

The Company shall make additional nonelective profit sharing contributions. Such contributions are allocated by percentages of compensation based on years of service as identified below. For the year ended December 31, 2024, Employer nonelective profit sharing contributions totaled \$1,504,531. There were no Employer nonelective profit sharing contributions made for the period December 29, 2023 through December 31, 2023.

Less than 5 years of service	3%
At least 5 years but less than 10 years of service	4%
10 or more years of service	5%

The Company may contribute an amount which it designates as a qualified nonelective Employer contribution for any permissible purpose, as defined in the Plan document. For the year ended December 31, 2024 and for the period December 29, 2023 through December 31, 2023, no qualified nonelective employer contributions were made.

#### Participant Accounts

Each participant's account is credited with their contributions, allocations of Employer contributions and Plan investment earnings/losses thereon and charged with administrative expenses, as applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer discretionary nonelective profit sharing contributions and Employer matching contributions are subject to a vesting schedule based on years of vested service.

1 year of service	20%
2 years of service	40%
3 years of service	60%
4 years of service	80%
5 or more years of service	100%

All eligible employees that spun out of the Koch Industries Employees' Savings Plan on December 29, 2023 are 100% vested in the Employer matching contributions and Employer profit sharing contributions.

### **Note 1 - Description of the Plan (Continued)**

#### ***Payment of Benefits***

Participants are entitled to their vested account balance upon death, disability, retirement or termination of employment. A participant may elect to withdraw any portion of their distributable vested interest in their account in the form of either a lump-sum distribution or an installment payment. In-service withdrawals from a participant's vested account balance are permitted upon the attainment of age 59½. Hardship withdrawals (\$500 minimum) may be taken from the sources identified in the Plan document and cannot exceed the amount to meet the immediate financial hardship.

If a participant's vested account balance is equal to or less than \$5,000, the Plan administrator will direct the Trustee to distribute the amount to the Participant in a lump sum without the Participant's consent. If the vested account balance is greater than \$5,000, the Participant may delay their distribution until they are required by law to receive Required Minimum Distributions.

#### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are generally up to five years (up to 15 years for the purchase of a primary residence). Participants may only have two loans outstanding at a time. Loans are secured by the vested balance in the Participant's account and bear interest at a rate commensurate with local prevailing rates charged by other lenders for loans which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions.

#### ***Plan Administration***

The Employer is the Plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan.

#### ***Administrative Expenses***

Plan expenses are paid either by the Plan or the Employer. Expenses that are paid directly by the Employer are excluded from these financial statements. Individual participant accounts are charged directly for notes receivable from participants' recordkeeping and benefit disbursement processing fees, if applicable, and terminated participants pay an annual maintenance fee. In addition, certain investment related expenses are included in net appreciation in fair value of investments.

#### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$53,417 and \$0, respectively. These amounts may be used to offset Plan expenses and to reduce Employer contributions. For the year ended December 31, 2024, the Plan utilized \$1,612 to offset Plan expenses. For the period December 29, 2023 through December 31, 2023, the Plan did not utilize any forfeitures to offset Plan expenses or to reduce Employer contributions. Subsequent to year-end, the Plan utilized \$59,781 to reduce Employer matching contributions and Employer nonelective profit sharing contributions related to the year ended December 31, 2024.

### **Note 2 - Summary of Significant Accounting Policies**

#### ***Basis of Presentation***

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

#### ***Contributions***

Contributions from Plan participants and the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Benefits Paid***

Benefit are recorded when paid.

#### ***Subsequent Events***

The Plan has evaluated subsequent events through December 19, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

### **Note 3 - Information Certified by Trustee and Custodian**

Plan investments are held by Fidelity Management Trust Company (“Fidelity”), the Plan’s trustee and custodian. The fair value of investments as of December 31, 2024 and 2023, and all investment transactions for the year ended December 31, 2024 and for the period December 29, 2023 through December 31, 2023, including interest and dividends, and net appreciation in fair values, are reported to the Plan and certified as complete and accurate by Fidelity. Information included in the supplemental Schedules of Assets (Held at End of Year) and notes receivable from participants have also been derived from information certified by Fidelity.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental Schedules of Assets (Held at End of Year). Participants may direct their contributions to any of the Plan’s investment options.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

### Note 4 - Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Mutual Funds and Self-Directed Brokerage Accounts

Valued at the daily closing price as reported by the fund. Mutual funds and self-directed brokerage accounts that consist of open-end mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds and self-directed brokerage accounts held by the Plan are deemed to be actively traded.

### Note 5 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events, such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### ***Note 6 - Related-Party Transactions and Party-in-Interest Transactions***

Plan investments are managed by Fidelity, the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. During the Plan year ended December 31, 2024, \$82,866 of administrative expenses were incurred by the Plan to Fidelity and other service Plan providers. There were no administrative expenses incurred for the period December 29, 2023 through December 31, 2023. In addition, notes receivable from participants are also deemed to be exempt party-in-interest transactions.

### ***Note 7 - Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in all of their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### ***Note 8 - Tax Status***

The Internal Revenue Service (“IRS”) has determined that the prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”) and informed Fidelity of such in a letter dated June 30, 2020. The Plan administrator has adopted the prototype plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### ***Note 9 - Delinquent Participant Contributions***

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the Employer’s general assets. While the Employer remitted all participant contributions to the Plan, contributions of \$18,353 were not remitted within the required time during the year ended December 31, 2024, as reflected in the accompanying Schedule of Delinquent Participant Contributions. The Employer is in the process of calculating and funding lost earnings for the late remittances to the affected participants during the Plan year 2025.
