INDEPENDENT AUDITOR’S REPORT

To the Board of Trustees of the Minor League Baseball Trust
Minor League Baseball Players Health Plan

Opinion

We have audited the accompanying financial statements of the Minor League Baseball Players Health Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Security Act of 1974 (“ERISA”), which comprise the statement of net assets available for benefits as of March 31, 2025, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of March 31, 2025, and the changes in its net assets available for benefits for the year ended March 31, 2025, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Plan Merger

As discussed in Note 10 to the financial statements, the Office of the Commissioners of Baseball approved the plan merger with an effective date of April 1, 2024. This is in pursuant to a collective bargaining agreement between Major League Baseball and the Major League Baseball Players Association, by which the Office of the Commissioner established Minor League Baseball Players Health Plan (“MiLB Players Health Plan”), a multiemployer plan. The Plan merged into the MiLB Players Health Plan and the surviving plan is the MiLB Players Health Plan.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and

fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTE 1 - SUMMARY DESCRIPTION OF THE PLAN

The following description of the Minor League Baseball Players Health Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a complete description of the Plan’s provisions.

General: The Plan provides health and welfare benefits covering substantially all international scouts, field personnel, Minor League players, and their dependents of the participating Major League Baseball clubs (the “Participating Employers”). The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (“ERISA”), as amended.

Benefits: The Plan provides health benefits, life insurance, dental and vision benefits to eligible employees of the Participating Employers. In addition, the Plan provides medical, dental and vision benefits to their enrolled dependents.

The Plan has contracted with Dearborn National Life Insurance Company, Highmark, Inc. Highmark Life Insurance Company and United Concordia to pay life insurance, medical, vision and dental claims incurred under the terms of the Plan and to provide stop loss coverage. Of these contracts, the contracts for medical benefits, vision and voluntary buy up vision are so called “experience-rated” contracts. The premium costs are affected by, among other things, the number and size of claims.

The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”).

Certain benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processor under an administrative service agreement. Eligible claims are reimbursed to the claims processor by the Plan on a monthly basis.

Contributions: Each Participating Employer makes the contributions the Trustees require to fund benefits under the Plan. This generally will not exceed the maximum amounts allowed as a tax deduction by the Internal Revenue Code. Under present law, the Participating Employers are not permitted to deduct amounts for future benefits to current employees.

Employees may contribute specified amounts, determined periodically by the Participating Employer, to cover the premiums for dependent coverage.

Other: Although it has not expressed any intention to do so, the Office of the Commissioner, as the Plan Sponsor, has the right under the Plan to modify the benefits provided to active employees and to terminate the Plan subject to the provisions set forth in ERISA. Participating Employers have the right to discontinue their contributions at any time in accordance with the terms of the Plan and their participation agreements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements are presented in accordance with the American Institute of Certified Public Accountants (“AICPA”) Accounting Standards Codification 965.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Premiums paid are recorded as premium payments in the accompanying Statements of Changes in Net Assets Available for Benefits.

Claim payments are recorded as claims paid in the accompanying Statements of Changes in Net Assets Available for Benefits.

Allowance for Credit Losses

Premium receivables are reported at amounts due from contributing employers and COBRA participants. The Plan evaluates collectability in accordance with ASC 326, *Financial Instruments—Credit Losses*. Based on this evaluation, management has determined that all premium receivables are fully collectible; therefore, no allowance for credit losses was recorded as of March 31, 2025.

Subsequent Events

The Plan has evaluated subsequent events through December 3, 2025 the date the financial statements were available to be issued.

NOTE 3 - CASH

Financial instruments that potentially subject the company to concentration of credit risk consist principally of cash deposits. Accounts at each institution are insured by the Federal Deposit Insurance Corporation (“FDIC”) up to \$250,000. At March 31, 2025, the Plan had approximately \$4,894,000 in excess of FDIC insured limits.

NOTE 4 - RATE STABILIZATION FUND

When the total amount of premiums that Highmark Health Services receives in a given year exceeds the cost of claims plus the developed premium, the excess is credited to the Rate Stabilization Fund (the "RSF"). The RSF is taken into account in the calculation of premium payment for future contract periods.

A credit balance may result in a reduction, in an actuarially determined amount, of premium payments that would otherwise be required in future years. Conversely, a debit balance may result in an increase, in an actuarially determined amount, of premium payments that would otherwise be required in future years. In the event this contract is terminated by either party, the Plan will lose all rights, claims, or benefits, whatsoever, to any credit balance remaining in the RSF. In such case, the Plan will not assert any rights of recovery of such credit balance against Highmark Health Services. Furthermore, if a deficit balance remains in the RSF at the time of termination of this contract, Highmark Health Services will not assert, any rights of recovery of such deficit balance against the Plan. Neither Highmark Health Services nor the Plan intends to terminate the contract within the foreseeable future. Highmark Health Services refunded \$2,070,323 to the Plan for the excess beyond the four-month RSF corridor for 2022 and 2023.

NOTE 5 - ACCRUED POOLING CHARGE

The Board of Trustees of the Minor League Baseball Trust approved a seven percent (7%) pooling charge for field personnel and international scouts and a six percent (6%) pooling charge for players. The pooling charge is included in the premium rates Highmark Health Services charged to the various Participating Employers. Because the pooling charge is accounted for in the RSF, there is no accrued pooling charge to the Minor League Baseball Trust in 2025. This pooling charge will be used to offset certain claims (in excess of the pool threshold of \$100,000 for players and \$150,000 for field personnel and international scouts) that would otherwise be chargeable against the RSF.

NOTE 6 - BENEFIT OBLIGATIONS

Health costs incurred by participants, their beneficiaries and dependents are covered by insurance contracts maintained by the Plan. It is the present intention of the Plan Sponsor and the Plan to continue to obtain insurance coverage for benefits. As stated in NOTE 1, the Participating Employers are not permitted under present tax law to deduct amounts for future benefits (beyond one year).

NOTE 7 - TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify as a voluntary employees' beneficiary association (a "VEBA") pursuant to Section 501(c)(9) of the Internal Revenue Code. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service, and the Plan Sponsor believes that the Trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

The merger of the Plan into the VEBA did not result in the creation of a new trust, and therefore the VEBA continues to rely on its existing IRS determination letter. No new determination letter was required or obtained in connection with the merger.

NOTE 8 – PATIENT-CENTERED OUTCOMES RESEARCH INSTITUTE FEE

The Patient-Centered Outcomes Research Institute ("PCORI") fee is an assessment arising from the Affordable Care Act ("ACA"). This fee is used to fund the PCORI, a nonprofit organization that funds research intended to help patients make more informed healthcare decisions. The fee is equal to the average number of lives covered during the plan year multiplied by the applicable dollar amount for the year. Although the Office of the Commissioner is the Plan Sponsor, it does not pay Plan expenses or administer the Plan. Since the Plan's Board of Trustees (the "Board") meets the definition of a Plan Sponsor, acts as the Plan Sponsor, exists solely for the purpose of sponsoring and administering the Plan, and has no source of funding independent of plan assets, plan assets may be used to pay the PCORI fee.

NOTE 9 - ADMINISTRATIVE EXPENSES

Legal and accounting fees, as well as all other administrative expenses, have been paid by the Minor League Baseball Trust.

NOTE 10 - PLAN MERGER

Effective April 1, 2024, pursuant to a collective bargaining agreement between Major League Baseball and the Major League Baseball Players Association, the Office of the Commissioner established Minor League Baseball Players Health Plan ("MiLB Players Health Plan"), a multiemployer plan. The MiLB Players Health Plan provides medical, dental, vision, and life insurance benefits to the Minor League players and certain benefits to other employees of Participating Employers. The Plan merged into the MiLB Players Health Plan and the surviving plan is the MiLB Players Health Plan. As a result, all assets and liabilities of the Plan were transferred to MiLB Players Health Plan. The total net assets of \$10,609,138 was transferred in as of April 1, 2024.
