Basis for Opinion

The Plan was amended to terminate the Plan effective July 29, 2022 and management determined that liquidation is imminent as of that date. As a result, the Plan changed its basis of accounting to the liquidation basis as of the plan termination date. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

1. Description of the Plan

The following brief description of the Retirement Income Plan for Employees of Woodstock Resort Corporation (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan was a noncontributory, defined benefit pension plan covering employees of The Woodstock Resort Corporation (the “Plan Sponsor”), as described below. The Plan was established as of July 1, 1974 to provide retirement benefits and restated effective January 1, 2021. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan covered all full-time employees hired on or before July 31, 2007 who accrued six months of service and worked 30 hours per week on a regularly scheduled basis, and all part-time employees hired on or before July 31, 2007 who worked 1,000 hours in their first anniversary year or 1,000 hours in a subsequent calendar year. Entry into the Plan was frozen effective July 31, 2007.

Effective December 31, 2008, the Plan Sponsor amended the Plan to cease the accrual of any future benefits and freeze the Plan. Eligible participants continued to earn additional years of vesting service after the Plan was frozen, and all participants became fully vested.

Termination

On October 10, 2017, the Plan Sponsor resolved to terminate the Plan (“Plan Termination”). The Plan was amended to terminate effective July 29, 2022. The Plan Sponsor filed for regulatory approval and received an acknowledgement letter from the Pension Benefit Guaranty Corporation dated March 20, 2023 as well as a determination letter from the Internal Revenue Service (“IRS”) dated January 31, 2024.

In May 2024, the Plan purchased a group annuity contract on behalf of the Plan participants with Midland National Life Insurance Company (“Midland”) for commencement of benefits on July 1, 2024. The annuity is for the purchase of benefits from the Plan and represents contracts under which Midland is obligated to pay benefits to named employees or their beneficiaries.

All assets of the Plan were either transferred to Midland or distributed to participants of the Plan by December 19, 2024. As a result, the Plan ceased to exist after December 19, 2024.

Pension Benefits

Employees with five years of service were entitled to annual pension benefits beginning at the normal retirement age (65) equal to their final average compensation, multiplied by 1.25% times the participant's years of benefit accrual service. Final average compensation is the average of the five highest consecutive years of annual basic compensation, plus overtime and incentive earnings, out of the last 10 years before December 31, 2008. In addition, a participant who earned benefits prior to July 1, 1974 received benefits using the previous formula, as defined in the Plan document, if this amount is greater. The Plan permits early retirement at age 55. Employees could elect to receive their pension benefits in the form of a joint and survivor annuity, life annuity payable monthly, or a lump-sum amount determined by the present value of a participant's benefit when payment does not exceed \$5,000.

Death and Disability Benefits

If an active employer died at 55 or older, a death benefit equal to the value of the employee's accumulated pension benefits was paid to the employee's beneficiary. Active employees who became totally disabled received annual disability benefits under the Plan Sponsor's long-term disability plan. Disability benefits were paid until the normal retirement age, at which time disabled participants began receiving normal retirement benefits computed as though they had been employed through normal retirement age, with their annual compensation remaining the same as at the time they became disabled.

Funding Policy

The Plan Sponsor agreed to voluntarily contribute amounts as necessary to provide assets sufficient to meet the benefits to be paid to Plan participants. The Plan has met the minimum funding requirements. Prior to the Plan liquidation on December 19, 2024, it was determined that the Plan was overfunded by \$703,545 which was transferred to the Plan Sponsor.

Vesting

Employees became fully vested in accrued benefits after five years of eligible service under the five-year cliff vesting method and were fully vested upon plan termination.

Administration

The Plan was administered by the trustee of the Retirement Income Plan for Employees of Woodstock Resort Corporation. Principal Trust Company was appointed as a trustee and performed most administrative duties.

Payment of Benefits

Death benefits were paid as an annuity for life with 10 years certain. If the participant died before the end of the 10-year period, payment would continue to the beneficiary until that period ends. A spouse or beneficiary could choose to have the death benefits paid as a single sum. A participant could choose a percentage (50%, 66 2/3%, 75%, or 100%) of monthly income to continue for the lifetime of a named survivor.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

As a result of Plan Termination (see Note 1), and in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), the Plan's financial statements as of December 19, 2024 and December 31, 2023 and for the period ended December 19, 2024 are presented using the liquidation basis of accounting. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts.

The preparation of financial statements in conformity with U.S. GAAP requires the Plan sponsor or plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. These estimates are based on information available at the time the estimates are made. Actual results could differ from those estimates.

The Plan used an actuary to determine the actuarial present value of accumulated benefits. A change in the actuarial assumptions used could significantly change the amount of the actuarial present value of accumulated benefits reported in the financial statements.

Investment Valuation and Income Recognition

U.S. GAAP defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist.

Investment Valuation and Income Recognition (continued)

Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis.

Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the period.

The Plan's investment in pooled separate accounts are valued based on the net asset value ("NAV") of units of the pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the quoted prices of the underlying investments. This practical expedient would not be used if it were determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Each pooled separate account provides for daily redemptions by the Plan at the reported NAV per share, with no advance notification requirement.

Pursuant to U.S. GAAP guidance, investments where fair value is measured using the NAV per share as a practical expedient are not categorized within the fair value hierarchy.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses related to maintaining the Plan were paid by the Plan Sponsor and were excluded from these financial statements. Administrative expenses consist primarily of investment advisory fees. Investment related expenses other than investment advisory fees are included in net appreciation in fair value of investments.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, Schedule H, Part IV, Line 4j – Schedule of Reportable Transactions (liquidation basis) including investments held by the Trustee at December 19, 2024 and December 31, 2023, and net appreciation in fair value of investments for the period ended December 19, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, the Trustee of the Plan, a qualified institution.

4. Actuarial Present Value of Accumulated Benefits

Accumulated benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits for retired or terminated employees or their beneficiaries are generally based on employees compensation during their five highest consecutive years of earnings during the 10 Plan years preceding the frozen accrued benefit date (December 31, 2008). The accumulated benefits for active employees who did not reach five years prior to the frozen accrued benefit date (December 31, 2008) were based on their average compensation during all determination periods prior to December 31, 2008.

Benefits payable under all circumstances; retirement, death, disability, and termination of employment, were included to the extent that they are deemed attributable to employee service rendered through the valuation date.

The actuarial present value of accumulated benefits is determined by an actuary from Principal Financial Group and is the amount that results from applying actuarial assumptions to adjust the accumulated benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation prepared on the liquidation basis at December 31, 2023 were: the interest rate used to discount the obligation was 4.67%; mortality was updated for Plan termination assumptions using either the IRS 417(e) mandated table (for non-retired lump sums) or the Pri-2012 Total Dataset projected with Scale MP-2021 (for current annuitants and non-retired annuitants); inflation assumption was 2.40%; and the valuation factored in assumptions about the form of benefit. There were no changes in actuarial assumptions for the period January 1, 2024 through December 19, 2024. The Plan was liquidated effective December 19, 2024.

5. Tax Ruling

The IRS determined and informed the Plan Sponsor by letter dated January 31, 2024 that the Plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the IRC.

The Plan recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition or disclosure. All tax years since 2021 remain open to examination by the Internal Revenue Service. There are currently no examinations in progress.

6. Party-in-Interest Transactions

Certain investments of the Plan were managed by the Trustee. Therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

Certain employees of the Plan Sponsor, who could be participants in the Plan, performed administrative services for the Plan at no cost to the Plan. Additionally, the Plan Sponsor pays for certain administrative fees for the Plan (note 2).
