NOTES TO FINANCIAL STATEMENTS
JUNE 30, 2025 AND 2024

(1) DESCRIPTION OF PLAN:

The following description of Edgar A. Weber & Company (the Company) Employees Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The financial statements were available to be issued on December 5, 2025, with subsequent events being evaluated through this date.

General -

The Plan is a defined contribution plan covering all full-time employees of the Company who meet the eligibility requirements. Excluded employees are those covered by a bargaining agreement as well as nonresident aliens. In order to be eligible for deferrals and Safe Harbor contributions, employees must be at least twenty one (21) years of age and have completed 3 months of service. In order to be eligible for non-elective contributions, employees must be at least twenty one (21) years of age and have completed 1 year of service. Following satisfaction of age and service requirements, entry dates for profit-sharing are January 1 and July 1 of each year. They are January 1, April 1, July 1 and October 1 for deferrals and Safe Harbor contributions.

Contributions -

Participants may contribute up to 100% of their compensation as defined by the Plan, limited to the maximum amount allowable under the IRS. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans. Employees can amend withholding for bonus payments up to 100% of the bonus amount. The Company has elected to make a 3% Safe Harbor nonelective contribution of eligible compensation. The Company may also make matching contributions on elective deferrals made during the Plan year by eligible participants and catchup contributions. Additional employer matching percentages and profit-sharing amounts may be contributed as determined by the Company.

Upon enrollment in the Plan, participants may direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options daily. Contributions are subject to certain limitations.

Participant Accounts -

Each participant's account is credited with the participant's elective contribution, employer's matching and discretionary contributions, rollovers, and earnings thereon. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) DESCRIPTION OF PLAN: (Continued)

Vesting -

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in the Company's contributions after six years of credited service. A year of service, for vesting purposes, is defined as a Plan year in which the employee completes 1,000 hours of service. Participants are always 100% vested in their accounts attributable to salary deferrals (including catch-up contributions), rollover contributions, and safe harbor contributions. Participants become fully vested if they attain Normal Retirement Age, or if they die while employed by the Company. Vesting in the Company's discretionary matching contributions portion of participant accounts due to termination for reasons other than those previously mentioned are as follows:

Forfeited Accounts -

Forfeited balances of terminated participants' non-vested accounts are used to reduce administrative expenses and employer contributions. At June 30, 2025 and 2024, forfeited non-vested accounts totaled \$8,630 and \$14,391, respectively. The Company used \$14,594 of forfeitures to reduce the Company's contribution to the Plan for the year ended June 30, 2025.

Participant Loans -

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than one note outstanding at a time. The maximum loan term is five years, unless it is for the purchase of a principal residence, which may permit a longer repayment term. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates charged by commercial lending institutions, as periodically determined by the Plan administrator. Interest rates applicable to all outstanding loans range between 4.25% and 9.50%.

Payment of Benefits -

Participants withdrawing during the year for reasons of minimum required distributions, disability, retirement, death, or termination of employment are entitled to their vested account balance. If withdrawing participants are not entitled to their entire account balance, the amounts not received are forfeited. Benefit payments are made in the form of a lump sum payment if the amount does not exceed \$5,000. Amounts over \$5,000 can be paid in installments if elected. Hardship withdrawals are not permitted. Normal retirement age and date is 65. Early retirement is not applicable.

(2) SUMMARY OF ACCOUNTING POLICIES:

Basis of Accounting -

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates -

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income -

Investments are reported at fair value. Shares of registered investment companies are valued based on the quoted market prices of the shares held by the Plan at year end. Gain or loss recognized from the disposition of an investment held at the beginning of the year is equal to the difference between the market value of the disposed asset at the beginning of the year and the proceeds from disposition. Gain or loss realized from the disposition of an investment acquired during the year is equal to the difference between the cost and the proceeds from disposition. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation or depreciation in the market value of an investment held both at the beginning and end of the year is equal to the difference between the market value at the beginning and end of the year. Appreciation or depreciation in the market value of an investment acquired during the year and held at the end of the year is equal to the difference between the cost and the market value of the investment at the end of the year.

Notes Receivable from Participants -

Notes receivable from participants are measured at their unpaid principal balances plus accrued interest, if any.

Payment of Benefits -

Benefits are recorded when paid.

Administrative Expenses -

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid by the Company. Administrative expenses of \$232,679 were paid by the Plan during the year ended June 30, 2025.

(3) PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(4) FAIR VALUE MEASUREMENTS:

The Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(4) FAIR VALUE MEASUREMENTS: (Continued)

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2025 and 2024.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Shares in registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) INCOME TAXES:

The Plan has adopted the Non-Standardized Profit Sharing Plan with CODA, sponsored by FIS Business Systems LLC. The Plan has received a determination letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the plan is qualified under the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan's tax counsel believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that it is no longer subject to income tax examinations for fiscal years prior to 2022.

(6) CERTIFIED INVESTMENTS:

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2025 and 2024, and net appreciation/depreciation in fair value of investments, interest and dividends for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC (the trustee of the Plan).

(7) RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(8) PARTY-IN-INTEREST TRANSACTIONS:

Participants covered under the Plan are considered to be parties-in-interest. Participant loans in the amounts of \$351,786 and \$234,405 at June 30, 2025 and 2024, respectively, are considered to be party-in-interest investments.
