INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the accompanying financial statements of Buchanan General Hospital (the Hospital) Medical and Dental Care Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act (ERISA), which comprise the statements of net assets available for benefits as of March 31, 2025, and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Buchanan General Hospital Medical and Dental Care Plan as of March 31, 2025, and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Note 1. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Plan benefits

Plan liabilities for health claims incurred prior to March 31, 2025 and 2024, but paid subsequent to March 31, 2025 and 2024, are accrued in accordance with generally accepted accounting principles.

Note 2. PLAN DESCRIPTION

The following description of the Buchanan General Hospital Employee Medical and Dental Care Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan provides medical and dental benefits covering substantially all full-time and part-time employees of Buchanan General Hospital (the Hospital). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Hospital oversees governance of the plan.

Benefits

The Plan provides health benefits (medical, hospital, surgical, major medical) and dental benefits (preventive, basic, major dental) covering active employees of Buchanan General Hospital after 30 days of service. Active means an employee who normally is scheduled to work at least thirty (36) hours per week for full-time or fifteen (15) hours per week for part-time.

Current health claims of active participants and their dependents are provided by the participants' contribution and the Hospital's contribution from its general assets. Stop-loss insurance provides for claims in excess of \$100,000 for a specific insured person or \$1,000,000 maximum for the group on an annual calendar year basis.

Contributions

The full-time participants contribute \$113.00 bi-weekly for single medical coverage, \$200.00 for subscriber plus one medical coverage, and \$372.50 for family medical coverage.

The full-time participants contribute \$3.28 bi-weekly for single dental coverage, \$4.76 for subscriber plus one dental coverage, and \$8.04 for family dental coverage.

The full-time participants contribute 100% bi-weekly for single and family vision coverage.

Note 3. FUNDING POLICY

The Plan agreement provides that Buchanan General Hospital pay health and dental benefit claims in accordance with the provisions of the Plan. Employees contribute a specified amount for single, subscriber plus one, or family coverage.

Note 4. PARTIES IN INTEREST

Contributions receivable of \$197,069 and \$185,686 at March 31, 2025, and 2024, respectively, represents amounts due from Buchanan General Hospital, the Plan sponsor.

Administrative expenses paid by Buchanan General Hospital on behalf of the Plan amounted to \$119,193 and \$111,446 for the years ended March 31, 2025 and 2024, respectively.

The Plan sponsor paid professional fees on behalf of the Plan, amounting to \$8,500 and \$8,500 for the years ended March 31, 2025 and 2024, respectively.

Note 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

Note 6. INSURANCE

The Plan's excess loss insurance policy through American United Life provides for reimbursements to the Plan for an individual's claims in excess of \$100,000 for the year and \$2,000,000 in a lifetime. Aggregate stop-loss for the Plan is \$1,000,000 for any plan year.

Note 7. SUBSEQUENT EVENTS

The Plan did not have any other subsequent events through December 15, 2025, which is the date the financial statements were available to be issued (or "were issued" based on client facts and circumstances) for events requiring recording or disclosure in the financial statements for the year ended March 31, 2025.
