Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of I.U.P.A.T. Local 447 Deferred Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following description of the I.U.P.A.T. Local 447 Deferred Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan was originally established as a money purchase pension plan on May 1, 1984, and most recently amended effective May 22, 2023. The Plan covers employees who are represented for collective bargaining purposes by the Local Union #447 I.U.P.A.T. AFL-CIO (Local 447), and who are employed by an employer who has executed a collective bargaining agreement with Local 447. The Plan also covers Local 246 members of the International Union of Painters & Allied Trades, District Council 81, which Local 447 is a member, and the International Association of Heat and Frost Insulators and Asbestos Workers Local No. 74 (Local 74). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Contributions from employers are determined each month and are due by the 30th day of the following month. The participating employers contribute rates based on the respective collective bargaining agreements to which they are subject. Other members of District Council 81 can opt out of the District Council 81 Health & Welfare Plan and have their hourly contribution to the Health & Welfare Plan contributed to this Plan. In addition, covered employees may elect to defer a portion of their compensation (in \$.50 per hour increments) and have it contributed to the Plan (401(k) contributions). Participants may also contribute amounts representing distributions from other qualified plans or IRAs. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

The Plan has reciprocal agreements with other local unions. In accordance with these agreements, the Plan is required to remit funds received and is entitled to receive funds from participating employers on behalf of temporary employees to and from the employees' participating local unions. Reciprocal contributions received and paid are recorded as employer contributions in the statements of changes in net assets available for benefits.

Participant Accounts

Each participant's 401(k) account is credited with (1) the participant's voluntary contribution and (2) an allocation of the investment earnings (loss) and charged with an allocation of administrative expenses. Each participant's nonelective account is credited with (1) participating employer contributions made in their name and (2) an allocation of the investment earnings (loss) and charged with an allocation of administrative expenses. Allocations are based on participant earnings of account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their elective deferrals plus actual earnings thereon. For employer contributions, participants are 100% vested upon completing two years of service with participating employers, or upon the earliest of the following: reaching normal retirement age, death, or becoming totally and permanently disabled. A participant's vesting percentage in employer contributions is either zero or 100%.

Payment of Benefits

Upon retirement, death, or withdrawal from the trade, a participant may elect to receive vested benefits in either a single lump sum equal to the value of their account, or in installments over various periods not to exceed the life expectancy of the participant and the named beneficiary (a joint and survivor annuity). Hardship distributions are also allowed.

If a participant leaves covered employment as a result of termination, the participant can make an application for a lump-sum distribution of the amount of the participant's individual account and will receive distributions the earlier of (1) 24 months after the participant last worked in covered employment requiring employer contributions on behalf of the participant to the Plan or (2) the participant has attained the age 59½ with the distribution paid six months after the participant last worked in covered employment requiring employer contributions for the participant to the Plan.

Administrative Expenses

Administrative expenses are paid by the Plan.

Forfeited Accounts

Forfeited, nonvested accounts totaled \$-0- for each of the Plan years ended April 30, 2025 and 2024. There were \$-0- of forfeitures transferred to the cash account and used to pay administrative expenses for the years ended April 30, 2025 and 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates in Preparing Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) of investments includes both realized gains and losses from sales and unrealized market gains and losses.

Contributions Received and Receivable

Contributions due but not paid prior to year-end are recorded as contributions receivable. Reciprocal contributions receivable is also included with employer contributions receivable. Delinquent contributions and payroll audit findings are individually analyzed for collectability. As of April 30, 2025 and 2024, all outstanding contributions receivable amounts are reported net of contributions considered uncollectible by the Plan.

Contributions are subject to audit, and any delinquent accounts are subject to liquidated damages. At any point in time, certain accounts are receivable by the Plan due to audit results and may be subject to various disputes or legal actions. Such accounts receivable are recognized based on the ultimate collectability as determined by Plan management. As of April 30, 2025 and 2024, the allowance for credit losses were insignificant.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statements of net assets available for benefits.

Concentration of Credit Risk

The Plan maintains its cash balances in two commercial banks. Accounts at the institutions are insured by the FDIC up to \$250,000. At times, cash balances may be in excess of the insured limits. Cash balances are not allocated to participants as of April 30, 2025 and 2024.

Subsequent Events

Management evaluated subsequent events through December 10, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

John Hancock Trust Company LLC, the qualified institution, has certified to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of April 30, 2025 and 2024, and the related investment activity reflected the statements of changes in net assets available for benefits for the years ended April 30, 2025 and 2024, and the schedule of assets (held at end of year) as of April 30, 2025.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 6 PLAN TAX STATUS

The Plan obtained its latest determination letter on July 17, 2015, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan trustees and counsel believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION

Although the Plan is expected to continue indefinitely, it may be terminated at any time upon written notice to all parties concerned, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 CONCENTRATION

In 2025, there was one contractor that represented 30% of the total employer contributions. In 2024, there were two contractors that represented more than 35% of the total employer contributions.
