**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Walker Sands, LLC Employee Health and Welfare Benefits Plan, (the "Plan") provides only general information. Effective January 1, 2024 (inception), the Plan changed its name multiple times from Walker Sands, LLC Employee Benefits Plan to Walker Sands, LLC Group Medical Plan then changed again to the current Plan name. Interested parties should refer to the plan document and related amendments for a more complete description of the Plan's provisions.

1. General

The Plan was established effective January 1, 2024 (inception) and is a health and welfare defined benefit plan covering all eligible employees of Walker Sands, LLC (the "Plan Sponsor" and "Company"). Employees are eligible to participate upon hire if they are full-time and regularly work 30 or more hours of service per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan established a trust for medical benefits with an accounting year January 1, 2024 to December 31, 2024.

2. Consortium

The Plan belongs to a Consortium, which is designed to provide cost effective employee benefit programs for members and is a self-funded group-purchasing consortium that offers essential health benefit coverages for its members as defined in the Plan document. Coverage programs are developed specific to each member's healthcare needs and the related premiums for coverage are determined through the application of uniform underwriting criteria. Variable plan options are available to members. These plans vary primarily by deductibles, coinsurance levels, office visit co-pays, and out-of-pocket maximums.

The Consortium is a self-insured program with stop loss and aggregate reimbursement arrangements in place to limit the liability of the Plan (Note C). The premium charged and collected from each of the members is fully funded.

Plan Trustees sign an agreement, which provides that each member agrees to pay all funding rates associated with the coverage it selects; as such, funding rates are set and billed to the members by various carriers, and premiums are billed and paid on a monthly basis. The assigned funding rates consist of administrative fees, stop loss and aggregate premium expense, expected claim costs, and reserves.

The Consortium has an agreement with Benecon Group, Inc. to provide agent management, underwriting, claims management, risk management, accounting, system support services, and consulting services.

2. Consortium (Continued)

The Plan has an obligation to reimburse for all paid claims (less than the specific stop loss) up to the cumulative maximum liability limit (aggregate). The obligation to reimburse for any excess over the cumulative maximum liability limit is only to the extent that in any month there is a positive difference (monthly surplus) between cumulative paid claims and the cumulative maximum liability limit (aggregate). There is no obligation to pay any excess to the aggregate (cumulative monthly liability limit) other than through this funding arrangement. Monthly timing of paid claims may be such that the Plan may need to advance a payment that exceeds cumulative claims funds deposited to date until an aggregate claim reimbursement is received.

3. Contributions

The cost will be paid in a discretionary manner in part by the Plan Sponsor and in part by participants through pre-tax contributions on a monthly basis.

4. COBRA Insurance Arrangements

The Plan allows for coverage for a specified time period when a qualifying event occurs as defined by the Plan document under the Consolidated Omnibus Budget Reconciliation Act of 1985 ("COBRA"). If a participant's medical coverage terminates because of a qualifying event, then the participant and eligible beneficiaries may have the right to purchase continued coverage for a temporary period of time. COBRA related claims are processed in a similar manner to all other claims (Note A-2) when the event causing the Plan to become obligated to pay COBRA benefits occurs, however the employee bears the sole burden for these costs.

5. Health Savings Account Arrangements

The Plan offers Health Savings Account ("HSA") options for eligible participants to cover qualified expenses up to certain limits. Under the arrangement, eligible employees may contribute to their individual HSAs, and the Plan Sponsor makes matching contributions up to certain limits. The Plan does not maintain these HSA funds in a trust under its control; funds are held in individual third party administrator custodial HSA accounts in the employees' names. As a result, the Plan does not record any HSA account activity, and this activity is excluded from these financial statements because the Plan is not obligated to pay these benefits.

6. Payment of Benefits

The Plan provides access to essential health benefits as defined in the Plan document, to eligible participants and to their beneficiaries and covered dependents. These benefits of active participants, dependents, and beneficiaries under the Plan are provided through insurance policies within the trust. Benefits are administered under contracts with certain providers.

7. Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third parties for claims processing and other management fees based on the number of employees enrolled. These expenses are reported on the statement of changes in net deficit available for benefits as administrative expenses. Certain administrative expenses are paid by the Plan Sponsor and excluded from these financial statements. The Plan pays fees that are based on the number of employees enrolled.

8. Interest Bearing Cash

The Plan maintains a cash account that is interest-bearing. This account is held by the Plan's trustees and earns interest at a nominal variable rate based on prevailing market conditions. Interest income earned on this account is credited directly to the Plan and is included in interest income in the accompanying statement of changes in net deficit available for benefits.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. Claims and insurance premiums are recorded as paid.

2. Use of Estimates

In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net deficit during the reporting period. Actual results could differ from those estimates.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**3. Payment of Benefits**

Claim payments to participants are recorded when paid in accordance with the provisions of the Plan. Claims payable by the Plan shall be recognized as a liability when they are due and payable in accordance with the terms of the Plan.

Claims incurred, but not reported ("IBNR") at year-end are estimated for Plan obligation disclosure purposes based on historical claims experience and other relevant factors (Note D). The IBNR estimate is based on historical claims run-out patterns, adjusted for recent claims trends and changes in enrollment.

The Plan maintains a stop loss insurance policy that limits the Plan's exposure for individual participant claims and, in certain cases, aggregate claims (Note C). Recoveries under the stop loss policy are recorded when the reimbursable claim is paid. For the year ended December 31, 2024, stop loss premium related reimbursements totaled approximately \$310,000 and are shown net of claim payments on the accompanying changes in net deficit available for benefits.

The Plan receives rebates or refunds from insurance carriers. Such rebates are recognized as reductions of claim expense when earned (Note C). For the year ended December 31, 2024, rebates totaled approximately \$65,000 and are shown net of claim payments on the accompanying changes in net deficit available for benefits.

**4. Administrative Expenses**

Administrative expenses are recorded as incurred.

**NOTE C - STOP LOSS INSURANCE**

The Plan maintains stop loss insurance coverage to limit its exposure to large individual claims and, in certain cases, aggregate claims under the self-insured benefit programs. Specific stop loss coverage protects the Plan against claims for individual participants that exceed a predetermined threshold. Aggregate stop loss coverage protects the Plan if total claims for the Plan exceed a specified aggregate limit. The Plan Sponsor has an annual maximum for eligible claims not to exceed \$790,497, at which point the stop loss insurance will cover the difference between the monthly deductibles and annual maximum (\$1,000,000). The Plan Sponsor paid \$943,081 for the year ended December 31, 2024 relating to premiums which covers losses, claims and fees.

The Plan's deficiency of net assets compared to benefit obligations is expected to be funded through future contributions by the Plan Sponsor and Plan participants.

**NOTE E - TAX STATUS**

The trust established under the Plan to hold the Plan's assets is not qualified as tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code ("IRC"), and accordingly, the trust's interest income is subject to income taxes. As such, the trust is required to file Form 1041, U.S. Income Tax Return for Estates and Trusts with the Internal Revenue Service ("IRS"), for its taxable income. Accordingly, no provision for income taxes has been included in the Plan's financial statements as taxable income and the related tax expense for the year ended December 31, 2024 is deemed insignificant.

Accounting principles generally accepted in the United States of America ("U.S. GAAP") require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provisions of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the plan's participants.

NOTE G - RISKS AND UNCERTAINTIES

The actuarial present value of accumulated Plan benefits is reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

NOTE H - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Claims processing and other management functions are performed by the Consortium, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

The Plan Sponsor provides certain accounting and other exempt administrative services for the Plan but receives no reimbursement from the Plan for these services. The Plan has several arrangements with service providers. These transactions are exempt party-in-interest transactions under ERISA.

NOTE I - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through December 11, 2025, the date that these financial statements were available to be issued. Plan management has determined that no events or transactions, other than disclosed below, have occurred subsequent to the statement of net deficit available for benefits date that require disclosure in the financial statements.

Effective January 1, and March 1, 2025, the Plan was amended to change certain essential health benefits as defined by the related amendments. Eligibility and other pertinent Plan criteria remain unchanged. Interested parties should refer to the related plan amendments for a more complete description of the Plan's provision changes.
