Opinion

1. Plan Description

The Milwaukee Electrical Joint Apprenticeship and Training Plan (“Plan”) was organized to support education and training programs for electrical apprentices and journeymen who are under its jurisdiction. Contributions are made by electrical contractors based on a contractually agreed upon percentage between 1.00% and 1.85% of total employers' productive payroll depending upon craft. For a complete description of the Plan, see the Summary Plan Description available in Plan office.

2. Summary of Significant Accounting Policies

Basis of Reporting

The accounts of the Plan are maintained on the accrual basis of accounting.

Accounts Receivable

Accounts receivable are reported at contract value, less our estimate for uncollectible amounts based on our experience relative to the total population of accounts receivable.

Investment Valuation and Income Recognition

Accounting principles generally accepted in the United States of America (U.S. GAAP) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – Inputs other than quoted prices that are observable for securities, either directly or indirectly. Examples include matrix pricing utilizing yield curves, prepayment speeds, credit risks, etc.; quoted prices for similar assets in active markets; and inputs derived from observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Realized gains and losses and unrealized appreciation and depreciation of plan assets are reported in the statement of changes in net assets available for benefits as net appreciation in fair value of investments.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investment Valuation and Income Recognition (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Inventories

Inventories on hand are stated at cost on a first-in, first-out basis.

Property and Equipment

Purchased property and equipment is recorded at cost and contributed property and equipment is recorded at fair value. Depreciation and amortization is provided on the straight-line method over the estimated useful lives of the assets of three to ten years for equipment and furniture, fifteen years for leasehold improvements, and thirty-nine years for buildings.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Equivalents

The Plan considers demand deposit, savings and money market fund accounts to be cash and equivalents for purposes of the statements of cash flows. Short-term investments without regard to original maturity are not considered cash and equivalents for purposes of the accompanying statements of cash flows.

Certificates of Deposit

Certificates of deposit totaling \$250,000 and \$500,000 at May 31, 2025 and 2024, respectively, are presented in the accompanying financial statements. The certificates bear interest ranging from 3.70% to 5.35% for the year ended May 31, 2025, and have maturities of between one months and six months, with penalties for early withdrawal. Any penalties for early withdrawal would not have a material effect on the financial statements. Interest earned on certificates of deposit totaled \$20,270 and \$22,477 for the years ended May 31, 2025 and 2024, respectively.

Tax Status

The Plan obtained its latest determination letter on August 11, 1995, in which the Internal Revenue Service stated the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Department of Labor or Internal Revenue Service. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of May 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

Management of the Plan has evaluated all subsequent events through November 13, 2025 for possible inclusion as a disclosure in the notes to the financial statements. The Plan has no subsequent events that require disclosure in the notes to the financial statements.

3. Contractor Contributions

Contractor contributions are received from the Milwaukee Electrical Construction Industry Board (Board) which collects the funds on behalf of the Plan. The Board's cash basis records are prepared directly from reports submitted by contractors. The contractors' reports are audited on a three-year rotating basis. The Plan's intent is to fund all costs out of current contributions and accumulated assets.

4. Investment Manager

On November 23, 1993, the Plan entered into an investment manager agreement with US Bank, N.A. At May 31, 2025 and 2024, all investments were held by the investment manager.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks of loss such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

6. Scholarship Loan Agreements

The Plan has entered into demand scholarship loan agreements with its apprentices. Terms of the loans require that the amounts due the Plan for the direct and indirect costs of the apprentices' training are reduced over a ten-year period commencing with the attainment of journeyman status. Payments under the loans are not demanded unless the apprentice fails to reach journeyman status or fails to complete ten years of service as a journeyman. The loans do not provide for interest unless a demand for payment is made.

Prior to demand repayment by the Plan, the contingent nature of the loans precludes the recording of these loans as an asset of the Plan. Accordingly, these loans are not reflected in the financial statements. After demand repayment is made by the Plan, a scholarship loan receivable is reflected in the financial statements.

7. Operating Leases – Plan as Lessor

Effective September 1, 2019, the Plan entered into a lease agreement with the Association, which requires rent payments of \$4,661 per month through August 31, 2029. The Plan has deferred rent in the amount of \$174,621 and \$215,709 at May 31, 2025 and 2024, respectively. Future expected lease revenue and recognition of deferred rent revenue is as follows:

Effective May 17, 2021, the Plan entered into a lease agreement for office space it rents to the Plumbing Mechanical Sheet Metal Contractors' Alliance, Inc. (Tenant). The lease requires monthly payments of \$5,000. On June 1 of each year, 2022 through 2025, the monthly rent shall be increased by 2.5%. The Tenant has the option to terminate the lease after three years, with written notice at least 90 days prior to expiration. Future expected lease revenue is as follows:

8. Related-Party Transactions

Administrative services are provided by the Association, a related employer association. Charges for these services include staff, office supplies used, and code consulting services. Total charges paid and accrued for the years ended May 31, 2025 and 2024 were \$33,018 and \$32,024, respectively. Electronic data processing services are provided by a leasing arrangement with Electrical Construction Industry Pension Plan, a related affiliated employee benefit plan. Postage and office supplies are also charged by Electrical Construction Industry Pension Plan. Total charges paid and accrued to the Electrical Construction Industry Pension Plan for the years ended May 31, 2025 and 2024 were \$6,804 and \$6,593, respectively.

9. Retirement Plans

NEBF Plan - The Plan makes contributions to the National Educational Benefit Fund on a percentage of payroll basis for certain covered employees. Plan contributions for the years ended May 31, 2025 and 2024 were \$13,805 and \$19,700, respectively.

IRA Plan - The Plan adopted a qualified IRA plan, which covers all regular full-time employees' and instructors' annual wages in excess of \$450, and provides for employer contributions of 15% of salary. Contributions for the years ended May 31, 2025 and 2024 were \$63,808 and \$68,181, respectively.

10. Termination of the Plan

When the obligations of all the employers to make contributions to the Plan terminate, or the Plan otherwise terminates, the trustees shall determine the disposition of any assets remaining in the trust after all expenses of the Plan have been paid; such distributions shall be made only for the benefit of former participants and for the purposes set forth in the Plan.

The distributions shall be made in accordance with the then present law, so as to not adversely affect the tax-exempt status of the Plan.

Credit Risk

The Plan's bank balances occasionally exceed the Federal Deposit Insurance Corporation (FDIC) insurance coverage limit. Cash equivalents and investments held at the trust company are not covered by FDIC insurance.

Contributions

A concentration exists relative to contributions in that they relate to work performed predominantly in Southeastern Wisconsin. Consequently, a reduction in work levels in that geographic area could curtail contributions.


