Opinion on the 2025 Financial Statements

Note 1. Description of Plan

The following description of the Retirement Security Plan of Womble Bond Dickinson (US) LLP - Plan D (the "Plan" or "Plan D") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Plan Status

Effective February 28, 2025, the plan administrator resolved to merge all assets into the Womble Bond Dickinson Cash Balance Pension Plan. Assets in the amount of \$3,637,894 were legally transferred out of the Plan as of February 28, 2025. Assets that were legally transferred during the reporting period are recorded as a payable due to another qualified plan to reflect the related settlement obligation.

General

The Plan was established effective January 1, 2024 as a cash balance defined benefit retirement plan covering all eligible equity partners and certain employees of Womble Bond Dickinson (US) LLP (the "Firm"). The Retirement Plan Committee of the Firm manages the operation and administration of the Plan. Charles Schwab Trust Bank ("Schwab"), the trustee, maintains control over the Plan's assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions and Participant Accounts

A hypothetical account is maintained for each participant in which contributions are credited for the benefit of the participant. The contribution credit to the accounts of participants who are equity partners is based on a formula, as set forth in the plan document. The eligible employees participate based on fixed amounts as set forth in the plan document. Each participant's account receives a daily earnings credit based on the underlying performance of Plan assets.

Benefits

A participant may receive a distribution equal to the value of his or her account upon termination of service, disability, or upon reaching age 59½. The value of the participant's account will be equal to cumulative contribution and any earnings credits, subject to a cumulative earnings cap and a minimum floor as defined in the plan document. Distributions may be in the form of a lump sum, or a straight life annuity purchased from an insurance company.

Vesting

Participants become fully vested upon completion of three or more years of service, attainment of normal retirement age, disability, or death while in service, or termination of the Plan by the Firm, whichever occurs first.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded upon distribution. As of February 28, 2025 and December 31, 2024, there were no amounts allocated to accounts of participants who elected to withdraw from the Plan, but had not yet been paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Firm, as provided by the plan document. Certain administrative functions are performed by employees of the Firm. No such employee receives compensation from the Plan.

Subsequent Events

The Firm evaluated the effects subsequent events would have on the financial statements through December 22, 2025, which is the date the financial statements were available to be issued.

Note 3. Funding Policy

Contributions to provide benefits under the Plan are made solely by the Firm. Contributions are accrued based on actuarially determined amounts as determined by the Plan's independent actuary. The Firm met the minimum funding requirements of ERISA for the period from January 1, 2025 through February 28, 2025 and year ended December 31, 2024.

Note 4. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those estimated future periodic payments, including lump-sum distributions, which are attributable under the Plan's provisions to service rendered by participants as of the valuation date. Accumulated plan benefits include benefits expected to be paid to (1) retired or terminated participants or their beneficiaries, (2) beneficiaries of participants who have died, and (3) present participants or their beneficiaries. Benefits under the Plan are based on service and interest credits on the valuation date. The Plan uses a beginning of year valuation date.

The actuarial present value of accumulated plan benefits is determined by October Three, an independent actuary, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal, or retirement) between the valuation date and expected date of payment.

The effect of Plan amendments on accumulated plan benefits is recognized during the plan year in which such amendments become effective.

Note 6. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of assets and liabilities and their placement within the fair value hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds and Exchange Traded Funds

Mutual funds and exchange-traded funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Interest-Bearing Cash

Interest-bearing cash is valued daily at the closing balance as reported by the trustee.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Exempt Party-in-Interest Transactions

Plan investments are held by Schwab, the trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on the fund.

Note 8. Tax Status

The Firm has applied to the Internal Revenue Service to confirm that the Plan meets the qualification requirements set forth in Section 401(a) of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Contingencies and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that material changes in the values of investment securities could occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
