Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Fredrikson & Byron, P.A. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended May 31, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Description of Plan:

The Fredrikson & Byron, P.A. Profit Sharing Plan (the Plan) was established to assist eligible employees to provide for their future security after retirement through employer contributions and employee salary deferrals. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan was established on June 1, 1973, and was most recently restated to the Cycle-3 restatement cycle effective June 1, 2022 on July 18, 2022. There were no substantive changes to Plan provisions. The Plan is a defined contribution plan and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligible employees enter the Plan and become participants on the first day of the month following the hire date with respect to the salary deferral (401(k)) portion of the Plan and after two years of service with respect to the profit sharing portion of the Plan.

Employees who are neither a shareholder, nor an officer of the employer, nor an employee who is designated in his or her employment agreement as an of counsel attorney, are automatically enrolled with a 3% salary deferral which shall increase by 1% annually until it reaches a maximum of 10% unless the employee elects a different salary deferral, or elects not to participate in the Plan.

Contributions:

The employer, at its discretion, may make a profit sharing contribution to the accounts of participants in the Plan who are employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year. The contribution must meet the top-heavy rules as defined by the Plan.

An employer contribution is also allocated to the accounts of participants who have terminated employment during the Plan year on account of death, disability or retirement. Participants should refer to the Plan documents for a more complete description of the profit sharing allocation provisions and other Plan provisions.

Participant benefits:

Amounts credited to each participant's account are generally made available upon death, disability or retirement of the participant, discontinuance of employment, or termination of the Plan.

Vesting:

Contributions to the Plan are fully vested upon receipt.

Investment of contributions:

The Plan permits participants to select among various investment funds. The participant's accounts are then invested, at the participant's direction, in one or more of these funds. If a participant does not select an investment fund, his or her accounts will be invested in the JPMorgan Smart Retirement® Fund Institutional Class Shares. The Plan also permits participants to self-direct the investment of their accounts in a Brokerage-Link® account through Fidelity. A BrokerageLink® account may be invested in Fidelity and non-Fidelity mutual funds, U.S. Treasury securities, all corporate bonds, certificates of deposit, exchange-traded funds, individual common stocks, preferred stocks and short-term investments as stipulated in the Plan document. The Plan does not guarantee any rates of return or investment results.

1. Description of Plan (continued):

Notes receivable from participants:

A participant may borrow from his or her accounts in the Plan for any purpose. However, a participant may not have more than three loans outstanding for purposes other than the purchase of his or her principal residence and one loan outstanding for the purpose of the purchase of his or her principal residence. Loans are limited to the lesser of 50% of his or her vested interest in the plan or \$50,000 less the highest outstanding loan balance during the previous 12-months. In addition to those limitations, a loan cannot be made for less than \$1,000.

Beginning on March 27, 2020, the Plan adopted the CARES Act Loan provisions. These provisions are available for any participant who self-certifies they are a qualified individual as defined by the CARES Act. A loan made during the period of March 27, 2020 through September 23, 2020 can be issued for the lesser of \$100,000 or 100% of their account balance, reduced by the highest outstanding loan balance during the previous 12-months. A CARES Act Loan will have a first payment due on January 2021 and repayment can be up to a five-year period after the first payment. In addition, qualified individuals with an outstanding loan(s) were allowed to delay repayments until January 2021, at which time the loan became amortized with a new loan repayment amount determined.

2. Summary of significant accounting policies:

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are automatically reinvested into the mutual fund from which they were distributed and recorded on the ex-dividend date.

The change in net unrealized appreciation/depreciation of investments held from the beginning of the Plan year to the end of the Plan year is included with realized gains/losses as net investment income reported in the accompanying statement of changes in net assets available for benefits.

Accounting for uncertainty in income taxes:

Management has evaluated tax positions taken by the Plan and concluded it had taken no uncertain position that more likely than not would not be sustained upon examination.

Tax status and Plan amendments:

The Plan restated its plan document for regulatory requirements effective June 1, 2022. Therefore, the Plan Sponsor believes the Plan is designed and operated in compliance with the applicable provisions of the Internal Revenue Code. In 2020, the Plan chose to adopt the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) which provided retirement plans the option to allow COVID-19 related distributions, increase loan amounts, and waive 2020 required minimum distributions as early as March 27, 2020. The Plan was updated to reflect these changes on June 1, 2022.

2. Summary of significant accounting policies (continued):

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes receivable from participants:

Participant loans are classified as notes receivable from participants, which are segregated from Plan investments.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. If participants fail to make payments when they are due under the terms of the loan, the loan is considered to be in default. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Other income:

Other income consists of revenue credits from Fidelity Investments that are used to offset Plan administrative expenses.

Benefits paid to participants:

Participants' benefits payments are recorded when paid.

Concentrations:

A total of approximately 25% and 25% of investments were held in two mutual funds as of May 31, 2025 and 2024, respectively.

Subsequent events:

Management has evaluated for subsequent events through December 19, 2025, the date the financial statements were available for issuance.

3. Certified investments:

The May 31, 2025 and 2024 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the years ended May 31, 2025 and 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the trustee and custodian, Fidelity Trust Management Company, as complete and accurate, as permitted by ERISA Section 103(a)(3)(c).

4. Fair value measurements:

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Levels of the fair value hierarchy under FASB ASC 820 (continued):

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

Mutual funds, money market funds, collective investment trust, and brokerage securities - Valued at the net asset value, which approximates fair value, of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investments at contract value: _____

The Mellon Stable Value Fund, which is a fully benefit responsive common collective trust, consists primarily of underlying investments GICs, synthetic GICs, separate account GICs, variable rate GICs, repurchase agreements, and cash and cash equivalents.

Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value (principal plus accrued interest to date). Withdrawals prompted by certain events may be paid at the market value of the fund's securities, which may be less than principal plus interest accrued to date. The terms of the contracts purchased for the fund prohibit participants from making a direct exchange from this fund to competing funds. Instead, participants must first exchange to a non-competing fund for 90 days. The Fund imposes certain restrictions on the Plan, and the Fund itself may be subject to circumstances that impact its ability to transact at contract value. Contract value represents contributions made to the Fund, plus earnings, less participant withdrawals and administrative expenses. Plan management believes that the occurrence of events that would cause the Fund to transact at less than contract value is not probable.

6. Notes receivable from participants:

Notes receivable from participants mature in one to five years from inception of the loan and include interest from 5.25% to 10.50%. Notes receivable from participants also include ten-year loans from which the proceeds had to be used towards the purchase of a principal residence. The notes are collateralized by the participants' vested account balances.

7. Transactions with parties-in-interest:

Certain Plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Investments is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

8. Plan termination:

The employer has reserved the right to terminate the Plan or to amend the Plan at any time and in any respect. However, no such action may deprive any participant or beneficiary under the Plan of any vested benefit.

9. Risk and uncertainty:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
