Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Notes to Financial Statements

Note 1: Description of Plan

The following description of the Jewish Home and Care Center, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all qualifying employees of Jewish Home and Care Center, Inc., Prospect Congregate Housing, Inc., and Jewish Home and Care Center Foundation, Inc., which are all related organizations (collectively the "Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Eligibility and Participation

Employees of the Sponsor become eligible to participate in the Plan upon attaining the age of 18. To qualify for matching contributions, the employee must attain one year of service.

Contributions

Participants may elect to defer up to 100% of compensation, as defined in the Plan document, not to exceed the limits of the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified plans ("rollovers").

The Sponsor may make discretionary matching contributions up to 3% of participant compensation. The Sponsor may also make discretionary profit sharing contributions to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The contribution rate increases annually by 1% up to a maximum of 10%.

For the year ended December 31, 2024, the Sponsor matched 100% of participant elective contributions up to 3% of participant compensation contributed to the Plan.

There were no discretionary profit sharing contributions made for the year ended December 31, 2024.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Sponsor's contributions and Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and any earnings (losses) thereon.

Vesting in the Sponsor's contributions is based on years of service in accordance with the following vesting schedule:

3 years	66 %
4 years	100 %

Upon a participant's total disability or attainment of normal retirement age of 59½, participants are fully and immediately vested in all contributions, and actual earnings (losses) thereon.

Notes Receivable From Participants

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Interest rates on existing loans range from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either an amount equal to the value of the participant's vested interest in their account in either a lump sum amount or in annual installments if the account balance is greater than \$7,000. If the participant's vested account balance does not exceed \$7,000, it can be distributed only in a single lump sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Note 1: Description of Plan (Continued)

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Sponsor before becoming 100% vested in the Sponsor's contributions. If the participant is reemployed and fulfills certain requirements, the forfeitures can be restored. Forfeitures remain in the Plan and are used to reduce the Sponsor's contributions or to reduce the Sponsor's administrative expenses. At December 31, 2024 and 2023, unallocated forfeitures from nonvested accounts totaled \$11,180 and \$337, respectively.

For the year ended December 31, 2024, \$134 of forfeitures were used to offset Sponsor contributions and no forfeitures were used to reduce Plan expenses from forfeited nonvested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract ("FBRIC"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The FBRIC is reported at contract value, which is the amount participants would receive if they were to initiate permitted transaction under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Sponsor absorbs various Plan expenses including third-party administration fees and audit fees. Investment advisory and management fees are allocated proportionately to Plan participants based on their respective account balances and are included in administrative expenses. Other investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net appreciation in fair value of investments. Loan fees are charged directly to the participant's account against the investment option for which the loan was originally charged.

Subsequent Events

Subsequent events have been evaluated through December 7, 2025, the date that the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4: Fully Benefit-Responsive Investment Contract

The Plan has a guaranteed investment contract ("GIC") which provides a guarantee of principal and interest which is guaranteed by the general account of Empower Annuity Insurance Company of America ("Empower"). Contract value represents contributions made under the contract, plus earnings (losses), less withdrawals and administrative expenses. Subject to Plan or Internal Revenue Code ("IRC") limitations, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The average crediting interest rate for this fund was approximately 1.66% for the year ended December 31, 2024. There are no reserves against contract value for credit risk of Empower or otherwise.

Certain events limit the Plan's ability to transact at contract value with Empower including Plan termination and other events as specified in the GIC. The Plan Administrator believes that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are improbable of occurring. The GIC does not permit Empower to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by the Trustees

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (the "Trustees").

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan document to discontinue its contributions at any time or partially terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Sponsor contributions.

Note 7: Tax Status

The Sponsor adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Party-in-Interest Transactions

During 2024, Plan investments were managed by the Trustees. These transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations. Fees incurred and paid by the Plan for investment and advisory management services were \$34,581 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
