## Notes to Financial Statements

### **1. SIGNIFICANT ACCOUNTING POLICIES**

#### **BASIS OF ACCOUNTING**

The financial statements of the Automatic Payroll Systems, Inc. 401(k) Retirement Plan (the Plan) have been prepared on the accrual basis of accounting.

#### **INVESTMENT VALUATION AND INCOME RECOGNITION**

For the years ended December 31, 2024 and 2023, the Plan's investments are held in pooled separate accounts reported at estimated fair market value. These accounts are considered Level 2, Fair Value Measurements. The fair value of these investments is measured by the underlying publicly traded funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

#### **PAYMENT OF BENEFITS**

Benefits are recorded when paid.

#### **USE OF ESTIMATES**

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### **2. DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **GENERAL**

The Plan is a defined contribution pension plan covering all employees of Automatic Payroll Systems, Inc (the Company) who have attained the minimum requirements of three months of service following the employee's commencement date and are twenty-one (21) years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **CONTRIBUTIONS**

Each year, participants may contribute any percentage of pretax annual compensation or after tax compensation (Roth elective deferrals), as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts as investment options for participants. Contributions are automatically invested in a designated Target Date/Life Path Fund until changed by the participant. The Plan is a safe harbor plan and contributes 100% of the first 3% of contributions and 50% of the next 2%. The matching Company contribution is invested in the same default fund or funds selected by the Participants. The Plan sponsor, at its discretion, may contribute a profit sharing contribution. Contributions are subject to certain statutory limitations.

### **PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan sponsor's contribution (if applicable), (b) Plan earnings and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **VESTING**

Participants are immediately vested in their contributions plus actual earnings thereon. Employer safe harbor contributions are immediately vested. Vesting in the Companies discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six (6) years of credited service.

### **INVESTMENT OPTIONS**

Upon enrollment in the Plan, a participant may direct contributions into selected mutual funds that are administered by John Hancock. The available accounts allow the participant to choose from variety of investment objectives. If no investment options are chosen by the participant, the funds are invested in a portfolio of funds based on their age and retirement date.

### **PAYMENT OF BENEFITS**

On termination of service due to death, disability or retirement, a participant is entitled to receive the value of his account as soon as the distribution is administratively feasible. The participant may elect to receive the vested portion of the account in a lump-sum distribution.

### **NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow amounts from the Plan up to the lesser of \$50,000 or 50% of the vested account balance. Note repayments are made by a payroll deduction over a period not to exceed five years (except for the purchase of a primary residence). Notes are reported at the outstanding principal balance and interest is recorded on the economic accrual basis. The interest rate is a reasonable rate of interest as established by the Plan administrator. A participant's failure to repay the note will result in the total outstanding amount of the loan including any accrued interest to be defaulted and deemed distributed to the participant. Accordingly, no allowance for loan losses is necessary.

### **FORFEITURES**

There were no forfeited, nonvested accounts for the years ended December 31, 2024 and December 31, 2023.

### **EXPENSES**

Certain expenses of maintaining the Plan are paid by the Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in administrative expenses. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

### **3. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify, suspend, or discontinue contributions to the Plan at any time, and such action shall not be deemed to be

a termination of the Plan. The Plan sponsor also has the right to terminate the Plan subject to the provisions of ERISA.

In the event of Plan termination, each participant will become 100% vested in his or her account balance. Each participant, retired participant or beneficiary shall be entitled to receive any amounts then credited to his or her account.

#### **4. FAIR VALUE MEASUREMENTS (UNAUDITED)**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3.

Pooled separate accounts are reported at fair value based on Level 2 inputs. The Level 2 inputs consist of quoted market prices for various securities held in pooled separate accounts. The fair value hierarchy presentation for investments reported at fair value as of December 31, 2024 and 2023.

### **6. INCOME TAX STATUS**

The Internal Revenue Service has ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. Since being qualified by the Internal Revenue Service the Plan has been amended. The Plan administrator and the Plan's trustee believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The sponsor is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

### **7. PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of pooled separate accounts managed by John Hancock Life Insurance Company. The Plan sponsor has agreements with John Hancock, John Hancock Life Insurance Company, New York Life Securities, and Heard, McElroy, & Vestal. These entities provide investment management, recordkeeping services, and administration to the Plan. Due to the services provided by these companies, each of them is considered a party-in-interest.

### **8. MANAGEMENTS' REVIEW**

The Plan sponsor has evaluated subsequent events through December 18, 2025, which is the date the financial statements were available to be issued. There were no subsequent events that require recording or disclosure in the financial statements for the year ended December 31, 2024.

### **9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **10. SECURE ACT 2.0**

The SECURE Act 2.0 was signed into law in December 2022. SECURE Act 2.0 includes numerous reforms to existing retirement law intended to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and simplify and clarify retirement plan rules.

### **11. CONTINGENCY**

The Plan audit is being filed past the extended filing due date. The late filing could result in penalties to the Plan sponsor. Any amounts that may be assessed could not be determined, therefore no liability has been accrued in connection with this contingency.
