Independent Auditors' Report

Qualified Opinion

We have audited the financial statements of Employees' Retirement Plan of the Albany Area Commercial Printers (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - liquidation basis as of June 30, 2025 and 2024, the related statements of changes in net assets available for benefits - liquidation basis for the years then ended, and the related notes to the financial statements.

In our opinion, except for the omission of the information described in the Basis for Qualified Opinion section of our report the accompanying financial statements present fairly, in all material respects, the net assets available for benefits - liquidation basis of Employees' Retirement Plan of the Albany Area Commercial Printers Retirement Plan as of June 30, 2025 and 2024, and the changes in net assets available for benefits - liquidation basis for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Qualified Opinion

As described in Note 1 to the financial statements, because of the Plan becoming insolvent, the Pension Benefit Guaranty Corporation (PBGC) is providing funds to cover funding deficiencies. The PBGC has advised the Board of Trustees that the annual actuarial valuations are not required for insolvent multiemployer plans that are receiving financial assistance from the PBGC, unless requested. Since such valuation has not been requested and the PBGC will not fund its cost, the Board of Trustees has not requested that Plan actuaries perform a valuation as of July 1, 2024. Therefore, the Plan's financial statements do not present information regarding the Plan's accumulated plan benefits as of June 30, 2024, and the changes in accumulated plan benefits for the year then ended. In our opinion, presentation of that information is required to conform with accounting principles generally accepted in the United States of America. The Board of Trustees has not quantified the amount of, or changes in, the Plan's accumulated plan benefits and, in the absence of an actuarial determination, these amounts and their effect on the financial statements are not reasonably determinable.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Employees' Retirement Plan of the Albany Area Commercial Printers Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

Emphasis of Matter - Terminated Plan and Liquidation Basis of Accounting

As further discussed in Notes 1 and 4 to the financial statements, due to the mass withdrawal of all employers, the Trustees submitted a notice of termination to the PBGC. As a result, Employees' Retirement Plan of the Albany Area Commercial Printers is presenting the financial statements on the liquidation basis of accounting. Effective July 1, 2020, Employees' Retirement Plan of the Albany Area Commercial Printers became insolvent and as a result, benefits were reduced. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Responsibilities of Management for the Financial Statements (Continued)

- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Employees' Retirement Plan of the Albany Area Commercial Printers' internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Supplementary Information

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplementary Schedules of Administrative Expenses - Liquidation Basis for the years ended June 30, 2025 and 2024 is presented for purposes of additional analysis and is not a required part of the financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. In our opinion, except for the omission of the information described in the Basis for Qualified Opinion section, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole.

Notes To Financial Statements

Note 1: Description Of Plan

The following description of Employees' Retirement Plan of the Albany Area Commercial Printers (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan was established as a multi-employer noncontributory defined benefit plan as a result of collective bargaining agreements between local printing companies and various unions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - The Plan has been frozen and years of service worked after December 31, 1992 are excluded from the calculation of retirement benefits.

Funding policy - The Plan was funded by employer contributions as specified in the collective bargaining agreement. The contribution rate in effect was \$.01 per shift through February 2003. Effective March 2003, the rate increased to \$1.84 per shift. Effective June 2007, the rate for all non-union employees was reduced to \$.01 per shift and the union members remained at \$1.84 per shift. As of June 30, 2012, all employers have withdrawn from the Plan. One employer is currently making their required employer withdrawal liability payment.

Pension benefits - Employees retiring at 65 years of age with at least five years of continuous plan participation are entitled to annual pension benefits beginning at normal retirement age (65) equal to \$19.70 per month multiplied by his/her years of benefit service, through December 31, 1992. For a participant who did not accrue three "new" years of benefit service before December 31, 1992, the monthly benefit for years of benefit service before July 1, 1989 (July 1, 1988 for Boyd Printing) is \$12.00. Annual pension benefits for early retirement beginning at age 62 are as stated above, reduced by a specified percentage as stated in the Plan for each year under age 65. Details regarding early retirement benefits, death and disability benefits, and benefit payment options are described more fully in the Summary Plan Description. Due to the Plan's insolvency, the full amount of a pensioner's benefit may not be eligible for payment under the Pension Benefit Guaranty Corporation (PBGC) insurance program. Effective July 1, 2020, only vested benefits are guaranteed by the PBGC. Specifically, the PBGC guarantees a monthly benefit payment equal to 100 percent of the first \$11 of the monthly benefit accrual rate, plus 75 percent of the next \$33 of the accrual rate, times each year of credited service. Therefore, the PBGC's maximum guarantee is \$35.75 per month times a pensioner's number of years of credited service. If a pensioner's benefit accrual rate is greater than \$11, it is likely they incurred a reduction in benefits.

Plan termination - As of June 30, 2012, the last employer required to contribute to the Plan withdrew from the Plan. This event is considered a mass withdrawal, and accordingly, the Trustees submitted a notice of termination to the PBGC. The assets of the Plan are to be used for the benefit of the participants and beneficiaries, in an order of priority that is set forth in the Plan. Whether a particular participant's accumulated plan benefits will be paid depends on both the priority of those benefits and the level of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guaranty while other benefits may not be provided for at all.

Notes To Financial Statements

Note 2: Summary Of Significant Accounting Policies

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. The application of these accounting principles involves the exercise of judgment and use of assumptions as to future uncertainties and, as a result, actual results could differ from these estimates. The Plan periodically evaluates estimates and assumptions used in the preparation of the financial statements and make changes on a prospective basis when adjustments are necessary.

Basis of accounting - The financial statements have been prepared on the liquidation basis of accounting.

Tax status - The Plan is exempt from federal income tax under applicable regulations of the Internal Revenue Code. Tax positions are evaluated and recognized in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities.

The Plan obtained its latest determination letter on September 22, 2016, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Presentation - Certain reclassifications, when applicable, are made to the prior year financial statement presentation to correspond to the current year's format. Reclassifications, when made, have no effect on total net assets available for benefits - liquidation basis or changes in net assets available for benefits - liquidation basis.

Note 3: Employer Withdrawal Liability

Effective June 30, 2012, Fort Orange Press, Inc., the last contributing employer of the Plan, withdrew from the Plan. As required under ERISA, Fort Orange Press, Inc.'s required initial withdrawal liability was calculated to be \$906,032 with a required annual payment of \$15,149.

Note 4: Insolvency And The Pension Benefit Guaranty Corporation Funding

During the year ended June 30, 2020, the Plan submitted a notice of insolvency to the PBGC. In connection with this notice, the Plan submitted an application for financial assistance requesting that the PBGC provide supplemental funding for payment of benefits and reasonable administrative expenses incurred by the Plan after the depletion of existing plan assets. Effective July 1, 2020, the PBGC began providing financial assistance to the Plan. During the years ended June 30, 2025 and 2024, the Plan received \$460,500 and \$407,200, respectively.

Note 5: Commitments And Contingencies

The Plan follows the guidance for uncertainty in income taxes. As of June 30, 2025, the Plan believes that it has appropriate support for the income tax positions taken and to be taken based on an assessment of many factors including experience and interpretations of tax laws applied to the facts of each matter. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits.

Amounts received from the PBGC are recognized as an addition to net assets in the period received. Supplemental funding provided by the PBGC is technically a loan, but due to the circumstances, repayment is considered no more than a contingency, and no liability has been recorded. The ability of the Plan to continue operations and payment of benefits is dependent on the PBGC continuing to provide financial assistance.

Note 6: Subsequent Events

Subsequent events have been evaluated through December 15, 2025, which is the date the financial statements were available to be issued.
