Opinion

Note 1 - Description of Plan

The following brief description of the Acme Engineering & Manufacturing Corporation Comprehensive Health & Dental Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan provides health and other benefits to qualified employees of Acme Engineering & Manufacturing Corporation (the Company) and their covered dependents. The Plan and related trust were established May 12, 1986.

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Salaried full-time employees are eligible to participate in and enter the Plan the first day of the month immediately following date of employment. Hourly full-time employees are eligible to participate in and enter the Plan the first day of the month immediately following completion of the waiting period. The waiting period is defined at sixty (60) calendar days of full-time employment. Vested rights to benefits include claims that have actually been incurred by a participant that would otherwise be eligible for payment under the Plan.

Benefits

The Plan provides health benefits (dental and medical) to eligible participants and covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures the dental and transplant benefits through insurance contracts. Insurance premiums include the cost of insuring against the payment of benefits. Insurance deficits must be paid by the Plan or the Company. Premiums for dental and transplant policies are recorded as contributions and premium payments in the accompanying statement of changes in net assets available for benefits.

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The Plan is responsible for claims up to \$125,000 per employee for benefit expenses. The reinsurance company is responsible for reimbursing the Plan for all individual claims that exceed these amounts during the Plan year as appropriate.

Self-Insured Benefits

All benefits other than dental and transplant benefits are self-insured up to individual stop loss limits. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The administrators pay claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA Trust or the general assets of the Sponsor. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The employee contributions are automatically withheld from employees' paychecks and remitted monthly to the trust. Contributions from participants are recorded in the period following the period the Company makes payroll deductions from Plan participants, except for the month of December, in which contributions are made in that month. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions and are recorded in the same period as the corresponding participant contributions. The Company pays the full cost of stop loss insurance. The Company contribution is paid monthly. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in the ERISA. In the event of termination of the Plan, the assets are to be allocated to accrued liabilities incurred as a result of the termination and to any claims existing at the time of termination. Any remaining assets would be used to pay benefits on behalf of participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Payment of Benefits

Premiums paid by either the Company or the VEBA trust are recorded as insurance premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor and are reflected as claims paid in the accompanying statement of changes net assets.

Stop Loss

Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits for the period March 1, 2024 through February 28, 2025. The Plan was entitled to receive no refunds for the twelve months ending February 28, 2025, and no refunds have been netted with claims paid on the statement of changes net assets available for benefits.

Expenses

Administrative expenses incurred in the administration of the Plan that are paid by the Plan include bank charges, accounting and legal fees, preferred provider organization and review fees, and other administration fees. These expenses are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Expenses that are directly paid by the Sponsor, such as professional fees, are excluded from these financial statements.

Claims Incurred but not Reported

Plan obligations at February 28, 2025 and February 29, 2024, for claims incurred but not reported at that date, are estimated based primarily on past claims experience. These amounts are paid by the Plan only if claims are submitted and approved for payment. Such estimated amounts are included in the accompanying statements of the benefit obligations in the amounts currently payable.

Subsequent Events

The Company has evaluated subsequent events through December 19, 2025, the date which the financial statements were available to be issued.

Note 3 - Tax Status

The VEBA trust funding certain benefits of the Plan, received an exemption letter from the Internal Revenue Service (IRS) dated June 2, 1997, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in the twelve months ending February 28, 2025, for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 - Party-in-Interest Transactions

As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

Note 5 - Risks and Uncertainties

The estimated liability for claims incurred but not reported is based on historical trend information, which is subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in this estimate and assumptions in the near term could be material to the financial statements.

Note 6 - Concentrations of Credit Risk

The Plan holds assets in various certificates of deposit and money market deposit accounts, the balances of which are periodically in excess of federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank, for each account ownership category. At February 28, 2025, and February 29, 2024, the Plan had \$-0- in excess of FDIC-insured limits.
