Dear Sir or Madam:

We are writing to request abatement of penalties for the late filing of Form 5500-SF for plan year 2024. The delay was due to circumstances beyond our control, and we acted promptly to correct the issue once discovered.

Explanation of Delay: The late filing occurred due to unexpected staff turnover at our accounting firm. The personnel responsible for plan compliance left during a critical period, and the transition to new staff caused a breakdown in communication regarding filing deadlines. As a result, the Form 5500-SF was not submitted on time. Once the issue was identified, we acted promptly to complete and file the return.

Corrective Action Taken: As soon as we became aware of the missed filing, we immediately prepared and submitted the Form 5500-SF through EFAST2. We have also implemented internal controls to ensure timely compliance in the future, including calendar reminders and engaging a dedicated compliance resource.

We respectfully request that the Department consider these circumstances and waive any penalties associated with this late filing under the reasonable cause provisions.
