## INDEPENDENT AUDITOR'S REPORT

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Partners for Rural Impact Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the Plan Administrator.

General: The Plan is a defined-contribution plan sponsored by Partners for Rural Impact, Inc. (the “Company”) established May 1, 2022. The Plan provides eligible employees the opportunity to make regular and systematic contributions through salary reductions. The Company, as administrator, is responsible for the control and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility: All employees of the Company, except AmeriCorps service members, are eligible to make salary deferrals to the Plan immediately upon hire. In order to receive an employer contribution, as described below, an employee must work at least 1,000 hours of service in the prior 12 months. The Plan recognizes prior service with certain predecessor organizations, including Berea College and other Code §501(c)(3) organizations, subject to documentation and continuity requirements as outlined in the Plan document.

Effective August 1, 2024, pursuant to Amendment #1, the Company eliminated the requirement to complete 1,000 hours of service in the prior 12 months to be eligible for employer contributions. All eligible employees, regardless of hours worked, may receive employer contributions upon hire, provided they are not excluded from participation.

Contributions: Each year, participants can contribute up to 100% of their annual pre-tax compensation, limited to a maximum as established by the Internal Revenue Service (the “IRS”). The Plan allows eligible participants to make Roth contributions in accordance with the IRS regulations. In addition, the Plan allows “catch-up” elective deferral contributions for those participants who have attained age 50 by close of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company will contribute a fixed contribution of 8% of each participant’s plan compensation earned during each payroll period. Contributions are subject to certain limitations.

Forfeitures: The amount of any non-vested forfeiture may be used to fund Company contributions. During 2023, \$8,649 of forfeitures were applied to offset Company contributions. The remaining balance of forfeitures available to offset future Company contributions as of December 31, 2024 was \$5,076.

Auto-Enrollment and Auto-Increase: Effective January 1, 2023, the Plan implemented an automatic enrollment feature. Participants who have not affirmatively elected a deferral percentage are automatically enrolled at 2% of plan compensation. The deferral rate increases by 1% annually on July 1 of each year, up to a maximum of 10%, unless a new election is made. Certain employee classifications, including temporary, seasonal, and summer employees, are excluded from automatic enrollment.

Participant Accounts: Each participant’s account is credited with the participant’s contribution, Plan earnings or losses, and an allocation of the Company’s contributions, and charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balance, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in all contributions to their accounts plus actual earnings thereon.

**NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)**

Payment of Benefits: Upon termination of service a participant or participant's beneficiary is entitled to receive the vested interest in his or her account. Participants may elect to receive a partial payment, installment payments or lump-sum amount, as specified by the Plan. The Plan allows for the automatic distribution of participant account balances that do not exceed \$5,000. In certain circumstances, participants may make voluntary in-service withdrawals and hardship withdrawals if certain criteria are met and subject to certain limitations as outlined in the Plan document.

Rights Upon Plan Termination: Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Administrative and Investment Management Expenses: Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation/ depreciation reported by the Plan on the statement of changes. All other expenses of the Plan may be paid by the Company or the Plan, at the Company's discretion.

Plan Transfers: Effective July 9, 2024 the Berea College Retirement Plan transferred \$4,012,525 of assets into the Plan. This bulk transfer has been reported as a transfer from other plans in the accompanying financial statements. In addition, approximately 45 participants with TIAA Traditional holdings will transfer in monthly installments over a five-year period. These ongoing transfers will continue in future years and will be recorded in the period received.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit responsive investment contracts are reported at fair value. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balance.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES** (Continued)

Unaudited 2023 Information: Amounts reported as of December 31, 2023 have not been audited by independent accountants. The first year that the Plan required an audit in accordance with ERISA was for the year ended December 31, 2024.

**NOTE 3 - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments from participants held at December 31, 2024 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc (“Lincoln”).

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan’s principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Registered Investment Companies:* Registered investment companies are valued using quoted market prices from nationally recognized securities exchanges (Level 1 inputs).

**NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a fixed annuity contract with Lincoln National Life Insurance Company, which is considered a guaranteed investment contract. The contract is considered to be fully benefit-responsive and reported at contract value. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 1%. The crediting rate is based on a formula established by the issuer and is reviewed quarterly for possible adjustment.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options for deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The contract limits the circumstances under which Lincoln National Life Insurance Company may terminate the contract. Circumstances that would allow Lincoln National Life Insurance Company to terminate the contract include: (i) the Plan's loss of its qualified status, (ii) termination or partial termination of the Plan, or (iii) investor breach of a provision of the Agreement. If one of these events were to occur, the issuer could terminate the contract at an amount less than contract value. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some professional fees for the administration of the Plan are paid directly by the Company.

Certain Plan investments are managed by an affiliate of Lincoln, the trustee and custodian of the Plan, therefore, these transactions and the Plan's payment of fees to Lincoln and its affiliates qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions. Investment management fees charged to the Plan as a reduction of investment returns qualify as party-in-interest transactions.

**NOTE 7 - TAX STATUS**

Effective during 2013, the Internal Revenue Service began accepting applications for opinion and advisory letters for prototype and volume submitter 403(b) Plans. The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2017 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor or Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.
